FAMILIES' Dhuluiya, which comes from the word "ribs", is a small town surrounded on three sides by a kink in the Tigris. A north-south highway runs through it, making it potentially one of the final stops for fighters attempting to assault Baghdad from the north.

When Islamic State fighters arrived in June, members of the al-Jubouri tribe refused their request to hand over 35 local police and security forces officers. Since then, there have been attacks and counter-attacks, while the Sunni tribesmen have been mostly besieged inside the town.

With no way out, they began receiving help from Balad, the mainly Shia sister town on the opposite bank.

"We have no access now except using boats to go to Balad, the only place which helps us. The people of Balad have helped us with food, ammunition, weapons and receiving the wounded," said Abdullah Mohammed, a fighter from the Jubour tribe. "Some of them even fight with us."

The Dhuluiya municipality chief, Turki Khalaf Turki, said the coopera-

> On Tuesday, the fighters launched what appeared to be a coordinated assault to capture the town once and for all. Insurgents flanked Dhuluiya from the eastern and northern sides, using mortars, RPG rounds, machine guns and hand grenades, Colonel Hussein al-Jubouri from Dhuluiya's police force said.

> "We were able to stop them and our people have high morale because they are defending their town and families," he told Reuters on Wednesday, adding that the area was being targeted by mortars as they spoke. Nine residents and four fighters died.

Across the river, the insurgents also launched an attack on Balad near a Shia shrine that would have allowed them to complete their siege of Dhuluiya. Abu Gyath, an influential Shia sheikh, said fighters in Balad defended the territory to help the tribesmen across the river.

"If they control this area, God forbid, then Dhuluiya will be suffocated and it will be hard for us to send help. Otherwise, we pledged to help them as they are in a difficult situation," he

organised at BNP chief Khaleda Zia's Gulshan office in the capital yesterday evening, just an hour after Prime Minister Sheikh Hasina at another press briefing said her government would not hold talks with the BNP.

On Abdul Latif Siddique's removal from the cabinet, Mirza Fakhrul said:"The prime minister's inaction [on the matter] has frustrated and disappointed the nation."

He claimed that in Hasina's yesterday's speech there was no clear indication when Latif would be removed from the cabinet.

The PM said she would take steps according to the proper government procedures [on the matter] while the people are demanding that Latif be punished under the law immediately,

Mirza Fakhrul said.

At yesterday's press briefing, Hasina also said it was Latif Siddique who would pay the price, not her government or Awami League, for the comments he made in New York. Fakhrul criticised the PM for her

remark and said: "In a parliamentary democracy, the prime minister takes the responsibility of such comments made by her cabinet members."

"So, the PM cannot avoid the responsibility."

"Any legal measure is yet to be taken he said. [against Latif] for making derogatory remarks on our Prophet Muhammad (pbuh)," he said.

On September 28, Latif at a reception in New York arranged by expatriate Bangladeshis said he was against hajj and Tabligh Jamaat.

The remarks triggered widespread criticisms at home and abroad, and embarrassed the government.

At yesterday's press conference at Gulshan, BNP vice chairman Shamsher Mabin Chowdhury alleged that the Awami League was spreading some false information about Sheikh Hasina's recent visit to the USA.

"There was no bilateral meeting between the prime minister and Ban Ki-moon. She got only five minutes for a photo shoot [with Ban Ki-moon],"

"The government has highlighted the meeting between Hasian and Indian Prime Minister Narendra Modi [in New York]. But on the other hand, India did not highlight the meeting because they did not consider it important," Mabin added.

"This way, hajji. Don't stop here. You're blocking the way," security men shouted through loudspeakers, trying to control the crowds. "Sometimes we have difficulties

understanding each others' languages, and mostly the elderly can't understand what we are saying," said Ali al-Shemmari, a soldier stationed at the hill. "The pilgrims believe that they should climb up, although this is not

necessary... But things are going well," he said. The number of faithful seemed fewer than past years following a

crackdown by authorities on illegal pilgrims, more than 145,000 of whom have been turned away, the official Saudi Press Agency said.

Saudi authorities are also striving to protect pilgrims from two deadly viruses, Ebola and the MERS coronavirus.

No such cases have been recorded among the hajj visitors, officials say. Pilgrims will stay at Mount Arafat

until sunset when they set off for nearby Muzdalifah, where they gather pebbles for the symbolic "stoning of the devil" today.
