# Investor optimism keeps stocks afloat ahead of holiday

Investors helped stocks end in the positive territory last week anticipating a favourable post-Eid market.

DSEX, the benchmark general index of the Dhaka Stock Exchange, gained 4.19 percent or 210 points, to close at 5,237.72.

The shariah index of the Dhaka bourse, DSES, closed at 1,219.25 points after gaining 37.57 points or 3.18 percent.

Expectations of upswing and consequent good returns after the festival made investors buy more stocks across the market, IDLC Investments said in its daily market analysis.

Even though the investors

neutralised short-term returns, buying binge was strong across the market and fund injections remained vigilant, the investment banker said.

ued search for lucrative scrips kept the market volatile throughout the stockmarket. week, it said.

boosted confidence and inflow of new funds in the stocks, analysts said.

stockmarket increased 34 times to a record Tk 426 crore year-on-year in September.

In September, overseas investors The news of growing foreign bought shares worth Tk 589.60 investment in the stockmarket crore and sold stocks worth Tk 163.35 crore, showing a 403 percent rise in net investment compared to the same period last year, Net foreign investment in Dhaka according to data from the Dhaka Stock Exchange.

Gainers took a strong lead over the losers with 245 to 60, while 7 remaining unchanged out of the 312 issues that traded on the DSE.

Among the major sectors, only telecoms ended the day in red by losing 4.22 percent.

Banks and non-bank financial institutions posted hefty returns of 6.97 percent and 6.42 percent respectively over the week. These were followed by pharma with 4.97 percent, power 4.12 percent, and food and allied 4.40 percent.

Titas Gas was the most liquid stock of the week with 2.64 crore shares worth Tk 238 crore changing hands followed by Grameenphone and MJL Bangladesh.

Popular Life Insurance was the biggest gainer of the week, posting a 37.89 percent increase, while Bangas was the worst loser, shedding by 23.64 percent.

# Yahoo plans to invest in Snapchat

Yahoo Inc plans to invest a part of the proceeds from the Alibaba Group Holding Ltd stake sale in mobile app Snapchat, which lets users send messages that disappear after a few seconds, the Wall Street Journal said.

Yahoo and Snapchat held talks that are expected to lead to an investment in the mobile-messaging startup's next funding round, the Journal said, citing three people familiar with the matter.

The round values Snapchat at about \$10 billion and it was not clear how much Yahoo plans to invest in the hugely popular application, the Journal said.

Yahoo and Snapchat were not immediately available for comments.

Institutional Venture Partners and DST Global, two previous Snapchat investors, are also planning to invest in the company, the paper reported, citing two people familiar with the matter.

Yahoo's shares were up 1.4 percent at \$41.07 in late trading on Friday.

"Everyone is losing money. The demand side of the economy has got some hiccup," he said, urging policymakers to look into the matter.

The poultry sector that employs tens of thousands of people in the suburbs and rural areas is a major contributor to the economy.

The livestock sub-sector, where poultry is the main driver, accounted for 1.78 percent of gross domestic product (GDP) in fiscal 2013-14.

With six grandparent stock farms, 60-70 parent stock farms, hatcheries, along with thousands of poultry farms, the country is selfsufficient in meeting its annual requirement for chicken and eggs, according to industry operators.


Earlier, BGMEA and Hossain paid salaries of May, June and July and overtime allowances of August, to 1,600 Tuba Group workers.

Five units of the group have remained inoperative since May this year due to a shortage of work orders and a lack of working capital. The units have been in a crisis of work orders

since the devastating fire at Tazreen Fashions, a sister concern of Tuba Group, on November 24 last year that claimed 112 lives. The acting president of BGMEA said, "We,
