This invitation for bids follows the general procurement notice for this project that appeared in United Nations Development Business (UNDB online) on March 22, 2010.

The People's Republic of Bangladesh has received a credit from the International Development Association (IDA) towards the cost of the Chittagong Water Supply Improvement and Sanitation Project (CWSISP), and it intends to apply part of the proceeds of this credit to payments under the contract for Construction of Transmission and Additional Distribution Pipelines (No Regret Investment), Contract No. CWSISP/W-4.

The Chittagong Water Supply & Sewerage Authority (CWASA) now invites sealed bids from eligible bidders for construction of the transmission line from Modugnaghat Water Treatment Plant to Kalurghat Booster Pump Station and some additional distribution by using trenchless technologies and open cuts, which includes app. 49km piping of HDPE and Ductile Iron in dimension between 150-1,200mm. Furthermore, bridge and culvert crossing; and detailing and installation of valve and inlet chambers in concrete, which e.g. contain valves, air release valves, pressure reducing valves and washout, etc., all located in public roads.

Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, May 2004, Revised October 1, 2006 & May 1, 2010 and is open to all bidders from eligible source countries as defined in the guidelines.
