Save the Bayside jhau trees

Tidal water from the Bay of Bengal threatens a few thousand jhau trees (tamarisk) as they may collapse anytime due to gradual exposure and damage of roots.

Around a thousand trees fell into sea water during tidal surges at the time of full moon in three months since last July, locals and forest officials said.

September 24 from Sea-in point to Samitypara of Nazirartek, it was found that a large number of trees of the five-kilometre forest had tilted on the sea shore as their roots came out of sands.

This correspondent visited Nazirartek, Samitypara, Niribili Cottagepara, diabetic hospital point, Kabita Chattar, Shoibal hotel and Laboni

During a visit on point areas where locals also alleged that a gang with the connivance of a section of forest guards was also looting the trees.

> The gang has been buying each tree at Tk 500-800 each, they said.

However, refuting the allegation, forest official Tapos Dev of Cox's Bazar Sadar range said they recovered more than 500 damaged trees from the sea water in the last three months.

He said, it was impossible to protect and look after such a big forest with the help of only four temporary forest guards.

Forest official of South Range Abdul Awal stressed the need for materialising the Cox's Bazar town protection dyke project to save the 'important' forest from the onslaught of the sea.

Dumping of poultry waste damages aman fields

Aman plants on at least 60 bighas (one bigha is equal to 0.3306 acre) of land have been damaged allegedly due to dumping of poultry waste by a farm at Majhipara village in Tentulia upazila of Panchagarh.

Thirty farmers of Majhipara, Khutagoch and Narayangoch village on August 28 submitted a complaint to Tentulia upazila parishad Chairman Md. Shahin, demanding steps to stop the waste dumping.

The farmers alleged that aman plants on 60 bighas of land were being damaged due to dumping of poultry wastes by a farm of Paragon group. They feared that a hundred bighas of arable land would be affected if the process continued.

The farmers called for suspension of operation of the poultry farm until making a proper waste drainage system. They also demanded compensation for the affected aman grow-

FLOOD-HIT DHUNAT IN BOGRA

Farmers planting early winter vegetables to recoup losses

Farmers in Dhunat upazila of the district are trying to recoup losses incurred in recent flood by cultivating early winter vegetables in their farmlands.

Upazila agriculture office sources said at least 46 thousand farmers were badly affected as their aus and aman crops and vegetables worth around Tk 36 crore got damaged by the recent flood.

T-aman on 9, 821 hectares of land, aus on 20 hectares of land, vegetables on 200 hectares of land, spices on 19 hectares of land, and jute on 7 hectares of land at 150 villages in 10 unions of the upazila were damaged, source added.

With recession of flood waters, the farmers in the upazila have started preparing their farmlands to cultivate winter vegetables. They are doing the job, taking loans from non governmental organisations

(NGOs) and local moneylenders. Jafor Mondol of Chikashi village under Chikashi union said crops on his one and a half bighas of land were damaged by recent flood. Now he is cultivating vegetables on the same land to recoup the losses by taking

loan from a moneylender. Vegetable grower Fazar Ali of Bakshapara village under Goshaibari union said with the recession of flood water, he has prepared a seedbed in the home yard by taking loan

from an NGO. Contacted, Upazila Agriculture Officer (UAO) of Dhunat upazila Jahangir Alam said they had sent a report to the higher authority and sought financial support for the flood affected farmers so that they could cultivate mustard, maize, wheat and winter vegetable in their farmlands to recoup the losses.
