#### Man killed in land dispute

An elderly man was killed in an attack allegedly by his neighbour over a land dispute at Purirpathal village in Ulipur upazila yesterday. The deceased was identified as Nowab Ali, 65. Jamir Uddin, officer in-charge of Ulipur Police Station, said Nowab Ali and Mahfuz Ur Rahman had long been at loggerheads over the demarcation of their homesteads. As a sequel to the dispute, an altercation took place between Mahfuz and Nowab around 9 in the morning. At one stage, Mahfuz along with his men swooped on Nowab Ali and beat him up mercilessly, leaving him dead on the spot. Police picked up three people -- Asgar Ali, 45, Enamul Haque, 20, and Jobeda Begum, 28 of Mahfuzur's family in connection with the murder.

### **UP** chairman arrested

# Hilsa catching continues despite punitive steps

A section of fishermen are catching hilsa in different rivers of the district despite 'massive' drives against netting the delicious fish. The government on

October 5 imposed an 11day ban on catching, selling and transporting hilsa to ensure safe spawning of this popular fish during its peak breeding period. The ban will go on Thursday. Though the officials of

the Fisheries Department have claimed success in protecting mother hilsa from being caught due to 'massive' drives in the last nine days, hilsa is still being netted in plenty in different rivers of the district.

Fishermen were found catching hilsa in Tentulia, Paira, Lohalia, Buragourango, Kalabador, Kazal, and Montaz rivers early yesterday though the restriction is still in force.

Contacted, SM Azharul Islam, acting district fisheries officer (DFO), said they conducted over 50 drives in different rivers from October 5 to 11 and seized 2.5 tonnes of hilsa.

At least 27 fishermen were sent to jail while 27 others fined during the period, the DFO said, adding that they seized 3.66 lakh metres of nets worth over Tk 1.12 crore from different rivers and

destroyed them with fire. Sources said several hundred trawlers are now stay-

ing in the Bay and netting hilsa, defying the ban. They will return to the shore just after ending the ban on October 15, sources added.

dent reported that a magistrate was injured in an attack by fishermen during a drive at Gobindia area in the River Megna yesterday morning. The incident occurred

when a mobile court led by Magistrate Rajibul Haque launched a drive in the area at around 8:00am. The fishermen threw brick chips on the magistrate, leaving him injured. He received treatment at Chandpur Sadar Hospital.

Coastguards had to fire at least 21 blank shots to bring the situation under control.

They arrested three fishermen and seized 25 kg mother hilsa and nets during the drive. The mobile court later sentenced the fishermen to Our Chandpur corresponone year's imprisonment each for netting hilsa, defying the ban.

> According to the district administration, around 400 fishermen and 40 buyers were jailed in the last eight days for netting and buying hilsa defying the ban.

## Man held for killing girl

after rape

Police arrested a man on charge of killing a minor schoolgirl after rape in Sirajganj Sadar upazila on Sunday night.

The schoolgirl was strangled in Shibnathpur village of the district early hours of the day.

The victim, Ritu Khatun, 8, daughter of Nazrul Islam of the village in Sadar upazila was a student of Class I at Shibnathpur Government Primary School.

Officer in-charge of Sirajgan Sadar police station Habibul Islam said, locals found the body of the girl in a crop field of the village on Sunday morning and informed police.

The girl was strangled allegedly by one Nur Islam after rape in the field.

Nur Islam, son of Abdul Khaleque, took the girl from her residence for watching TV but she did not return home at night, the OC said quoting the family members.

Mother of the deceased, Kohinur Begum, filed a case accusing Nur Islam and two others in connection with the incident.

During a drive, police later caught Nur Islam from Kandapara village in the district headquarters on Sunday night.

"During interrogation he confessed to raping and killing Ritu," the OC said.

Meanwhile, angry villagers vandalised the house of Nur Islam on Sunday morning.

# Thousands suffer as bridge remains incomplete

destroyed with fire near Munshiganj launch terminal.

Unusual delay in reconstruction of Sitarampur bridge on Narail-Jessore highway causes sufferings for thousands of commuters using the road for going to Jessore, Khulna and other areas.

As the dilapidated bridge collapsed in 2010, a temporally bridge and a diversion road was made there but it remains too risky for a large number of vehicles plying the busy road.

"It is very risky to cross this temporary bridge, especially for heavy loaded trucks," said a driver.

Tender was invited in 2011-2012 fiscal year to build the 74.04-metre-long bridge and Md Wahiduzzaman and MS Sikder Construction jointly got the work order worth Tk 2 crore and 82 lakh.

The work was scheduled to be complete within July 22, 2013.

But the work has been

delayed as the required money was not released in time, said contractor Wahiduzzaman.

Taposi Das, executive engineer of Roads and Highways Department in Narail, said, "Sixty percent of this bridge construction work is already complete. We received Tk 1 crore 11 lakh of the total amount. We hope that the remaining money will be given soon and the bridge will be complete this year."


