**SC stays case**  
**against BNP**  
**MP Hafiz**  
**Ibrahim, wife**

The Supreme Court yesterday stayed for four weeks the proceedings of a money laundering case against former BNP lawmaker Hafiz Ibrahim and his wife Mafruza Sultan.

The Anti-Corruption Commission filed the case with Gulshan Police Station on August 16, 2011 against Hafiz and his wife for laundering US \$1.75 lakh to Singapore.

According to the case statement, the money was paid allegedly by Siemens Bangladesh Ltd to the duo's account to help the company win a deal of supplying core telecommunications equipment to Bangladesh Telecommunications Company Ltd (BTCL).

The amount was sent to an account at a branch of Standard Chartered Bank in Singapore between 2005

## Women farmers lost in shadow of men

**Says Zaheda Begum of Barisal on International Day of Rural Women**

"I preserve seeds, sow them, water the fields and take care of the plants yet I have no right to proceed of the crop sale," said Zaheda Begum, hailing from Barisal.



Proposed in the United Nation's Fourth World Conference on Women in 1995, the day is being celebrated worldwide since 1997 in over 100 countries to raise awareness about women's contributions to agriculture and farming.

With no access to agricultural loan or government-issued farmer's card, which helps access agricultural inputs, Zaheda was forced to depend on her husband's money for her agricultural venture. "When I asked

**SARADHA FUND SCANDAL**  
**India's external**  
**affairs ministry**  
**seeks CBI findings**  
**CBI sources claim no such instance, but say probe ongoing**

India's Ministry of External Affairs (MEA) has sought from the Central Bureau of Investigation (CBI) details of its probe into the Saradha chit fund scam after news reports surfaced of the scam money being allegedly pumped into Bangladesh for terror activities.

High officials quoted unnamed top brass as saying that the CBI has been asked to submit a report on whether any such issue has cropped up during its probe to date.

The CBI sources, however, clarified that so far they encountered no instance of funds being transferred to terror groups or Jamaat-e-Islami but with the probe still on, nothing conclusive could be said as of now. They said the MEA could be interested in the issue because of the news reports in India and Bangladesh.

"We are not aware of all this international terror linkages. No such indication has surfaced in our probe so far. We have not looked into that aspect. We will inform MEA about it,"

**'DEFAMING JUSTICE MANIK'**  
**Accused expatriate denied bail**

A Dhaka court yesterday rejected a bail petition of a Bangladeshi expatriate lawyer, Barrister Ashraful Islam, centring a defamation case and sent him to jail.

Mahbubul Alam, a Supreme Court lawyer, filed the case with the Chief Metropolitan Magistrate's court in Dhaka on August 12, 2012 against Ashraful and five others.

The case statement says the six made derogatory comments about Justice AHM Shamsuddin Choudhury Manik, a judge of the SC's Appellate Division, and the judiciary on a television talkshow in London on June 7, 2012.

Ashraful had stated that Mohiuddin, the president of Awami League's UK unit, had once sat for the Bangladesh Bar Council exam to be a High Court advocate when the said SC judge came from a different board, snatched his papers and verbally abused him, says the statement.

Ashraful also demanded that the SC judge's phone records be tracked, it added.

Mahbubul's lawyer AH Imrul Qasuar told The Daily Star that the allegations of the six were false and derogatory and the plaintiff has documents in this regard.

He said police, based on a warrant, arrested Ashraful on October 13 when he arrived at the capital's Hazrat Shahjalal International Airport. Metropolitan Magistrate of Dhaka Atiqur Rahman rejected the bail petition.

Meanwhile, Ashraful's wife Masura Akter, at a press conference on the Supreme Court Bar Association premises, demanded Ashraful's immediate release, saying he was arrested without a warrant in a false and fabricated case.

## Agriculture friendly public policy must

**Say experts at inauguration of 3-day Asian Society for Agricultural Economists conference in Savar**

To increase production and ensure food security, an agriculture friendly public policy should be adopted in Bangladesh, said experts at an international conference in Savar outside the capital yesterday.

Prof Joachim von Braun of the University of Bonn in Germany said about 80 percent of the world's 570 million small farmers lived in Asia. They are related to local resources but affected by global economic change, he said.


The small farmers in Asia particularly in Bangladesh are facing a big challenge because of rapid change in economic structure, global economical change, migration and so on, said the speakers.

In the country, the small farmers are migrating to the urban areas to get jobs while the size of farms is decreasing

## To Know is to Prevent

### Pain in the leg? Not anymore!



Even after his retirement from his teaching job from a government high school in Mirpur, Dhaka at sixty, Mr. Azizul Hakim used to have an active life style. At seventy two his days are low-key now; spent putting around the house. He started to notice recurrent pain shooting down the back side of his right leg while walking approximately five hundred meters. Eventually, the pain became so intense that even simple tasks like walking to the grocery store were unbearable; he even had difficulty sleeping at night. "I couldn't do everyday chores around the house or things that I enjoy because my legs always tightened up," he says, "the pain was pretty intense and it never went away". Hakim first thought it might be a pulled muscle or something similar; he tried a few home remedies like drug store creams, ointments, he stretched and massaged his leg a lot, but nothing worked. Hakim lived with the pain for more than two years, brushing it off as a sign of aging and something not to be taken seriously.

Upon advice from a local community doctor, Hakim consulted an Orthopaedic Surgeon in an International Standard Multi-specialty hospital in the city. A simple, non-invasive test called the Color Doppler Ultrasound diagnosed with PAD or peripheral arterial disease in Hakim's legs.

PAD develops when leg arteries become clogged with plaque or fatty deposits that cause poor blood flow to legs. Just like clogged arteries in the heart, clogged arteries in the legs increase the risk of heart attack and stroke. Like Hakim, people who experience signs or symptoms of PAD may have pain when walking or climbing stairs, which may be relieved after resting. This pain is called intermittent claudication. There are few risk factors for peripheral arterial disease such as increased blood lipids (fats and cholesterol), smoking, hypertension (high blood pressure), diabetes, lack of physical exercise, being overweight etc. These risk factors increase the normal aging process of the arteries, which can be problematic even at a young age.

Unlike many other big hospitals in the city, this hospital had an Interventional Radiologist; to whom the Orthopaedic Surgeon referred Hakim. The Interventional Radiologist explained Hakim his condition by drawing picture of blood supply of legs and showing multiple areas of blockage which he was having because of PAD; unless treated these could lead to gangrene of toes and legs when the affected body parts would need to be amputated.

### Schedule conflict postpones 3rd Bangladesh-US dialogue

The two-day third Bangladesh-US Partnership Dialogue, scheduled to have begun in the US capital Washington DC on October 21, has been postponed due to both sides having conflicting schedules.

Diplomatic sources, however, said both are working for a new date.

Foreign Secretary Md Shahidul Haque was due to lead a 10-member Bangladeshi delegation at the discussion with his counterpart Under Secretary of State for Political Affairs of the US Wendy R Sherman, focusing on the expansion of security, trade and development ties.
