According to the case statement, on May 6 last year, Anwar allegedly told a press briefing at the party's Nayapaltan office that hundreds of copies of the holy Quran were set ablaze by some ruling party men led by Swetchhasebak League leader Debashish Biswas during the mayhem caused by Hefajat-e Islam in the capital's Paltan and Gulistan areas on May 5.

On May 7 the same year, Sub-Inspector Md Nasir Uddin of Paltan Police Station filed a general diary in this regard accusing Anwar of hurting religious sentiments.

After an investigation, SI Aminul Islam pressed charge against MK Anwar on June 17 last year under the ICT act.

Debasish also filed a case against Anwar for allegedly inciting communal discord.

He said during primary interrogation, Nasir confessed that he made the threat.

Nasir wanted to influence a verdict, in his favour in a land related case, which was to be passed on October 14, said the deputy commissioner.

Kushum Dewan said Nasir wanted to frighten the defence so that they would be absent on the day, which might have ultimately swayed the judge in passing the verdict in his favour.

So, he [Nasir] called advocate Manas Kumar Das of Chittagong court and said Jama'atul Mujahideen Bangladesh would blow up the court building, Dewan added.

Nasir said he had given a piece of land to a developer company, but later another man claimed to own a part of the land, Dewan said, adding that the developer company demanded Tk 1 lakh in compensation, and Nasir was afraid that the verdict would not be in his favour.

Engr Md Hasan Chowdhury, additional deputy commissioner of DB, said they have not found any connection between Nasir and JMB.

## Detectives arrest two more

Detective Branch of Dhaka Metropolitan Police (DMP) Joint Commissioner Monirul Islam told a press briefing in the capital's DMP Media Centre yesterday.

The first arrest, of Sharif alias Chokka, was made in Tangail's Dhonbari on October 14.

Still on the run are four more accused, including the prime accused Mamun, who along with four other cohorts are already accused in a case for the physical and sexual assault on a pregnant woman and 10 of her family in Bhashantek slum area in February.

The criminals had carried five firearms during the killing. Detectives are trying to recover the others and arrest the rest, said Monirul.

On the night of October 10, Sharif took the youth, Nasir Hossain, to Mamun and his gang who indiscriminately beat and stabbed him, leading to his death at Dhaka Medical College Hospital two hours later, said the case statement.

The gang is known for extortion, mugging and stalking girls in the locality, Monirul said.

Following the incident, 19 police members of Bhashantek Police Station were suspended over allegations of keeping warm relations with local goons while officer-in-charge Hosne Ara Begum was transferred and inspector (investigation) Muhamamd Golam Nabi Sheikh closed.

Monirul said if investigations found police negligence, departmental and legal actions would be taken.

# Sweden good study location

## Says envoy

International students opting for studying in Sweden hardly face the language barrier as English is mandatory in Swedish education, said Swedish Ambassador Johan Frisell yesterday.

Bangladeshi students are highly competitive and they can always apply for scholarships and funding for studying in Sweden, he said, adding that nearly 90 Bangladeshi students had received scholarships among 500 international students in Swedish universities in the past few years.

The ambassador was addressing Bangladeshi students aspiring to study in Sweden at an event organised by an educational consultancy firm, Steps, at The Daily Star Centre in the capital.

He also assured that living cost in Sweden is lower compared to other industrialised European countries.

Stating the international nature of Swedish culture, Jonah Frisell said about 25,000 foreigners study in Sweden while a large proportion of the people are immigrants.

Abu Saleh Md Mazed, chairman of Steps, said students who are willing to stay abroad after completion of their courses should go to Sweden as they will be able to apply for permanent resident card.

Officials of two Swedish universities -- Jonkopings University and the University of Boras -- consulted interested students at the event.
