

'CONTEMPT OF COURT' HC summons three BCBL officials

The High Court yesterday summoned three high officials of Bangladesh Commerce Bank Ltd (BCBL) including its chairman for not complying with an HC order for serving notices on an elected director of the bank for attending its board meetings.

BCBL Chairman Yousef Ali Howlader, its Managing Director Abu Sadek Md Sohel and its Secretary Md Saiful Islam have been asked to appear before the HC at 10:30am on November 10.

The HC also issued a rule upon the three BCBL officials to explain why proceedings of the contempt of court should not be initiated against them.

The court came up with the order after hearing a contempt of court petition filed by the elected director Zakir Hossain.

Following a previous petition filed by Zakir, the HC on September 9 ordered the three to serve notices to Zakir so that he can attend all the board meetings and to inform the HC after complying with the order through swearing an affidavit on September 14, said Zakir's lawyer citing from the petition.

Countrywide road accidents killed four people and injured three others yesterday.

Our Munshiganj correspondent reports, Abul Kashem, 40, of Badhrapara village died and two people were injured when a truck ramed into a rickshaw in Tongibari upazila.

Our Bogra correspondent reports, Naznin Akhtar, 8, daughter of Javed Ali of Baropur Moddayapara died and her sister was injured when a microbus hit them while they were crossing Rangpur-Dhaka highway in Noadapara area of in Bogra town.

Meanwhile, Krisno Komol, 42, of Rangpur died when a truck hit him on the highway in Palsha area.

Komol was the coordinator of Bangladesh Shomajtantrik Dal Convention Committee of Bogra-unit and an accounting lecturer of Joypurhat Mahila College.

A correspondent from Chittagong adds Md Helal, 30, of Bhola died when a truck hit him while he was repairing his truck on Chittagong-Dhaka Highway in Shitalpur under Sitakunda Police Station.

Shirin returned home from Cameroon yesterday afternoon after being elected chairperson of the CPA.

At the press conference, the Speaker termed their victories the victory of Bangladesh, its people, 10th parliament, democracy and the government.

The assailants attacked with machetes and large knives, leaving Abul with wounds on his right shoulder and left wrist while his son, who came hearing his father's scream, on the face and both legs.

They left the flat soon without taking anything as locals were gathering there hearing their screams," said the son.

The victims suspected that the attack came as a consequence of robbery but police said they did not loot anything.

Police visited the spot while an investigation is underway to unearth the motive behind the attacks, said Rafiqul Islam, officer-in-charge of Sabujbagh Police Station.
