### AMASSING WEALTH ILLEGALLY ACC now sues

After implicating former state minister for housing and public works Abdul Mannan Khan for amassing wealth illegally, the Anti-Corruption Commission yesterday sued his wife Syeda Hasina Sultana with the same allegation.

ACC Deputy Director Nasir Uddin lodged against Sultana for illegally amassing wealth worth Tk 3.45 crore and concealing information about property worth Tk 1.86 crore.

According to the case, Sultana submitted her wealth statement to the ACC on April 9, stating that she had immovable property worth Tk 2.46 crore and moveable property worth Tk 9.50 lakh.

But according to Sultana's income tax return documents, her total movable and immovable property is worth Tk 3.59 crore and her valid income is only Tk 14.30 lakh, said an ACC official.

# FORCEFUL CONVERSION OF HINDUS TO ISLAM IN 1971 Another witness accuses Jabbar

Another prosecution witness has testified that on orders of war crimes accused Abdul Jabbar, Razakars forced around 200 Hindus to convert to Islam at the end of May during the Liberation War.

In his deposition before the International Crimes Tribunal-1 yesterday, Mohendra Adhikari, 84, the 14th prosecution witness, said Razakars -- an auxiliary group to the Pakistan occupation army -changed his name to "Mahbub Khan" after

forcing him to accept Islam as his religion. So far, four victims of the forced conversion at Phuljhuri village of Pirojpur testified

before the tribunals and all of them gave almost similar depositions.

The witness said about 30-40 Razakars led by Jabbar and the Pakistani occupation army attacked his village on May 17, 1971 and looted and set fire to about 360 houses.

About 8 to 10 days later, Razakars and Peace Committee members came to the village and told them that Jabbar had given them instructions that Hindus should convert to Islam if they want to live.

"Afraid for our lives, we conceded to accept Islam," he said. Two to three days after, several "converted Muslims" were forced to eat beef.

Abdul Khalek, another third year student, said the principal deliberately failed them as the students had been vocal against her irregularities and corruption, which were also reported

answer sheets, so there was no scope for manipulating the results.

Last year, only 12 among 71 students passed the first year final exam while this year 31 out of 83 succeeded which indicates improvement, Hosne Ara said, adding that she had already applied for her LPR (leave preparatory to retirement) yesterday.

Prof Dr Selim Mohammad Jahangir, dean of the Faculty of Medicine of Chittagong University, under which comes the college, said they also wanted more students to pass the exam and held the inadequate number of qualified teachers for the result bizarre.

tempt of court, cabinet decision, any investigation process and prejudicial to the rights of the House of the Nation. MRDI Executive Director Hasibur Rahman said the law was enacted to protect peoples' right to information and ensure transparency and accountability

in government and non-government offices. But some authorities do not provide information by misinterpreting and misusing section-7. It may jeopardise

the main target of the law, he said. Hasibur placed a series of recommendations, which were prepared on the basis of a survey conducted on 242 people by the MRDI from February to August, to revise the section.

A clause that said "any such information that may, if disclosed, impede the process of investigation" are not mandatory to be provided, can be amended as "any such information that may, if disclosed, impede the process of investigation and the process of taking a final decision", according to the recommenda-

Two subsections -- "any such information which is, according to the law, liable to be published only for a certain period of time" and "any such information pertaining to a governmental purchase process before it is complete or a decision has been taken about it"-- may be omitted, he proposed.

Hasibur also suggested that different subsections, which talked about almost the same issues, be merged together.

Other recommendations include -clarifying all the subsections in detail, developing Information Disclosure Policy for all government and nongovernment institutions, and setting up help-desk and updating information

preservation system at all offices. Addressing the function as chief guest, Information Minister Hasanul Haq Inu said restrictions on provid-

ing some types of information had been imposed for the security of the state and society as well as for protecting institutional and individual dignity. "It might be amended, if comprehensive suggestions and demand come from all stakeholders," he

MJF Executive Director Shaheen Anam said, "We need to collect more evidence of how section-7 is being misused. Then we can show the authorities concerned in which sectors the right to information act does not work properly." Additionally, interest should be raised among the public about using the act more and more,

she added. Former information commissioner Prof Sadeka Halim cited different examples in the education sector where authorities show reluctance to disclose
