Ashraf's comments make it clear that Latif indeed had sent his reply to the show-cause notice sent by the AL on October 14 asking him to explain why his party membership wouldn't be cancelled. However, the ruling party

never officially admitted it. On whether or not Latif would retain his membership in parliament, the AL spokesperson said the party resolution would be sent to the Election Commission, the sole authority to decide on the matter. "Whatever decision the Election Commission makes will be the final one."

According to article 46 (Kha) of the AL constitution, appeals can be made to the AL national committee against any punishment measure taken by the ALCWC. And the decision made by the AL national committee will be considered the final.

### Abducted Chinese worker freed in Sudan: Minister
