### Amnesty Int'l for moratorium on executions

Amnesty International yesterday urged the government to immediately impose a moratorium on executions as a first step towards abolition of the death penalty and ensure that political interference does not mar judicial processes.

The organisation made the appeal

in a statement issued hours after the Supreme Court upheld the death sentence of Muhammad Kamaruzzaman, a senior leader of the Jamaat-e-Islami, for crimes against humanity during the

Liberation War. Amnesty opposed the death penalty in all cases without exception, regardless of the nature or circumstances of the crime: guilt, innocence or other characteristics of the individual, or the method used by the state

to carry out the execution, read the

statement. "The relentless push to impose death sentences in Bangladesh is deeply worrying. After a hiatus of nine months since the last death sentence was announced, three more men have now been sentenced to the gallows in the space of less than a week," said the organisation quoting

its researcher Abbas Faiz. The rights group pointed to the remarks of Prime Minister Sheikh Hasina and Attorney General Mahbubey Alam where the PM, following the verdict of the SC against Kamaruzzaman's appeal, said the death sentences would be carried out. The attorney general also said there would be no possibility of any other

Although the constitution guarantees the right of defendants to apply for a review of the judgment issued by the Supreme Court as the last avenue of appeal, the attorney general's statement against the possibility of any more reviews appears to undermine this right, it said.

judicial remedy.

"The outcome of ICT proceedings has become intensely politicised. The government must not bow to political pressure from its supporters, but instead immediately commute all death sentences in the country and impose a moratorium on executions with a view to full abolition," the statement mentioned quoting Abbas.

It also said 140 countries have abolished the death penalty in law or practice. Bangladesh was one of only nine countries that carried out executions every year between 2009 and 2013.

The proposed trip has become necessary as the probe into the October 2 blast in a Burdwan house has led to various leads that pointed to alleged involvement of JMB people, sources said.

The NIA last week announced a cash reward of Rs 10 lakh for information leading to the arrest of main accused Kausar, Nasirullah, Sajid (all believed to be Bangladeshis) and West Bengal residents Talha Sheikh and Maulana Yusuf Sheikh.

The blast took place inside a house at Khagragarh, killing one Shakil Ahmed instantly. Another person Sovan Mandal died of his wounds at a hospital. The two were suspected to have terror links.

The NIA, which was being assisted by West Bengal police, was unable to prepare sketches of either Sajid or Nasirullah. During its visit to Bangladesh, the NIA team will try to find out more about the two so that a sketch could be circulated among various police agencies, said sources.

Our diplomatic correspondent adds, New Delhi yesterday formally handed over a report containing the information on the blast and subsequent outcome of primary investigation by the NIA to Dhaka, a Bangladesh foreign ministry source

told The Daily Star.

According to the source, the Indian government informed Bangladesh that no substantial evidence has emerged so far to give any clue about the exact plans of JMB on a plot to target Bangladesh government leaders.

# Ponta leads Romania presidency vote after first round

Romania's Prime Minister Victor Ponta led the first round of the presidential election according to nearcomplete results yesterday, but he was pushed harder than expected by his conservative rival.

The European Union is watching the election closely because of fears that Ponta could reverse reforms aimed at tackling rampant corruption in one of the bloc's poorest countries. Official results from Sunday's vot-

ing showed Ponta, a social democrat, took just over 40 percent of the vote after 91 percent of the ballots were counted. "I am delighted that so many

my programme which aims at developing Romania and ending discord," 42-year-old Ponta said. But the race is tighter than expected, with his main rival, 55-year-old liberal

Klaus Iohannis from the Germanspeaking minority, on 30.5 percent. The second round will take place on

November 16.

second round. Much depends on the instructions given by candidates eliminated in the first round," Kivu said. The vote is seen as a crucial test for

the former communist country at a

time when democracy has suffered setbacks in some neighbouring states such as Hungary, and as the Ukraine crisis has shaken relations between the European Union and Russia.

The election campaign has been marred by scandal, with numerous corruption probes including some aimed at allies of the prime minister, and a settling of scores between Ponta and his long-standing rival President Traian Basescu. The popular centre-right Basescu,

who has accused Ponta of being a former spy, cannot run for a third term. He and Ponta have shared two stormy years at the top of Romanian politics. Whoever takes over the presidency

will face pressing issues including recession and persistent accusations of corruption and bad governance. Romania's head of state is responsi-

ble for foreign policy and top-level appointments such as prosecutors in the second poorest EU country after Bulgaria. "I think these elections can be a

maturity test for Romania," said Corina Rebegea from the Centre for Analyst Mircea Kivu said the out- European Policy Analysis in Washington.

The country needs "a president who can imprint a clear sense of vision about how we continue to build a democratic system of governance and rule of law, and prove that 25 years of transition are worth something."

# 23 Palestinians arrested in east Jerusalem

Israeli police arrested at least 23 Palestinians in east Jerusalem overnight and during yesterday, Palestinian officials said, in the latest crackdown after months of violent clashes in the Holy City.

But a police spokeswoman confirmed only four arrests, without accounting for the number of people who might have been arrested by other security services. Those arrested were from Issawiya

and Wadi Joz -- Arab neighbourhoods in Israeli-annexed east Jerusalem -- as well as the Old City, the Palestinian Prisoners Club said in a statement. On Thursday, police shot dead a

suspect in the attempted murder of a rightwing Jewish rabbi, sparking a day of clashes between stone-throwing Palestinians and security forces who responded with tear gas and rubber bullets.

The latest arrests came on top of the detention of some 111 Palestinians since October 22 over east Jerusalem violence, according to police figures.

around east Jerusalem, and yesterday in the neighbourhoods of Issawiya and flashpoint Silwan, roads were barricaded with makeshift checkpoints, local activists said.

Violence soared in the tense eastern sector of the city during the summer, after

the brutal July murder of a Palestinian teenager by Jewish extremists in revenge for the killing of three Israeli teens in the West Bank, and during the ensuing 50day war in the Gaza Strip.

Clashes have picked up again over the past few weeks, focused mainly on tensions around the Al-Aqsa mosque compound, a disputed holy site sacred to both Muslims and Jews in the heart of Jerusalem's Old City.

#### N Korea denies role in smartphone hacking in South

North Korea's state media yesterday blasted South Korea's spy agency for alleging that Pyongyang hacked tens of thousands of smartphones in the South using malware disguised in mobile gaming apps.

The South's National Intelligence Service (NIS) said in a report to parliament last week that the North Police have tightened security attempted to hack more than 20,000 South Korean smartphones between May and September.

The agency said it had worked with the owners of South Korean websites and government officials to remove the applications and block hacking channels.

Jafar Sadik, 23, son of Additional Deputy Inspector General Mozamme Hossain of CID, knocked down Mrityunjoy and dragged him yards along the street in Banani area on Thursday afternoon. The victim died on the spot.

Jafar, who was driving his father's Toyota Allion car, could not show any driving licence to police. Soon after the accident, Banani police arrested him and seized the car. He was freed on bail the following day. The family now fears that they

However, Attorney General (AG) Mahbubey Alam said after the Appellate Division delivered its verdict in Quader Mollah's case, a review petition was filed from the defence's side which was dismissed later.

"Besides, we have not yet received any judgment on whether the Appellate Division would allow any review petition," he said referring to the full text of the judgment on Mollah's review petition, which is yet to be published.

The attorney general however opined that there was no scope to file a review petition against the Supreme Court verdict that upheld Jamaat leader Kamaruzzaman's death penalty.

As for the defence's decision to file the review petition, Alam said, "The trial is being held under a special act [The International Crimes (Tribunals) Act-1973] which is a constitutionally protected law."

People of Sohagpur village in Sherpur will be happy with the verdict against Kamaruzzaman, he said referring to the charge on which the war criminal was awarded death penalty by the ICT-2.

The SC bench headed by Justice Surendra Kumar Sinha upheld the death penalty of Kamaruzzaman, by majority view, for killing 164 people at Sohagpur village in Sherpur during the Liberation War in 1971. Prosecutor Tureen Afroz, in her

immediate reaction, told reporters that the prosecution panel was satisfied with the judgment as it "fulfilled the expectation of the nation." The government too expressed

commemoration of the assassinations of four national leaders -- Syed Nazrul Islam, Tajuddin Ahmad, Capt M Mansur Ali and Quamruzzaman.

Referring to BNP Chairperson Khaleda Zia's oft-repeated antigovernment movement, Hasina, president of the ruling Awami League, said, "I am urging her to launch a movement, taking people with her and then we will have no problem. But you will have to cut ties with terrorists, militants and war criminals as there is no place for them in the county."

The BNP is finding it difficult to "swallow or spit out" its ally Jamaat-e-Islami. Khaleda can neither cut her ties with Jamaat, nor can she continue her relationship with the party, Hasina said. Boycotting the January 5 national

election was Khaleda's wrong decision, she said, adding that people were not supposed to get punished for her mistakes.

The premier lambasted Khaleda for her remark that the incumbent government is illegal. "Ziaur Rahman declared himself

president illegally and formed BNP in the same manner. So, as the chief of an illegal party, she [Khaleda] always considers everything of the present government illegal."

Hasina accused former president Ziaur Rahman of burying country's democracy by taking over the state power illegally and rehabilitating the anti-liberation forces in politics after the assassination of Bangabandhu Sheikh Mujibur Rahman in 1975.

She also accused her special envoy and Jatiya Party Chairman HM Ershad of patronising and rehabilitating the killers of Bangabandhu and the four

national leaders.

The present government was elected through people's mandate, the AL chief said. The whole world recognised the latest parliamentary election, she said,

citing Bangladesh's victory in the bat-

tle for the top posts of two global parliamentary forums -- Commonwealth Parliamentary Association and Inter Parliamentary Union. Referring to Khaleda's claim that her husband BNP founder Ziaur Rahman
