

# Cop held for abduction

**STAFF CORRESPONDENT**  
A plainclothes police constable was arrested by the Rapid Action Battalion in the capital yesterday on charges of abducting a land broker and demanding ransom.  
Being informed by the land broker, Abdul Mannan Mridha, 48, Rab arrested the constable, Jahangir, 30, of Rajarbag Police Line, in Dhanmondi.  
Jahangir and two other policemen abducted Mridha on Thursday in Karwan Bazar area and released him on Friday night after forcing him to sign a cheque for Tk 1.5 lakh.

Jahangir again met Mridha yesterday and demanded an additional Tk 6 lakh when Rab arrested him, said Md Kamrul Islam, assistant superintendent of police (ASP) of Rab.  
Arrested, Jahangir told Rab that Mridha swindled people and took around Tk 65 lakh from Novera Haque, 45, a Bangladeshi woman living in London.  
When contacted by Rab, Novera said she was swindled by Mridha, added Kamrul Islam.  
Rab said both Mridha and Jahangir would be handed over to police.

# District courts to get CMC

Chief Justice Muzammel Hossain said the yearly case disposal rate in three pilot districts had increased from 74 percent to 98 percent.  
He said, "In our justice system the overall responsibility of case flow management lies with the judges...I firmly believe that judges can, through effective utilisation of Case Management Committees, bring a qualitative change in this regard."  
He also opined considering new and innovative measures to expedite speedy dispensation of justice, including amending some provisions in existing laws.  
Law Minister Anisul Huq said there has

been a usual rise in the number of cases and new and innovative ways should be researched to reduce the time taken for trials. "The performance of Case Management Committees, however, made us optimistic," he added.  
UNDP Country Director Pauline Tamesis emphasised joint efforts of all justice institutions to ensure coordination and address the issue of widening access to justice for all, including people who were vulnerable.  
Judges of both Appellate and High Court divisions of the Supreme Court, judges of district courts and metropolitan session judge courts and chief judicial and chief metropolitan magistrates attended.

Fearing attack, he jumped into the river and swam 40 minutes before being rescued by a trawler, he said, adding that there were 10 people including nine crew members and workers and a friend of Shamim on board the vessel.  
Quoting Parvez, OC Kabir said two crew members had been in conflict with Shamim and Titu since Titu beat up and drove away the cook of the vessel on October 31 and replaced him another cook of their choice.  
He, however, said everything would be revealed after knowing the fate of the missing seven.
