DEATH SENTENCE Nizami asks lawyers to appeal against verdict STAFF CORRESPONDENT

Three counsels of convict Jamaat-e-Islami chief Motiur Rahman Nizami met him at Kashimpur jail yesterday, for the first time after the International Crimes Tribunal-1 on October 29 sentenced him death for committing crimes against humanity during the Liberation War in 1971.

The lawyers are Nazib Momen, also Nizami's son, Motiur Rahman Akand and Asad Uddin.

"He [Nizami] still believes that he is innocent and asked us to file appeal [against the verdict]," Asad told The Daily Star last night.

He also gave some instructions about some documents and testimonies of witnesses, which would be required to file the appeal, Asad said.

"His physical condition is almost sound," added the defence lawyer.

The tribunal sentenced Nizami, the chief of infamous Al-Badr force, an auxiliary force of Pakistani army, for four charges including the planned killing of intellectuals in the last part of the Liberation War in 1971.

All activities suspended for workers' strike

The workers of all cargo carriers plying the inland waterways across the country launched an indefinite strike yesterday after seven people aboard a fertiliser-laden lighter vessel went missing in Laxmipur the night before following what they said a robbery.

Though police claimed that it was an incident of internal fighting among the crew, they could not confirm what actually happened. Ten people were on board MV Karnaphuli-5, when it was headed towards Baghabari from Chittagong on Friday night. Three were rescued.

After the news spread, the lighter vessel workers at Chittagong Port and 16 private jetties of the Karnaphuli River stopped working, demanding security on the inland waterways which, the strikers said, is infested with frequent robbery, extortion.

The strike gradually spread to other parts of the country including Mongla and Narayanganj, and by the afternoon, around

three lakh workers of 20,000 cargo carriers including lighter vessel, coaster vessel, bulkhead, tanker, and barge, in the country joined it, said Chowdhury Ashikul Alam, general secretary of Bangladesh Noujan Sramik Federation.

He said the strike, which brought to a halt the transportation of cargo by river all over the country, would continue until the rescue of the seven. Ashikul said robbery and extortion were

SUCCESS IN QUICK CASE DISPOSAL District courts to get CMC: Chief justice

Having succeeded in aiding the quick disposal and reduction of the huge backlog of cases, Case Management Committees (CMCs) are being formed in the remaining 61 district courts alongside in five metropolitan session courts, Chief Justice Md Muzammel Hossain said yesterday.

The Supreme Court Special Committee for Judicial Reforms took the decision in September, he told a national seminar on CMCs, organised by Judicial Strengthening Project (JUST) at the Supreme Court auditorium in the capital.

JUST has been jointly implemented by Bangladesh Supreme Court and United Nations Development Programme (UNDP).

Functioning as pilot schemes in Dhaka, Kishoreganj and Rangamati district courts since February 2013, CMCs have been monitoring case flow management, identify causes of delays and taking necessary remedial measures to reduce

delays and ensure speedy disposal. The huge backlog was one key constraint of Bangladesh's judiciary, creating considerable pressure on the justice delivery

system and hindering access to justice, said the chief justice. SM Kuddus Zaman, national project director of JUST, said

around 2.7 million cases had pending around the country.

Political hindrance is the foremost cause that foils any attempt for planned urbanisation in the country, said Narayanganj city Mayor Selina Hayat Ivy at a seminar in the capital yesterday organised marking the world town planning day.

"We cannot protect rivers, canals, ponds and wetlands from being grabbed by real estate developers despite repeated public pledges by the prime minister for conservation of those...Are the real estate companies more powerful than the government?" she

In many instances she said to have failed to implement schemes for planned urbanisation primarily due to impediments either created by powerful political quarters or resource constraints and lack of manpower.

"I really feel helpless in running the city corporation with the local government's power centralised at the ministry," said Ivy, who has served as an elected chairman of Narayanganj municipality for eight years and as the mayor for the last three years.

She stated to have written 40 letters to the authorities during tenures of three governments -- one led by BNP and two by Awami League -- to save a 17-acre water body in the

heart of Narayanganj. "Finally, I took it upon myself as the mayor to save the water body at any cost no
