

Pak court issues arrest warrant against Khan AFP, Islamabad

A Pakistani anti-terrorism court has issued arrest warrants for cricketer-turnedpolitician Imran Khan and populist cleric Tahir-ul-Qadri over violence during anti-government protests, officials said yesterday.

Judge Syed Kausar Abbas Zaidi issued the orders for Khan, Qadri and 26 other people at Islamabad's Special Anti-Terrorism Court on Wednesday, a

court official told AFP. Weeks of protests led by Khan and Qadri seeking the resignation of Prime Minister Nawaz Sharif descended into several days of violence at the

end of August. Demonstrators clashed with police, attempted to storm parliament and briefly took over state broadcaster Pakistan Television (PTV), taking its news channel offair for a while.

A police spokesman told AFP no arrests had been made so far, but cases had been registered under antiterrorism laws for attacking PTV, parliament and other official buildings, and clashing with police.

Qadri called off his protest last month and has left for Canada, where he is normally based, but Khan continues to address supporters from the top of a shipping container outside parliament most evenings.

Kerry pushes peace in Jerusalem

More clashes as Israel says won't cooperate with UN Gaza inquiry

Top US diplomat John Kerry mounted a diplomatic push yesterday to calm surging tensions in Jerusalem through meetings in Jordan with the Israeli and Palestinian leaders.

held talks with Palestinian president Mahmud Abbas in Amman, officials announced that Israeli Prime Minister Benjamin Netanyahu would also join the diplomatic flurry. "They will focus on ways to restore

Hours after the secretary of state

calm and de-escalate tensions in Jerusalem," State Department deputy spokeswoman Marie Harf said of the planned three-way talks between Kerry, Netanyahu and Jordan's king.

It came hours after fresh clashes broke out in east Jerusalem where Israeli police fired tear gas, percussion bombs and rubber bullets to disperse Palestinian demonstrators.

Months-long unrest in annexed east Jerusalem has in recent days spread to the occupied West Bank and Arab



communities across Israel, raising fears of a new Palestinian uprising.

On Wednesday Israel approved plans for another 200 settler homes in annexed east Jerusalem -- a move sharply criticised by Washington.

Kerry and a sombre-looking Abbas embraced and had a brief whispered exchange as they met at the Palestinian leader's hillside villa in Amman where the US and Palestinian flags hung in front of a large night-time photo of Jerusalem's flashpoint Al-Aqsa mosque.

Much of the unrest in Jerusalem has

been fuelled by Israeli moves to step up settlement activity in the city's eastern sector and by religious tensions at the Al-Aqsa compound, a site holy to both Muslims and Jews.

Israel's Public Security Minister Yitzhak Aharonovitch said the authorities were on alert for more unrest, after several attacks in recent weeks by Palestinians wielding knives or ploughing cars into pedestrians.

Meanwhile, Israel on Wednesday said it will not cooperate with a United Nations inquiry into its 50-day war with militants in Gaza this summer.

"Since the Schabas commission is not an inquiry but a commission that gives its conclusions in advance, Israel will not cooperate with the commission of the UN Human Rights Council over the last conflict with Hamas," foreign ministry spokesman Emmanuel Nahshon said in a statement.

The Gaza war, which ended with a truce on August 26, killed more than 2,140 Palestinians, most of them civilians.

FAKE ENCOUNTER IN KASHMIR 7 Indian soldiers sentenced to life

An Indian military court has sentenced seven soldiers to life in prison for killing three Kashmiri youths in a rare ruling against the army, the tense region's top official said yesterday.

Kashmir Chief Minister Omar Abdullah said the soldiers shot dead the youths in 2010 after staging a gun battle and claiming they were trying to sneak across the disputed border from arch rival Pakistan. Rights groups have long accused the thousands of Indian

soldiers deployed in Kashmir of acting with impunity, as they search for militants fighting against Indian rule for independence or merger of the region with Pakistan. Families of the victims claimed the army lured the three

close to the de-facto border that divides Kashmir between India and Pakisan, on the promise of jobs and money, before staging the "fake encounter".

The killings in Machil sector sparked widespread protests in Kashmir at the time, leading to 120 deaths, according to the Press Trust of India news agency. The army declined to confirm when the military court's

ruling was handed down. According to local media, court martial proceedings began in January this year against the seven and ended in September.

Amnesty International applauded the sentences, but called for allegations of human rights abuses to be probed by civilian courts instead of the army itself.

Under an emergency military law known as the Armed Forces Special Powers Act, soldiers deployed in Kashmir cannot stand trial in civilian courts without express permission of the federal government in New Delhi.

About a dozen rebel groups have been fighting Indian forces since 1989 for Kashmir's independence or for its merger with Pakistan. The fighting has left tens of thou- India's family planning sands of people, mostly civilians, dead.

STERILIZATIONS Indian cops nab 'culprit' surgeon

An Indian doctor who conducted mass sterilisations that killed 13 women has been taken into custody, after saying he was being made a scapegoat for a controversial family planning scheme.

RK Gupta was detained for questioning amid mounting anger over the botched operations in central Chhattisgarh state, where women were paid to undergo a procedure that also left dozens in hospital, police said Thursday.

Gupta operated on 83 women in just five hours -spending an average of less than four minutes on each patient -- at a state-run camp in Bilaspur district at the weekend.

The impoverished women were paid 1,400 rupees (\$23) to undergo the surgery.

Gupta said the government was wrongly accusing him and blamed the drugs that were used during the surgery, as activists called for scheme to be overhauled.

Alexander-era tomb mystery grips Greece

AFP, Thessaloniki

Archaeologists are holding their breath that a skeleton found in a mysterious, richlydecorated tomb from the time of Alexander the Great will solve the riddle of who ancient Greece's biggest burial mound was built for.

Having dug their way past huge decapitated sphinxes, broken through a wall guarded by two caryatids and emptied out an antechamber decorated with stunning mosaics, experts have finally found the body it was all built for, the Greek culture ministry

said Wednesday. The bones were found scattered around a wooden coffin in the third room of the vast mound near Amphipolis in northern

Greece. The ministry said the remains were clearly those of "a powerful personality, which can be seen from this unique tomb", with speculation rife that it could be that of Roxana, Alexander's Persian wife, his mother Olympias, or one of his generals.

The tomb's near-intact sculptures and staggering mosaics have been a cheering reminder to Greeks of past glories with the country

Whoever the massive fourth-century BC structure holds, historians say it is highly unlikely to be Alexander himself, who conquered the Persian empire and much of the known world before his

death at the age of 32. After his mysterious end in Babylon he is said to have been buried in Alexandria in Egypt, the city he founded -although no grave has ever been found.


