The prime minister while flagging his concern over cross border tax avoidance and evasion also noted that increased mobility of capital and technology have created new opportunities for avoiding tax and profit sharing.

The three-page communique was released at the end of the two-day summit of Group of 20 industrialised and leading emerging economies hosted by Australia.

Welcoming the "significant progress" on the G20/OECD Base Erosion and Profit Shifting (BEPS) Action Plan to modernize international tax rules, it said, "We are committed to finalizing this work in 2015, including transparency of taxpayer specific rulings found to constitute harmful tax practices."

Briefing newsmen, Indian Railways Minister Suresh Prabhu and external affairs ministry spokesperson Syed Akbaruddin said the reference to transparency, which was not there in the draft communique, was incorporated in the final communique after prime minister's strong intervention at yesterday's plenary session.

After Modi's intervention, several countries, notably Brazil and South Africa wanted a reference to be made to transparency in the final communique, Akbaruddin said.

"After the prime minister's own and strong intervention (on repatriation of black money), several countries shared his sentiments and wanted the views to be reflected in the final communique," he said.

FROM PAGE 16 Footage of the high-speed ride showed a live display in each carriage keeping a constant record of the velocity as passengers watched the blur through aeroplane-sized windows.

The Central Japan Railway Company is running eight days of testing for the experimental maglev Shinkansen train on its test track in Yamanashi Prefecture, the BBC reported.

Maglev trains are even faster than Japan's famous bullet trains, which currently travel at about 200 mph (320 kmh).

They will eventually consist of 16 carriages, carrying up to 1,000 passengers at a time and cutting the current travel time by more than half, from 90 to 40 minutes.

Japan's reputation for highspeed rail started in 1964 with the unveiling of its first bullet train coinciding with the Summer Olympics.

The central line in the country the Tokaido Shinkansen – is the world's busiest high-speed rail, carrying 151 million passengers

each year. Britain's HS1 line connecting London with the Channel Tunnel through Kent allows speeds of up to 186 mph (300 kmh) in its fastest section and the planned HS2 could reach 225 mph (360 kmh).

Malum said Subhan was to be charged with superior responsibility on all nine charges and started to readout from the testimonies of prosecution witnesses.

At one point, Tribunal-2 chief Justice Obaidul Hassan said, "You need not go into facts as we have heard it [during factual arguments]. You have to establish a superiorsubordinate relationship between the accused and his alleged subordinates."

Citing the testimony of the second prosecution witness, Malum said Subhan advised his men to commit crimes that indicated his superior status over them. As he started to read from another

testimony, Justice Mozibur said, "The portion you read out does not contain even the name of the accused." But Malum said, "I am just speak-

ing about incident. His presence and participation in such crimes has been proved from the testimonies of earlier two witnesses."

Malum said Subhan held superior position over his subordinate as the district ameer of Jamaat and Razakar commander of Pabna. When Justice Mozibur Rahman

asked whether the prosecution would get any benefit if they could prove Subhan's superior liabilities, Malum replied in the affirmative. Justice Hassan said, "You have held

"If you read the whole one after another, then it would take the entire day -- it may even take four more days," said Justice Hassan. The prosecution has already taken six days to complete factual arguments.

Then Justice Mozibur Rahman said pressing the third charge, the prosecution said the Pakistan army was under Subhan's control. "Would you please show how the Pakistan army worked as subordinate to the accused?" asked the judge. Again citing the testimony of a wit-

ness, Malum said there were Pakistan army men and their collaborators in a camp and the victims were released from the camp following Subhan's orders, which proved Subhan's superior position over the army.

"Had the Pakistan army not obeyed Subhan, how would they [victims] have gotten released? In this specific incident, the Pakistan army worked as subordinate to Subhan," claimed Malum. Justice Mozibur Rahman said while

pressing the fifth charge, the prosecution claimed that Subhan had control over the Pakistan army. "How will you prove it," he asked. Subhan took the Pakistan army to the spots and showed the people to

New US-led strikes on Syria's Kobane: monitor

The US-led coalition against the Islamic State jihadist group carried out a series of air strikes overnight in the embattled Syrian town of Kobane, a monitor and activists said yesterday. The Syrian Observatory for

Human Rights also reported intensifying clashes between Kurdish fighters defending Kobane and IS jihadists in the south of the town, which lies on the Turkish border. Kurdish activist and Kobane resi-

dent Mustefa Ebdi reported at least seven international air strikes overnight. He said the explosions could be

heard 20 kilometres from Kobane, and shook the cars of people with him on the border between Turkey and Syria.

In southern Kobane, meanwhile, the Britain-based Observatory said fierce clashes underway for the past three days were continuing with reports of injuries on both sides.

Pricier, next year

Households with metered cooking stoves will see a price hike of 60.68 percent to Tk 235 from Tk 146.25. Houses with one-burner stove

will see their monthly charges for cooking go up by 112.50 percent to Tk 850 from Tk 400.

For two-burner stoves, the rise will be 122.22 percent to Tk 1,000 from Tk 450.

The average sales price of 1,000 cubic metres of gas now stands at Tk 139.62, which retailers say are much higher in neighbouring coun-

Retailers have proposed increasing the average retail prices by 40 percent to Tk 195.70 per 1,000 cubic metres, according to the documents seen by The Daily Star. Due to the low cost, there has

been a huge wastage thanks to inefficient usage of gas, depriving the government of revenues. Last time the government raised

the gas price was in 2009. In the last six years, only CNG prices went up twice in 2011, said Salim Mahmud of BERC. Though the gas prices went up by 11 percent in 2009, all the addi-

tional money accrued from the raise went to the Gas Development Fund. Meanwhile, the Power

Development Board (PDB) has proposed a 18.12 percent rise in bulk electricity rates. The State-run PDB sells power to

the five retailers at an average rate of Tk 4.67 per kilowatt-hour unit of electricity although the production cost is Tk 6.54 per unit. This gap has imposed a bulk tariff deficit of Tk 1.87 per unit on

subsidy of Tk 7,560 crore related to the tariff-induced deficit in 2013-14, said Salim Mahmud. The Rural Electrification Board (REB) has expanded its customer

base tremendously in the last several years, he added. "As a result, PDB is being forced to incur losses as the PDB sells electricity to the REB in the lowest rate in the country." The PDB has proposed an

increase of Tk 0.84 per unit to take the bulk tariff rate to Tk 5.5 per The bulk power tariff (the prices

retailers pay) will go up first and then the retail tariff (the prices end consumers pay) will be adjusted, added the BERC member. "This is a major jump in house-

hold gas price. It will be another burden on us," said Afsana Moni, a housewife in the capital's Mirpur area, when asked about the latest move to raise gas and power tariff. Asif Ibrahim, vice-chairman of New Age Group, said the increase of

gas prices for industry would reduce the overall competitiveness of the manufacturing sector. "If other infrastructural supports were adequate and the cost of capital in single digit, perhaps the industry could have absorbed the

He said the export-oriented industries will suffer more as they compete against other countries to procure orders.

"The garment sector is going through a massive restructuring phase and entrepreneurs are undertaking large investments to meet the international compliance standards. At this juncture, the garment sector should be exempted from further increase in direct expenditures," said the former president of Dhaka Chamber of Commerce and Industry.

With the European Union poised this week to extend the list of people subject to asset freezes, the Russian president individually met five European leaders including the British prime minister, David Cameron, and the German chancellor, Angela Merkel, where he refused to give ground.

Putin instead accused the Kiev government of a mistaken economic blockade against the cities in eastern Ukraine that have declared independence in votes organised in the past month. He said that action was short-sighted pointing out that Russia continued to pay the salaries and pensions of Chechenya throughout its battle for independence.

In an interview with German TV he also accused the west of switching off their brains by imposing sanctions that could backfire.

Putin said: "Do they want to bankrupt our banks? In that case they will bankrupt Ukraine. Have they thought about what they are doing at all or not? Or has politics blinded them? As we know eyes constitute a peripheral part of brain. Was something switched off in their brains?" The Russian leader also complained he had not been consulted by

However, British officials insisted behind Putin's bluster, that they detected a new flexibility about the Ukraine orientating towards the EU so long as this did not extend to Nato assets being placed on Ukrainian soil. "We are very clear with Russia that the continued destabilisation of

Ukraine is simply unacceptable. If Russia continues to destabilise Ukraine there will be further sanctions. President Putin can see he is at a crossroads," British Prime Minister Cameron said in his own press conference. Obama said Russia had failed, in spirit and letter, to adhere to the Minsk agreement signed in September, and that while the US was not

actively considering further sanctions on Russia, it would consider

increasing the pressure on Moscow if Russia's intransigence continued.

But Russia would remain isolated, Obama said. The crisis has been deepened by the creation of the declared Donetsk
