Tarique asked to appear in court on Dec 10

A Dhaka court yesterday summoned BNP Senior Vice-chairman Tarique Rahman to appear before it on December 10 in a case filed for calling Bangabandhu Sheikh Mujibur Rahman "Pakbandhu" (Friend of Pakistan).

Metropolitan Magistrate Md Rezaul Karim passed the order hours after Monir Khan, assistant secretary of Awami League's central subcommittee, lodged the lawsuit against the son of BNP Chairperson Khaleda

In his case statement, Monir alleged that Tarique called Sheikh Mujibur Rahman "Pakbandhu" at a discussion in London on September

"Sheikh Mujibur Rahman cannot be the Father of the Nation. He returned to the country with a Pakistani passport. Someone who accepts Pakistani passport even after Bangladesh's independence is a citizen of that country in the eyes of the law," Tarique told the programme at York Hall in East London.

Condemning the case filing, BNP acting secretary general Mirza Fakhrul Islam Alamgir said the lawsuit was "false and baseless" and demanded its immediate withdrawal, said a

Jan 5 Polls Fakhrul slates PM's comments on critics

BNP acting secretary general Mirza Fakhrul Islam Alamgir yesterday lambasted Prime Minister Sheikh Hasina for terming people who did not support the January 5 polls "childish".

"The whole world including the EU and the USA did not accept the January 5 polls. They still hold the same view. Around 90 percent people of the country have also rejected it. But according to her [Hasina] comment, everyone at home and abroad is childish," said Fakhrul at a discussion of the Jatiyatabadi Mohila Dal at Institution of Engineers, Bangladesh.

Hasina on Sunday in parliament said people who had rejected the January 5 polls were childish.

On HT Imam's reported statement on Chhatra League activists getting jobs, Fakhrul said the adviser to the premier had claimed that some media houses had distorted his statement.

"The adviser thought people were fools; they would not understand

the home ministry.

Monirul, who is spearheading investigation into militancy in Bangladesh, declined to disclose the number of suspects, saying they would first examine the list as militants usually take different names to evade arrest. The NIA is also not sure about the

identity of the suspects. "Some militants are absconding after being released on bail. We will verify the list with that of the absconding ones," he added.

Sources in the home ministry, however, said there are 25 to 30 names on the list.

The NIA last month released names of 12 Jama'atul Mujahideen Bangladesh (JMB) suspects involved in the blast and announced cash rewards for information leading to their arrest. Of them, four are believed to be Bangladeshi nationals and the rest from Assam and West Bengal.

Monirul said NIA officials shared with them the information regarding Burdwan blast and the activity of the JMB. "We will investigate based on the information [of the NIA] ... We told them that we will cooperate

in their investigation too." Bangladeshi investigators sought

information from NIA officials regarding the JMB fugitives who were snatched away in an ambush on a police van in Trishal last year. A four-member team headed by

Sharad Kumar, chief of the NIA, arrived in Dhaka yesterday to discuss the blast case, arrest of the culprits and share information about the JMB operatives in both the countries. The other members are NIA Inspector General Sanjeev Singh and deputy directors general Anurag Tankha and Sajid Farid Shapoo.

Asked whether there will be any joint drive to combat militancy, Monirul said the two sides will continue to share information and separately conduct counterterrorism operations.

Representatives of Detective Branch (DB) of police, Rapid Action Battalion (Rab) and other intelligence agencies were present at the three-hour long meeting.

Meanwhile, the home ministry yesterday formed a six-member committee to work on militancy and extend cooperation to the NIA in the investigation. Additional Home Secretary Kamal Uddin Ahmed heads the committee which will have representatives of intelligence agencies.

Upon arrival in Dhaka around noon, the NIA officials first sat with senior home officials and chief of police, Bangladesh Border Guard (BGB) and the intelligence agencies.

Patuakhali war crimes suspect faces 8 charges

The prosecution yesterday pressed eight charges against war crimes suspect Forkan Mallik of Patuakhali for his alleged involvement in crimes against humanity and genocide committed during the Liberation War in 1971.

Prosecutor Mukhlesur Rahman

Badal pressed the charges that include mass killing, murder, rape, arson and forced religious conversion allegedly committed by the alleged Razakar commander, who is now 63 and hails from Chailabunia village in Mirzaganj upazila of Patuakhali. After hearing, the International

Crimes Tribunal-2 fixed November 30 to decide about taking the charges into cognisance. The tribunal would hear arguments from both the prosecution and the defence to decide about indicting Forkan if the charges are taken into cognisance.

Earlier on June 25, the Detective Branch of police arrested Forkan at Rupatali Bus Stand in Barisal. He was later shown arrested in the war crimes case. An investigation agency of the international crimes tribunals completed investigation into the allegations against him on October 27.

Forkan, who was involved in antiliberation Muslim League in 1971, was

In December last year Jannati and Mostamsir launched Eco Sparks, a gaming zone and music cafe. It was Mostamsir's car she was driving that day.

The plaintiff in the murder case didn't say exactly how Mostamsir was "murdered". According to the post mortem report, he died in an accident and police say his seat belt was not fastened.

However, Jannati has been denied bail and taken on remand for 15 days in three phases.

With 15 persons named as witnesses, including a deputy secretary, the DG of ACC and the chief judicial magistrate of Dhaka, this is

now a high-profile case. "Mostamsir's family is influential. They are trying to be unjust to my daughter using their influences," alleged Jannati's mother Shakila Hossain, adding that they have been trying to go to the High Court for

Jannati's bail. Mostamsir's father Khan Mohammad Abdul Mannan is a former district court judge and now serving as the inspector general of registration (IGR).

"There is nothing to influence here. I filed the murder case as we thought there might be some loopholes in the police case. We want a proper investigation and will accept whatever comes out after the investigation," said Mostamsir's uncle Hannan

Hannan lodged the murder case with a Dhaka court on July 21. Accepting it, the court the next day ordered a CID investigation and merger of the murder case with the one injured. filed for reckless driving.

Talking to The Daily Star, Hannan said Mostamsir's family didn't support the friendship between Mostamsir and Jannati.

After descending the Mohakhali flyover, the car suddenly crashed against a police van parked on the street near Shaheenbagh. The frontleft side of the car badly hit the backright side of the police van, said Sub-Inspector Sardar Nizamul Haque, who

was inside the van at that time. "After patrolling Mohakhali area, we stopped near Shaheenbagh ramp of the flyover. It was around 1:00am. I was sitting next to the driver's seat," said the officer, who was then posted to Tejgaon Police Station.

"Suddenly, I heard a bang and the van then shook heavily and ran onto the footpath. My left hand was hurt," he said, adding that two Ansar members and a cop were also

"As I got down off the van, I saw a car and a woman inside it screaming for help," said Nizamul.

A police team from a nearby outpost came to the spot, and with their help, "we together rescued an unconscious man from the car and took him to the nearby hospital", said

Lalbagh Police Station. "As far as I can recall, he was alive

at the time we rescued him." Mostamsir was taken to Ayesha Around 11:30pm on July 10, Memorial Hospital where doctors declared him dead, according to

"The accused killed Mostamsir in a planned way amid rows over business and also to grab his property," he alleged.

Hannan also said that around 2:30am Mostamsir's driver Aziz informed him over the phone that Mostamsir died in an accident and his body was at Tejgaon Police Station.

Hannan along with other relatives then rushed to the police station and saw the body, read the case statement.

Shortly afterwards, Mostamsir's parents along with Law Secretary Abu Saleh Sk Mohammad Zahirul Haque, ACC Director General Kamrul Hossain Mollah, Islamic Foundation DG Shamim Mohammad Afzal and Mahbubar Rahman, then additional district judge of Narsingdi, arrived there. Police then showed them the

The approval was given in the regular meeting of the cabinet at the secretariat, with Prime Minister Sheikh Hasina in the chair.

Briefing reporters after the meeting, Cabinet Secretary M Musharraf Hossain Bhuiyan said the cabinet also gave the nod to the draft of an agreement for waiving visa requirements for visit of diplomats, their immediate family members and government officials of Bangladesh and Malaysia to each other's countries. Immediate family members will mean the spouses of the diplomats and their unmarried children below 21 years.

The cabinet, added Musharraf, rejected the proposal of the water resources ministry for making "Bangladesh Haor and Water Bodies Development Board" into a statutory body rather giving it the status of a department attached to the ministry.

The meeting approved the draft of the "Motor Vehicles Agreement for the Regulation and Cargo Vehicular Traffic amongst SAARC Member States" which will be placed in the ministerial meeting ahead of the ensuing Saarc

Cargo vehicles and regular and nonregular passenger transport would

come under regulation under the agreement which would enhance connectivity among the Saarc countries, said Hossain said adding that the draft proposed for multiple visa regime for the

operators of the vehicles.
