The prosecution yesterday completed closing arguments in the case against Jamaat-e-Islami leader Abdus Subhan and the defence started placing their arguments.

Prosecutor Zaed Al Malum yesterday took around 15 minutes to complete their legal arguments that started on Sunday.

Initiating their arguments, Subhan's counsel Mizanul Islam said the incidents narrated in the charges might have taken place in 1971, but his client was "not involved".

Subhan, a nayeb-e-ameer of Jamaat, faces nine charges including genocide committed in Pabna during the war. He, however, pleads not guilty before the court.

The three-member tribunal led by Justice Obaidul Hassan with members Justice Md Mozibur Rahman Miah and Justice Md Shahinur Islam adjourned the proceedings until today.

A war crimes case against fugitive Abdul Jabbar has entered the last stage as state-appointed defence counsel Mohammad Abul Hasan yesterday completed cross-examining last prosecution witness and investigation officer Helal Uddin.

The International Crimes Tribunal-1 has fixed November 25 for hearing closing arguments from the prosecu-

The defence yesterday suggested that first prosecution witness Shoebur Rahman Golder was a leader of Jatiya Party and testified against Jabbar, who was a party colleague, due to an intraparty conflict.

Helal said, "It's not true."

In reply to another question, the witness said it was not true that he had submitted a fabricated investigation report to ensure Jabbar's punishment.

The defence also suggested that the documentary evidence against Jabbar had been cooked up to harass his cli-

The witness denied the suggestion. Jabbar faces five charges for his alleged involvement in crimes against humanity.

Past Interpol public appeals have focused on themes like fugitives in the Americas, and led to over 600 arrests. Officers working on Operation Infra-Terra now hope for similar results. "Until recently, environmental

offences were not even considered a crime by many countries but as the years have passed, they have realised that environmental crime is a serious internal threat to our societies," said Andreas Andreou, a criminal intelligence officer with Interpol's environmental security unit. "It involves organised criminal networks which smuggle drugs, weapons and people. If a poacher need guns, for instance, here we have a crossover with arms trafficking.

Routes for trafficking ivory may also be used for trafficking weapons and the more profitable line may then be used to finance other ventures, Interpol say.

In the future, the agency intends to focus its activities geographically, with illegal logging and timber trade inquiries centred on the Americas, efforts to protect wildlife species particularly tigers - undertaken in Asia, pollution investigations that pinpoint Europe, and a crackdown on the poaching of elephants and rhinos in Africa.

Rhinos have already disappeared from several Asian and African countries and 94% of rhino poaching takes place in just two countries – Zimbabwe

and South Africa - where it has increased from an estimated 50 animals in 2007, to over 1,000 in 2013, due to the involvement of crime syndicates.

Between 20,000-25,000 elephants are killed every year in Africa, and forest elephant populations are thought to have declined by 62% between 2002-2011. A letter co-signed by 81 MEPs was

sent to the European commission last

week calling for urgent action to address the problem. "The unprecedented scale of illegal poaching is fuelling instability and driving many species to the brink of

extinction," the Liberal MEP Catherine Bearder said. "Unless we take action now, our grandchildren will only be able to see wild animals such as elephants, lions and rhinos in their history books." Persuading officials in some countries to address the problem remains

an uphill battle, and stricter law enforcement efforts and penalties may be needed internationally, Interpol sources say.

said in its annual report that it "expects to continue to outperform the global chocolate market".

But it also reiterated fears raised by Mars Inc of a global shortage of cocoa and the impact that could have on the individual consumer.

Fiona Dawson, the then-UK president of Mars chocolate, warned in 2012 that the global cocoa sector "may suffer a 1 million tonne shortage by 2020 because of the increasing economic and environmental pressures on cocoa farms", adding: "It's just not sustainable."

Last year, Kennedy's Confection magazine editor Angus Kennedy said the future of chocolate could be threatened altogether by that date - and added that the "chocolate bar of the future" would be made with so little cocoa it will be "nothing like the chocolate we know and love".

Barry Callebaut said cocoa prices rose in 2013/14 from around £1,600 per tonne to more than £2,000 per tonne - despite "strong" crops from major regions including Cote d'Ivoire and Ghana. This price rise, the company said, "has been fuelled by fears related to the Ebola outbreak in some West-African countries... el Nino forecasts... as well as financial speculation".

Despite the shortage warnings, the increase in demand for chocolate was almost seven times greater in Asia com pared to that of traditional European markets, the manufacturer said.

In South America, the market for chocolate expanded by a massive 7 percent. Brazil, once one of the world's great cocoa manufacturers, has in recent years become a net importer.

Efforts are being made to address the problems faced by the cocoa industry - in June, Barry Callebaut organised the second annual "Chocovision" conference to "foster collaboration" across manufacturing businesses.

But there are concerns that repeated warnings in previous years have simply not been listened to. In 2010, John Mason of the Ghanabased Nature Conservation Research Council, predicted that "in 20 years, chocolate will be like caviar". He said "It will become so rare and expensive that the average Joe just won't be able to afford it."
