Suicide car bomb kills five in Iraqi Kurdish capital

A suicide bomber driving a car packed with explosives blew himself up in the capital of Iraq's Kurdistan region yesterday, killing at least five people in the first big attack there in more than a year.

Mayor Nihad Latif Koja told Reuters the assailant had detonated himself as he tried to enter the governor's compound, which is protected by blast walls, in the center of Arbil.

Explosions are a regular occurrence in the federal capital Baghdad and other cities outside Kurdistan but the autonomous region has largely managed to insulate itself from the violence

convulsing the rest of the country. Islamic State militants who overran swathes of northern Iraq this summer have repeatedly threatened to launch attacks against the Kurds, who are fighting them along a front line stretching more than 1,000 km (600 miles).

Footage from the scene in Arbil after the mid-morning attack showed charred vehicles and blood smeared on the cobbles outside the governor's office. Windows on the opposite side of the street had been

shattered by the force of the blast. A witness interviewed live on Kurdistan TV said two policemen and two civilians had been killed in the explosion.

The United States launched air strikes in Iraq this August when IS militants advanced on Arbil, where many expatriates, including oil industry and aid workers, are

based. Since then, the region's peshmerga forces have regained ground from Islamic State, emerging as the West's most trusted and effective partner on the ground in

their war against the Sunni extrem-But the Kurdistan region's President Masoud Barzani on Wednesday said the peshmerga

needed heavier weapons from the international coalition to deliver a decisive blow to Islamic State. The last major attack in Arbil

was more than one year ago, when militants launched a coordinated suicide and car bomb attack on the headquarters of the security services. Another blast took place in August, but there were no casualties.

When NIA officials along with police went there, the shop owner told them that he threw the bottles containing picric acid in a nearby pond. Later, the bottles were fished out and the shop owner was detained for

yesterday. "She was five feet and 2.5 inches tall. How could a girl of her height hang herself with a scarf from a window grill of bathroom which is not higher than five feet?" he asked.

Mahjabin's neck and the left wrist indicated she was murdered. He said the doctors preparing the

autopsy report were reportedly under pressure.

"We did not contact the doctors. Who are putting pressure on them?' he questioned, seeking the prime minister's intervention in ensuring justice for her daughter.

A distorted postmortem report of Mahjabin might come out amid pressure from her in-laws, Nurul further alleged.

Mahjabin was the wife of Humayun Sultan, son of Khan Tipu Sultan, former lawmaker from Jessore-5. Humayun and Mahjabin got married in April last year.

Her father filed a murder case with Dhanmondi Police Station, accusing Tipu Sultan, his wife Jasmine Ara and Humayun on November 13. Police arrested Humayun, and he was put on a three-day remand.

Meanwhile, over 100 friends and colleagues of Mahjabin of Holy Family Red Crescent Medical College and Hospital formed a human chain in front of the Jatiya Press Club yesterday. They demanded transparency in preparing the postmortem report.

He later learnt that they all were brought to the vessel in groups from Cox's Bazar, much like the way he was. The traffickers would treat them ruth-

hope, Navy ship BNS Durjoy appeared on the horizon. After more than 12 hours' chase, the

UK judge says Pakistani man can sue over torture claim

A British judge on Wednesday gave the go-ahead for a Pakistani man to take Britain to court over his alleged unlawful detention and torture by UK and US forces in Iraq and Afghanistan, his lawyers said.

Yunus Rahmatullah was detained by British forces in 2004 in Iraq, where he said he was with a friend who was

on a pilgrimage.

He was transferred into US custody in Afghanistan and held for 10 years without charge before being released

Rahmatullah alleges that he was subjected to torture while in detention, including being beaten on the soles of his feet with rubber flex, being exposed to tear gas and being immersed upside down in water tanks.
