Seed crisis poses threat to onion farming in Pabna

Massive rotting wreaks havoc on the preserved vegetable

Onion cultivation faces seatback due to seed crisis in the country's largest onion producing district that saw early rotting of the preserved onion this year. "Last year I bought a kg of

onion seed for Tk 1200 but the price ranges from Tk 3000 to 3500 this year," said Abul Hossain, an onion farmer of Durgapur village in Sujanagar upazila under the district.

"I have prepared 14 bighas of land for onion cultivation but could not manage seeds for the purpose. I had preserved 400

maunds of onion including seeds to sell in December and January when the prices go up. But over a hundred maunds of the stored onion rotted and I sold the rest last month," he said.

In last year, 5.21 lakh tonnes of onion was produced from 41,714 hectares of land in Pabna district and the yield was 70 thousand tonnes more than that of the previous year, said sources of the Department of Agriculture Extension

"There is a target of onion cultivation on 42 thousand hectares of land in the district this year and we have given the requisition of 67

EBTEDAYEE TERMINAL EXAMS

19 candidates get question paper after 40 minutes

Nineteen of the 69 Ebtedayee examinees at Modhya Dharandee Primary School centre in Patuakhali Sadar upazila received the question of English First paper after 40 minutes of the scheduled time on the first day of the examinations yesterday.

But answer scripts of the 19 students were taken back along with the other students at the same time, without giving any 'extra time' as compensation, said teachers, students and guardians.

"There were 69 examinees at the centre but we found only 50 question papers that were given to the same number of examinees at the scheduled time 11:00am. As we informed the assistant upazila education officer (ATEO) of the matter, he brought more 19 question papers from the unfortunate, Md Ataur respectively, they said.

and then those were distributed among the rest examinees," said Abdur Rob, in charge of the examination centre.

Nazrul Islam, ATEO of Sadar upazila, said there were 19 questions found less in the centre and later on we solved the problem.

The authorities assured the guardians waiting outside the centre that the examinees who received the question paper later would get extra time but at the end of the schedule time they took back the answer scripts from all at a time, depriving the 19 examinees of 40 minutes of the stipulated time, alleged guardians.

"My son could not write answers to all the questions as he got much less time due to mistake of the authorities Uddin, a guardian.

nearby examination centre Rahman, district primary education officer of Patuakhali, said, "We will take step against the persons responsible after proper investigation."

Bhola Our Correspondent adds: A total of 3042 Primary School Certificate (PSC) and Ebtedayee examinees, out of 41,831 in 89 centres of the district, remained absent on the first day of the examinations yesterday.

The number of students enrolled for the PSC and Ebtedayee examinations this year were 34,672 and 7,159 respectively but 1995 PSC and 1047 Ebtedayee examinees did not attend, said sources of the District Primary Education Office.

Robbers kill one, loot house

One of the gang held with gun

A man was hacked to death by a gang of robbers at Probakorpara village in Chatmohar upazila of the

district early yesterday. The victim was identified as Md Mojibar Rahman, 40, son of Akher Ali Pramanik.

Officer-in-Charge Subrato Kumar Pal of Chatmohar Police Station quoted family members as saying that a gang of 10 robbers stormed into the house of Mojibar at around 2:00am. They confined the family members in a room and started looting valu-

ables. As Mojibar tried to resist the gang members, they hit him with sharp weapons, leaving him critically

injured. Hearing screams of Mujibar's family members, locals rushed to the spot, caught one of the gang members named Md Shukur Ali, 42, of Tantiband village in Sujanagar upazila of the district, while the rest man-

aged to flee. Locals beat up Shukur mercilessly. Being informed, police rushed to the village, arrested the robber and recovered Tk 20 thousand and gold ornaments from his possession.

Law enforcers also seized a shutter gun and two bullets from the spot. Arrested robber is undergoing treatment at Chatmohar Upazila Health Complex under police guard.

Mojibar was admitted to Pabna Medical College Hospital where he succumbed to his injuries at around 9:00am yesterday.

A case was filed with the police station, OC said, adding that they have launched a drive to arrest the rest of the gang members.

CRIMES AGAINST HUMANITY

Investigation against ex-Jamaat MP starts

A one member team of International Crimes Tribunal (ICT) investigated the crimes against humanity committed by Jamaat-eislamileader and former lawmaker of Gaibandha-1

constituency Abdul Aziz. Assistant Police Superintendent ZM Altafur Rahman started investigation against the former Jamaat lawmaker on November 20 and concluded on November 22.

He along with a cameraman went to different areas in Sundarganj upazila, talked to local people and collected evidence of war crimes committed by Aziz.

Mozammel Huq, officerin-charge of Sundarganj Police Station, said the ICT investigation team left Gaibandha yesterday.

Azizur Rahman Sarker, son

of late Alamuddin of Santiram village filed a case with Sundarganj Police Station on September 28, 2009 (case No 50/316), accusing former lawmaker Aziz and some others of killing his elder brother on November 10, 1971.

In the case statement, he alleged that the accused picked up his brother Bayes Uddin from their house at Santiram village on the day. They took him to Sundarganj army camp and

tortured him to death. Another murder case was filed against Aziz with the police station on September 28, 2009 (case No 51/317) by Anisur Rahman of Dharmapur village in the upazila.

In the case, the plaintiff stated that Aziz and his men killed his father Akbar Ali in November 1971. Both the cases were later transferred to ICT for trial.

6 hurt as rival AL men clash


