Main Uddin Khandaker, a freedom fighter and a member of Bangladesh Public Service Commission, died from heart ailments at the capital's United Hospital last night, aged 60.

He left behind his two daughters and a son, according to the BPCS website. Khandaker's namaz-e-janaza will be held at the city's Circuit House Jame Mosque at 9:00am today, Ekram Ahmed, chairman of BPCS, told The Daily Star. He will be buried at his village home in Narsingdi, he added.

KHALEDA'S APPEAL IN GRAFT CASE SC now decides on Nov 30

The Supreme Court yesterday fixed November 30 for passing an order on an appeal filed by BNP Chairperson Khaleda Zia challenging the High Court verdict that had upheld the charge framing against her in Zia Charitable Trust corruption case.

A five-member bench led by Chief Justice Md Muzammel Hossain, which scheduled to pass an order on the appeal yesterday, deferred the date.

Talking to The Daily Star, Khurshid Alam Khan, a lawyer of the Anti-Corruption Commission, said the court may examine Zia Charitable Trust's deed documents, which were submitted to the court on Monday, before passing the order.

A Dhaka court on March 19 framed charges against Khaleda and three others in the case.

The HC on April 23 upheld the indictment order against Khaleda by rejecting her petition. Khaleda on July 7 filed the leave to appeal petition with the SC against the HC order.

The ACC filed the case in 2011 accusing four people, including Khaleda, on the charge of abusing power in setting up the charitable trust.

Legal notice served to declare Latif's parliament seat vacant

A Supreme Court lawyer yesterday sent a legal notice to the Speaker of parliament and chief election commissioner asking to declare Abdul Latif Siddique's Jatiya Sangsad seat vacant in 24 hours.

Supreme Court lawyer Eunus Ali Aknod in the notice said he would file a writ petition with the HC, if Latif's seat is not declared vacant.

Samaritan shot by muggers

A car driver was shot and injured while trying to save a man from muggers in the capital's Kalabagan last night.

Mohammad Habib, 50, with a bullet wound to his left leg, was admitted to Dhaka Medical College Hospital.

The injured told reporters at DMCH that he along with a few other people chased three muggers when they were about to rob a pedestrian near Madina Tower on Central Road around 8:00pm. The three fled on a motorbike, firing several shots, and one of them hit his leg, he said.

Mohammad Iqbal, officer-in-charge of Kalabagan Police Station, confirmed the incident.

2 more BCL men held over Sust clash

Mizanul said.

"This is not only an improper investigation but also a dictated one," the defence lawyer said, adding that the prosecution itself "contradicted" its own evidence.

He said the alleged mass killing was committed in 16 villages but the investigator visited only seven and produced witnesses from only four villages of the seven.

The investigator did not produce many "important witnesses", and he did not explain why, resulting in a flawed investigation, said Mizanul Islam.

The three-member tribunal led by Justice Obaidul Hassan adjourned the case proceeding until today.

Subhan faces nine charges of crimes including genocide.

JABBAR'S CASE

The prosecution yesterday claimed that they had proved the involvement of fugitive war crimes accused Abdul Jabbar in the killing of three freedom fighters Motaleb Sharif, Razzak Biswas, and Sharda Kanto, and looting of 360 houses at Phuljhuri village of Pirojpur in 1971.

Placing arguments on two out of five charges, Prosecutor Zahid Imam told the tribunal-1 that the defence could not discredit the testimonies, through which Jabbar's involvement was proved.

Chief Prosecutor Ghulam Arieff Tipoo gave an opening speech before Zahid began arguments.

He said the prosecution produced 24 witnesses including the investigator in 39 working days and submitted supporting documents to prove charges against the former Jatiya Party lawmaker.

During the arguments, the tribunal asked prosecutor how Jabbar being a civilian could give order to a military force--the Pakistani army.

The question came when the prosecutor said Jabbar ordered the Pakistani army to shoot Sharda Kanto while the latter was fleeing for life after Razakars and the army raided his Phuljhuri village on May 17, 1971.

Zahid said he would explain it later. The case proceeding was adjourned until today.

The rule and order came after hearing the petition filed on November 23 by

Supreme Court lawyer ZI Khan Panna challenging the legality of Mosharraf's ministership.

The petition says Article 147 of the constitution clearly prohibits a minister and a state minister from holding any office, post or position of profit or emolument.

Mosharraf, however, resigned from the post of chairman of Peninsula Chittagong in the first week of this month.

Zakir Hossain said half of the Tk 2 crore fund of the "Ship breaking yard" project was already released, but the work was yet to start.

He said TIB itself unearthed stories of malpractices in the construction of BCCIF-funded cyclone resilient houses without walls and sanitation facilities. However, later BCCIF gave additional funds to complete the half-finished building, he added.

In his paper, "Climate Finance: Global Perspective and Expected Role of Bangladesh", Mizan R Khan, a professor at North South University, said Bangladesh could show that adaptation and development could go hand in hand. Iftekharuzzaman, executive director of TIB, was present on the occasion.

The Brahmaputra is one of the world's largest river systems, and its 3,000km channel flows through China, India and Bangladesh after originating in the Tibetan plateau.

"We want to know about the government's stance on this issue and what research it has done on the dam's impacts," Badal said. Azad supported Badal.

The first unit of the \$1.6 billion Zangmu Hydropower Station, which has a capacity of producing 5, 10,000MW, started operation Sunday, said China's official news agency Xinhua.
