## Hearing on charge framing against Latif Dec 7

A Dhaka court yesterday fixed December 7 for starting hearing on charge framing against sacked minister Abdul Latif Siddique in a case filed for hurting religious sentiment of Muslims.

The court also directed the prison authorities to produce the former post and telecommunications minister before it on that day.

Latif faces 22 cases in 18 districts for hurting religious sentiments. Arrest warrants were issued for him in four cases.

## Two suspects sent to jail

WAR CRIMES IN JESSORE, KISHOREGANJ

International Crimes Tribunal-1 yesterday sent two suspects to jail centring two cases filed over war crimes committed in Jessore and Kishoreganj during the 1971 Liberation War.

Sakhawat Hossain, arrested by police from Dhaka's Uttar Khan on Saturday evening, is a former Jamaat-e-Islami and BNP lawmaker from Jessore-6 and Shamsuddin Ahmed arrested on Thursday, a Kishoreganj court lawyer.

Following Prosecutor Sultan Mahmud Simon's plea, the tribunal fixed December 30, granting one more month, for the progress report submission on the probe against Sakhawat. With Sakhawat stating of his several ailments, the

He joined the Razakar Bahini, an auxiliary force of the Pakistani occupation army, during the Liberation War and was the in-charge of Hisladanga Razakar camp of Keshabpur, they alleged.

# Wage protection, speedy dispute settlement decided

Kuwaiti minister points out missing 'kafala' (sponsorship) issue

A wage protection programme, speedier labour dispute settlement, skill development and pre-departure orientation were among the measures Gulf Cooperation Council (GCC) decided to undertake to improve the work and living conditions of around 15 million foreign workers, including five million Bangladeshis, in its member states.

talks between ministers of 12 Asian labour-sending countries and GCC, the wage protection programme obliges GCC states to use banks in ensuring workers' payments and easy monitoring, reported Gulf-based newspapers.

However, the much criticised "kafala" (sponsorship) system, making it mandatory for workers to get their sponsor's consent when changing jobs, was not raised at the conference, said Kuwaiti Minister of Social Affairs and Labour Hind Al Subaih.

The GCC states -- Bahrain, Kuwait, Oman, Qatar, Saudi Arabia and the United Arab Emirates -- over the years were repeatedly and strongly criticised by international rights groups over the alleged maltreatment of foreign work-

ers, particularly domestic helps. Just last week, 90 international

Fakhrul was a lawyer for Salauddin Quader Chowdhury during the latter's war crimes trial.

Judge KM Shamsul Alam of the Cyber Tribunal in Dhaka passed the order yesterday after Fakhrul's lawyer submitted the petition.

The court also fixed December 11 for next hearing of the case.
