Govt orders closure of unlicensed hospital

The government yesterday ordered closure of Mohona Hospital on the capital's Green Road for running operations without a licence.

The order came a day after senior journalist Zaglul Ahmed Chowdhury underwent treatment there for accident injuries. He later died of his wounds at another nearby hospital on Saturday night.

A pall of gloom descended in and around the faculty as an ambulance carrying Qayyum's body reached there around 11:00am from the mortuary of the Square Hospitals. Overcome with grief, his colleagues and hundreds of his students paid their tributes to the artist.

The eminent artist suffered a massive cardiac arrest and breathed his last around 9:00pm in the capital's Army Stadium on Sunday night. The 82-year-old painter collapsed before uttering his last words during his speech at the Bengal Classical Music Festival.

He was laid to eternal rest at Azimpur graveyard after the Asr prayers.

Later his body was taken to the Central Shaheed Minar around 11:45am where his family members, friends, ministers, leaders of sociopolitical organisations, cultural activists and hundreds of his wellwishers gathered in silence, standing in front of the coffin, their faces etched with grief, as they paid their final tributes to the painter.

Different socio-cultural organisations placed wreaths and stood in silence to pray for his departed soul as his body lay in state there till 1:00pm.

Floral wreaths were also placed on behalf of President Abdul Hamid and Prime Minister Sheikh Hasina.

Qayyum's son Moinul Islam Zaber said bringing the motif of Bengali folk art on to the canvas was his lifelong goal.

"His every artistic endeavour was driven by this dream. Contemporary artists should continue to pursue this goal," he said.

graduated in 1954 from the Government Institute of Arts, now Faculty of Fine Arts. Mentored by the master painter Zainul Abedin, Qayyum pursued his passion for painting during the most exciting stages of the art movement in the '50s.

Qayyum won innumerable awards including the Imperial Court Prize, the Shilpakala Academy Award, the Leipzig Book Fair Prize for Book Illustration, the Ekushey Padak, the 6th Bangabandhu Award, the Sultan Padak and Swadhinata

ing system, with improvements shown in the success of the response to more recent cyclones, it says. However, most infrastructures don't follow building code while the road infrastructure is vulnerable

to disasters such as flood and cyclone. The report also says women representation in different institutions is very poor in Bangladesh. For example, women make up just

3.9 percent of police force. Women are disadvantaged by a lack of legal awareness or access to "institutional recourse" and they presently don't have inheritance

rights to properties. Moreover, socio-cultural norms restrict a large proportion of women to domestic responsibilities and limited access to education and health.

Bangladesh has suffered extensive human and financial losses in the past 20 years due to natural and man-made disasters that claimed around 15,719 lives and caused a loss of around \$13 billion, it said. The report was prepared between

March and June this year by following a methodology that included review of documents and interview of persons concerned. In the report, Japan was taken as

the benchmark since the country succeeded in achieving significant progress in building women's capacity in disaster resilience. At yesterday's press conference,

ActionAid Bangladesh Country Director Farah Kabir said the government has per capita allocation of \$5.3 for disaster relief. More government investments must be ensured to tackle the disaster risk management.

Necessary steps should be taken to ensure women empowerment and enhance their capacity in disaster resilience and gender-sensitive policy planning. It would help them take leadership to address the challenges, she said.

Govt tightens NGO rules

2014 that seeks to empower the NGO bureau under the Prime Minister's Office to inspect, monitor and assess the NGO activities and cancel registrations for violation of the law.

Briefing reporters after the meeting, Cabinet Secretary M Musharraf Hossain Bhuiyan said the proposed law envisages regulating activities of NGOs receiving foreign contributions. It will also ensure transparency, accountability and appropriate use of foreign funds, he said.

"Under the proposed law, no NGO will be able to undertake any project and implement it with foreign donations without the approval of the NGO Affairs Bureau," said the secretary.

As per the new law, in the application for registration, an organisation must clearly mention the sources of the funds and areas of spending. The registration will be given for ten years, but the government can cancel the registration anytime in case of any violation of the law.

An NGO can appoint a foreign consultant or expert upon taking security clearance from the bureau and the home ministry, the law said.

As per the law, the NGOs will have to keep their foreign contributions in a mother account of a designated bank, publish annual reports after audit of the accounts and submit those to the Director General of the NGO Affairs Bureau.

Any violation of the law would be considered as an offence and punishment will be applicable depending on the nature of the offence. Warning, cancellation of the registration and penalty would be the punishment for any administrative irregulari-

However, any offence of criminal nature like terror financing, women or child trafficking, drug smuggling will be dealt under the existing criminal law, the draft says.

"We have yet to see the final draft [of the law]. So we can't say anything specific right now," Sultana Kamal said, adding they would come up with the formal statements upon

reading the final draft. After the cabinet accepted the draft law in principle several months ago, Iftekharuzzaman said the law minister assured them of addressing the concerns.

Earlier, 15 leading NGOs including TIB and ASK said empowering the NGO Bureau to close down an NGO or stop all its voluntary activities is in conflict with the existing laws

of the land. They also termed negative the proposed restriction on receipt of foreign grants by individuals from a number of professions and organisations, and said such a provision is irrelevant.

The NGOs said it is appropriate and necessary to give the NGO Bureau the responsibility for inspection and audit. But it will be inappropriate to give it the task of project evaluation.

They felt that the word "evaluation" should be dropped from articles 10(1) and 10(3) of the draft law.

Contacted, Law Minister Anisul Huq said the NGOs discussed their concerns with him and Prime Minister's International Affairs adviser Gowher Rizvi. "I also conveyed their concerns to him [Rizvi] and the NGO Affairs Bureau. Those should have been addressed, I hope," he told The Daily Star.

Rizvi could not be contacted as his cellphone was found switched off.
