Reducing marriageable age of females new way of oppressing girls

Say women's rights activists STAFF CORRESPONDENT


A new way of oppressing girls is being introduced in the country with the government pushing to reduce marriageable age of females from 18 to 16, said women's rights activists at a human chain yesterday. They said if the move is

successful, females would be at a risk of suffering damage to their reproductive health and mental health and be deprived of their right to take part in political and economical activities as a citizen of the country.

Social Resistance Movement, a platform of 63 women's rights organisations, arranged the event in front of Jatiya Press Club in the capital demanding the minimum marriageable age of girls be kept 18 in the Child Marriage Restraint Act-2014.

Coast Guard arrests boat owner

Five others of gang being hunted

Bangladesh Coast Guard (East Zone) yesterday stated to be looking for five human traffickers and to have arrested the owner of the boat being used in an attempt to take 36 men to Malaysia over the Bay of Bengal, saying he is a member of the gang.

The 36 were taken into police custody while five boatmen were detained after the coast guard intercepted a small engine-run boat near Chittagong Boat Club area in the Karnaphuli river on Monday night.

Arrested in his Kotwali house in Chittagong yesterday centring information given by the boatmen and the 36, Kabir Hossain, 60, refuted the allegations saying

he had just rented the boat to one Yousuf

Soudagar, who he says has a shop in Sadarghat.

Kabir was coordinating with the five during the trafficking attempt, stated coast guard officials at a press conference at their Karnaphuli headquarters.

The 36, arriving from around the country, were first kept in a Madarbari hotel and then taken on the boat in an attempt to be shifted to a mother vessel, they added.

One of the 36, Md Shahinur, 30, a farmer from Jessore, told The Daily Star that his neighbour Alam, now in Malaysia, arranged the journey offering a job and he was to pay Tk 2.4 lakh on reaching there.

NURUL ISLAM'S DEATH IN 2008 HOUSE FIRE

Law enforcers, family still at loggerheads

Demand for reinvestigation, quizzing of political rivals falling on deaf ears

Over the last six years, the investigation into the fire that killed Gonotantri Party president Nurul Islam and his son had changed the hands of two law enforcement agencies

but it remains virtually inconclusive with the law enforcers calling it an accident and the family claiming it to be an arson attack and demanding further inquiry and interrogation of Nurul's political rivals.

The Criminal Investigation Department (CID) was the first to launch a probe after the house fire

in 2008, and submitted the final report early last year following five years of work. Then the Rapid Action Battalion (Rab) started further inquiry last June and submitted its report last December.

Both the agencies drew the same conclu-

sion that the fire was an accident because they did not find any incendiary material in the ashes and water collected from the scene. The Detective Branch of police now is

carrying out further probe after Nurul's family objected to the findings of the two agencies.

The family alleged that both

CID and Rab counted out the Bangladesh Council of Scientific and Industrial Research (BCSIR)'s chemical report that found existence of Osmic compound and arsenic in the collected ashes and Heated Osmic compounds and

arsenic release toxic fumes that directly attack the respiratory system and cause quick death, according to experts. Osmium is not used in home appliances while arsenic is a component of pesticides and rodenticides, they said. SEE PAGE 5 COL 6
