Erosion Takes Serious Turn

River Paira out to devour Lebukhali ferry ghat

Erosion by the River Paira has taken a serious turn, threatening Lebukhali ferry ghat (terminal) on Patuakhali-Barisal highway.

Over, 160 pieces of bamboo-made cages each filled with 25 bricks dumped at the erosion points to save the terminal recently were washed away by the river in the last three weeks, said WDB deputy assistant engineer Abu Bakar Bhuiyan.

Earlier, during the monsoon, about 300 metres of flood control dam on both sides of the ferry ghat went into the river.

Of the total, 100 metres on the east side and 200 metres on the west of the ghat were devoured, said Water Development Board (WDB) official.

"As the bamboo cages were not properly made, they were broken by heavy tidal surge eventually. The bricks came out from the cages and rolled into the river," said Shahjahan Pada, a resident of the area.

Due to the situation, the ghat, deemed as the lone entrance point of the district

and also the only way to Kuakata, is now under erosion threat, he said.

Local people blamed the men of contractors for the worsened situation.

adulteration and contamination of food, which is a major public health concern.

Use of formalin, fruit ripening agents, cowfattening medicines, excessive pesticides in food production and contamination of livestock feed have been rampant, much to the worries of consumers.

The authorities concerned had been negligent in coordinating with various government ministries and

departments responsible for checking the irregularities.

The Jatiya Sangshad, against such a grim backdrop, last year enacted Food Safety Act 2013 with a provision of forming Bangladesh Food Safety Authority. It will be tasked with setting food safety standards, enforcing related laws and ensuring coordination between the line minis-

tries and departments. Mike Robson, FAO representative in Bangladesh, lauded the government's approach to implement the food safety act. He stressed the need for capacity building and strengthening the institu-

tions concerning food safety. Shashi Sareen of FAO said they would help the government formulate the regulations on the basis of

the Food Safety Act 2013. Ramona El Hamzaoui of the United States Agency for International Development (USAID) also spoke, with Food Secretary Mushfeka Ikfat in the chair.

Police yet to submit charge sheet

Around three months into the incident, police are yet to submit charge sheet in the case filed for abducting and killing of a fiveyear-old boy in Sunderganj upazila of the districts.

Earlier, police arrested nine people, including Harun Mia, Mostafizur Rahman, Sumon Mia and Jewel Mia, in this connection. On December 1, a court

here granted a two-day remand for the four after police had produced them before the court, seeking a two-day remand.

Jinnat Ali, investigation officer (IO) of the case, said during remand the accused provided some vital information about the abduction and killing. After completion of their remand they were sent to jail on Wednesday night, the IO added.

Criminals abducted Shuvo Mia, son of Ashek Ali Master, a resident of Balapara area in the upazila from in front of his house on September 8, and demanded Eidgha field the same night.



Tk 15 lakh from Ashek Ali as ransom for his son's release on December 10.

pay the money and asked

Bridges lie useless for want of approach roads

Two concrete bridges built in Baufal upazila have been lying useless for a long time for want of approach roads on both sides of the bridges.

A 150-metre-long and 5.85-metre-wide RCC girder bridge on Nurainpur canal connecting Nurainpur and Keshobpur unions was built in 2008. On the other hand, a 120-

metre-long and 7.2-metrewide bridge on Kalishuri canal on Baufal-Dhulia road in the upazila was constructed last year, said sources at Local Government Engineering Department (LGED) office sides of the bridges.

'Missing' trader found killed


