12 sued for robbery at jewellers

Two cases have been filed in connection with Saturday's robbery at two jewellery shops in the port city that also left a person dead.

Rapan Kanti Dhar, owner of one of the shops, Gini Gold Jewellers, filed a case with Kotwali Police Station in the early hours of yesterday against 12

people, among whom 10 were named. The other case, in which two people were accused, was filed by police with Pahartali station.

The alleged prime suspect Imtiaz Uddin alias Babul, who was arrested in a raid near Zahur Ahmed

Chowdhury Stadium area hours after the robbery, was accused in both the cases, said Assistant Commissioner (Kotwali Zone) Shah Mohammad Abdur Rauf.

Around 9:00pm Saturday, a gang of robbers stormed Gini Gold Jewellers and Aparupa Jewellers in a market in front of Bangladesh Bank, cleaned out the showcases, and fled exploding bombs.

The explosion killed Md Syed, a 45-year-old street hawker.

Later that day, police found the microbus, used in the robbery, abandoned in Madarbari area, said AKM Mohiuddin Selim, officer-in-charge of Kotwali Police Station.

Rapan Kanti in his case claimed the robbers looted gold ornaments worth Tk 4.40 lakh from his shop alone.

Two other robbers, injured in the explosion, were being treated at Chittagong Medical College Hospital and would be arrested later, the OC

"Police are trying to arrest the other accused," he added.

"We saw from a distance cows being slaughtered at the house of Sonaton Das and around 200-250 Hindus being forced to wear tupis (prayer caps) and eat beef (prohibited in Hinduism)," he added, saying Akram was present there.

When they were forced to offer prayers, someone set two haystacks on fire, prompting the people to begin running to and fro, he said.

On Sirajul's instruction, Razakars, including Akram and Latif, took the detainees at the bank of a canal west of Doiboggohati Bazar, he added.

"Siraj Master blew a whistle three times and all the Razakars opened fire at the detainees," the witness said adding that the shots sounded like "popping corn" and he dived into the canal and took shelter in a paddy field.

Around 42 people were killed and many injured. The next day, the Razakars forced villagers to carry the

bodies and bury it in a large hole in Ramchandrapur village, said Nimai. He said a complaint he filed with

FROM PAGE 16 programmed to swim on its own. The unmanned underwater vehicle is able to make tight turns and move through the water quietly, making it ideal for surveillance

and reconnaissance missions. The Navy hopes it could be used to inspect the hull of a ship, check waters for threats such as mines or protrusions, deliver payloads including sonar and guidance packages, and access otherwise

Over the past several weeks, Boston Engineering's tuna-sized device, also known as Ghost Swimmer, has been gathering data on tides, varied currents, wakes, and weather conditions for the

development of future tasks.

"GhostSwimmer will allow the Navy to have success during more types of missions while keeping divers and Sailors safe," said Michael Rufo, director of Boston Engineering's Advanced Systems Group.

The GhostSwimmer was developed to resemble the shape and mimic the swimming style of a large fish.

At a length of approximately 5 feet and a weight of nearly 100 pounds, the GhostSwimmer vehicle can operate in water depths ranging from 10 inches to 300 feet.

"It swims just like a fish does by oscillating its tail fin back and forth," said Rufo.

Its bio-mimicry provides additional security during low visibility intelligence, surveillance and reconnaissance (ISR) missions and friendly hull inspections, while quieter than propeller driven craft of the same size, according to Navy Warfare Development Command (NWDC).

The robot is capable of operating autonomously for extended periods of time due to its longlasting battery, but it can also be controlled via laptop with a 500foot tether.

"We've got what we wanted," said Indian Environment Minister Prakash Javedekar, who said the text preserved a notion enshrined in a 1992 climate convention that the rich have to lead the way in making cuts in greenhouse gas emissions.

It also satisfied rich nations led by the United States who say it is time for fast-growing emerging economies to rein in fast-rising emissions. China is now the biggest greenhouse gas emitter ahead of the United States, the EU and India.

US Special Climate Change Envoy Todd Stern said that a joint US-China deal last month to curb emissions had helped show new ways to bridge a standoff between rich and poor. "The announcement of a few weeks ago came in handy here," he said. "This is a good document to pave

the way to Paris," EU Climate Action and Energy Commissioner Miguel Arias Canete told Reuters at the end of the talks about limiting more floods, desertification, heat waves and rising sea levels.

Some environmental groups, however, said the deal, reached at a tent city on a military base in the

Peruvian capital, was far too weak. "We went from weak to weaker to weakest," Samantha Smith of the successive drafts at the Lima talks. The idea of a UN deal with obliga-

tions for all nations marks a shift from the 1997 Kyoto Protocol which obliges only the rich to cut emissions. Christiana Figueres, the UN's

climate chief, said Lima found a new ways to define the obligations of rich and poor. "That is a very important breakthrough," she said. "What we are seeing is a new form

of international cooperation on climate change where all countries participate with a new set of rules," said Jennifer Morgan of the World Resources Institute think-tank. The UN Climate Change

Secretariat says that the combined pledges by all nations likely in Paris will be too weak to achieve a goal of limiting warming to an agreed goal of 2 degrees Celsius (3.6 Fahrenheit) above pre-industrial times.

Under the Lima deal, national pledges will be added up in a report by Nov 1, 2015, to assess their aggregate effect in slowing rising tempera-

If the bill to operationalise the agreement is not considered and passed in the ongoing session, then it has to wait till the long budget session expected to begin sometime late February next year.

The bill needs to be passed by twothirds majority of the members in both Houses of Indian parliament — Rajya Sabha and Lok Sabha.

Since a consensus has emerged among all the major political parties concerned with the bill, including ruling Bharatiya Janata Party, main opposition Congress and Trinamool Congress, the passage should not be a problem.

The consensus is reflected in the "unanimous" report of the parliament standing committee submitted to parliament on December 1 which recommended the passage of the constitution

amendment bill. The committee, headed by Congress lawmaker Shashi Tharoor, has members from BJP, Congress and Trinamool Congress, Communist Party of India (Marxist) and other parties.

However, right now it appears that during the ongoing winter session, the priority of Prime Minister Narendra Modi's government is to focus on passage of bills relating to Indian domestic

economic reforms. The bills may include Insurance Bill that seeks to enhance foreign direct investment limit in the capital-starved insurance sector and Companies Bill which aims at enhancing ease of doing

business. The official statement said that the bills proposed by the government for consideration and passing in Lok Sabha during the remainder of the session also include Regional Rural Banks (Amendment) Bill, 2014 and Anti-Hijacking

(Amendment) Bill. The bill relating to the implementation of LBA was placed in Rajya Sabha in 2013 by the then Congress-led UPA government, drawing strong opposition from BJP which was then in the

opposition. However, BJP has taken a U-turn with Prime Minister Narendra Modi himself declaring more than a week ago that the bill was in India's long-term security interest.

press release issued by Bangladesh Road Transport Authority (BRTA) yesterday, mentioned 5:00pm of December 22 as the deadline for sending information. Zaglul fell on a road near

Sonargaon intersection at Karwan Bazar on November 29 while trying to get off the bus. But the vehicle recklessly pulled away, leaving him critically injured. The renowned journalist later died at a private hospital.

Beximco's proposal considering its contribution to the country's economy and employment generation, the bank's Managing Director Abdus Salam told The Daily Star.

Salam, however, said it would come into effect only upon the central bank's consent.

As per the rescheduling proposal, the bank would deduct 5 percent from each of Group's export proceeds which would later be adjusted in instalments, said a Janata Bank official.

The interest rate on the loans is 11 percent, much lower than the market rate of 13-14 percent.

But for the bank to reschedule the loans till September 30, 2025, the Group has to mortgage property worth more than Tk 1,000 crore in addition to its present collateral of Tk 113 crore, said the source.

The rescheduling time would include a grace period of two years, meaning the Group wouldn't pay any instalment till September 30, 2016.

However, the conglomerate would forfeit the rescheduling facility if it fails to pay any instalment.

Last month, Sonali Bank rescheduled Beximco Ltd's loan for 12 years till 2026 with an interest rate of 10 percent. Both Janata and Sonali boards

approved the loan proposals without taking any down payments from Beximco. Wishing anonymity, a Janata Bank official said the Group's loans would be restructured, not resched-

uled, implying that the provision of down payment is not mandatory in this case. A number of bank officials and businesspersons said if Beximco is

given such a benefit, other business

groups may also demand similar

Another Janata Bank official said the proposal was approved because they received it through the central bank. If any other business group wants to seek similar facility it must come through the BB.

However, several bank officials said the conglomerate lobbied high-ups of the BB and several banks to get the facility.

Abdus Salam said Beximco, one of the country's largest business groups, owes more than Tk 2,000 crore in loans to Janata Bank. The bank considered the

rescheduling proposal to make it possible for the conglomerate to repay its loans on time, he said.

In his letter to the central bank, Salman showed two reasons behind the Group's liquidity crisis -- politically motivated credit restrictions on the Group between 2001 and 2008, and repayment of Tk 800 crore in bank loans in the last three

Beximco Ltd, listed on the stockmarket, operates in textiles, real estate, hospitality, marine food, commodities trading, ICT,

ceramics and aviation. Khondkar Ibrahim Khaled, former deputy governor of the central bank, told this correspondent that the BB would have to evaluate the rescheduling proposal cautiously

before giving its consent. On previous occasions, Beximco took loans from different banks resorting to irregularities, and later had those rescheduled using politi-

cal clout, Khaled said. According to the latest rescheduling proposal, the Group would get several facilities, including low

interest rate, he said. In the past, the Group availed itself of such facilities, and Bangladesh Bank would have to consider very cautiously whether it would give the conglomerate the same benefits over and over, said Khaled.
