

Female teacher brings rape charges against student

A female teacher of an educational institute has sued her student on charge of rape in the capital. According to the case statement, the 32-year-old teacher alleged that the 24-year-old student developed physical relations with her with a promise to marry her a few months ago. As the student refused to marry her on Wednesday, she filed the case with Mirpur Police Station on Saturday night. Police yesterday took the teacher to Dhaka Medical College where a forensic test on her has been done. The result of the test is yet to be known. The accused went into hiding after filing of the case.

Girl hospitalised 'being raped, fed substance' in capital

A 15-year-old girl was admitted to Dhaka Medical College Hospital in the capital in critical condition yesterday after she was allegedly raped and fed something. Talking to The Daily Star, her sister said the victim worked at a factory in Turag manufacturing tiles. She claimed that a colleague raped her with false promises of marriage. He then offered her a substance on Saturday, saying it was a contraceptive, she added. Locals handed over the accused to Turag police. Turag Police Station Officer-in-Charge Mahbub-Khuda said they were investigating the matter.

EXAM FEE HIKE AT CARMICHAEL COLLEGE, RANGPUR

Acquiescent students attack protesters

Victims allege that BCL, JCD, Chhatra Samaj jointly involved in it, but principal, cops and accused deny

Equipped with iron rods, a group of students attacked another group protesting examination fee hike at Carmichael College in Rangpur yesterday, injuring at least 15. The injured alleged that Bangladesh Chhatra League, Jatiyatabadi Chhatra Dal, and Jatiya Chhatra Samaj jointly launched the attack around 2:00pm while they were besieging Agrani Bank, the college branch. Of the injured, three are Imran Sarkar, the college unit organising secretary of Samajtantrik Chhatra Front; and students Mizanur Rahman Mizan and Anwarul Islam. In a critical

condition, Imran was admitted to Rangpur Medical College Hospital. The principal did not intervene in the situation, although she was present during the attack, alleged the victims. However, Prof Binte Hussein Nasrin Banu, principal of the college, denied the allegation. Md Abdul Qader Jilani, officer-in-charge of Rangpur Kotwali Police Station, said the attackers fled away when the law enforcers rushed to the spot. The college BCL President Rafiqur Rahman Rafi said no activist of the organisation was involved in it. Denying the allegation of attack, Rabiul Islam, general secretary of the

recently dissolved committee of the JCD unit, said a faction of the demonstrating students attacked other group. Echoing him, Chhatra Samaj President Sumon Islam said the attack was launched when a group tried to deposit the increased exam fee with the bank. However, Abu Raihan Bokshi, the unit president of Samajtantrik Chhatra Front, who is playing a leading role in the movement, said there was no faction among the demonstrating students. Students of honour's second year of 17 departments of the college are conducting their movement as their exam fee has been increased by Tk 1,000 on an average this year.

SALMAN SHAH'S DEATH

Mother rejects judicial probe report

The mother of late popular silver screen actor Shahriar Chowdhury Imon known as Salman Shah yesterday rejected the judicial probe report over the death of her son in 1996. Salman's mother Nilufar Chowdhury also filed a petition with the Chief Metropolitan Magistrate's Court of Dhaka seeking more time to submit a 'no-confidence' (naraji) petition against the report. After the hearing, Metropolitan Magistrate Amit Kumar Dey fixed January 21, 2015 for submission of the naraji petition. Salman Shah allegedly committed suicide at his Eskaton residence on September 6, 1996. His father Kamaruddin Chowdhury filled an unnatural death case with Ramna Police Station. Later, he applied to turn it into a murder case alleging that his son was murdered. Following his application Metropolitan Magistrate Imdadul Haque conducted the judicial probe and recorded statements of witnesses including Salman's parents. On July 9 this year, the court submitted the probe report where the magistrate said he found no evidence of the actor being killed and opined that Salman Shah committed suicide.

and uncertainty. Men of Jessore and Gaibandha told how restaurateurs were unwilling to allow them access as the locals avoided eateries which served Dalits. Srimongol's tea plantation workers described how land they have been using for over 100 years were being grabbed while they had been paid as little as Tk 69 a day in the pretext that they had been using the land for free. Following the "Mass hearing to resolve existing discrimination and suppression on Dalit" in the capital's Cirdap auditorium, Prof Mesbah Kamal of Dhaka University said neglect Dalits face was a social taboo and tool to deprive them of their rights. The jurists at the event, organised by Nagorik Uddyog, and Bangladesh Dalit and Excluded Rights Movement, decided contacting local administrations and police to expedite hearings and asking government high ups to ensure justice. Moreover, Barrister Sara Hossain, executive director (honorary) of Bangladesh Legal Aid and Services Trust (BLAST), said victims also can take support from BLAST's local offices. Guests said Dalits need to unite and raise voice to protest injustice they face and make public their opinions on ways to protect their rights. "Dalits' only target should be to seek justice and continue the fight till the end, said Supreme Court lawyer Khondoker Shariar Shakir, adding that Bangladesh's spirit dies when discrimination prevails. "You should not lose courage," said Nirupa Dewan, National Human Rights Commission honorary member, as chief guest, adding that relevant, effective laws were not implemented for a lack of sincerity and interest. Retired senior district judge Shamsun Nahar Begum and Chittagong lawyer Narayan Chandra Charmokar said Dalits should not think they were helpless and alone. The latter urged changing society's mindset through leaders created at local levels through forming organisations. "Bangladesh is still not in a position where one will carry out tortures and others will watch it silently," said Narayan. Nagorik Uddyog Chief Executive Zakir Hossain moderated the programme.
