KISHOREGANJ WAR CRIMES Fifth witness reveals Hasanled torching of his house

STAFF CORRESPONDENT A fifth prosecution witness

yesterday stated how Razakars led by fugitive Syed Md Hasan Ali set fire to his house in Kishoreganj's

Sachailpurbopara on April 27 during the 1971 Liberation War, just four days after he had left for combat training in India. The Pakistani occupation army and one of their auxiliary forces, Razakars, set up camps across Kishoreganj while he took

part in the Liberation War in Sunamganj following a 28-day training with 10-12 locals, Nurul Haque alias Lal Miah said in his deposition before the threemember International Crimes Tribunal-1. Returning to

Kishoreganj's Tarail near the end of June 1971, he came to know that Moulana Moslehuddin's son had become president of Peace Committee of Kishoreganj Mahakuma and his son Hasan commander of Razakars of Tarail Thana.

Nurul said Hasan killed one Tofazzal Hossain Bhuiyan at Konabhawal village, 12 persons of Paulpara in Shimulhati village, two Hindus of

Daily Star Centre in the capital where his son Eric performed. Pointing to his position in society, Ershad said, "When the announcer uttered former president


and army chief while inviting me for speech, I thought that she would call me a former dictator too." "After my resignation, an era started that marks

Indian visa centre

The Indian High Commission in Dhaka will open another Indian Visa Application Centre (IVAC) at House No 24, Road No 2 in the capital's Dhanmondi

on January 1. The State Bank of India (SBI) as the agent of the commission will accept all categories of visa applications and

deliver visas, said a press release yesterday. It will receive the applications from 8:00am to 1:00pm

and deliver visas from 3:00pm to 6:00pm. Such facilities are now available in Gulshan, Motijheel,

Chittagong, Sylhet, Khulna and Rajshahi. From January 1, visa applicants will have to pay Tk 600 at the IVACs in Dhaka, Chittagong and Rajshahi and Tk 700 in

Sylhet and Khulna. A special counter for medical emergency visas is available at IVAC, Gulshan. Medical emergency visa applica-

tions may be deposited on a walk-in basis. From January 1, applicants will have to scan and upload their photographs in the designated space provided in the

online application forms.

South Asian energy regulators finalise plan

South Asian energy regulators in a two-day meeting that concluded in Dhaka yesterday finalised a plan to promote cross-border electricity trade and agreed to remove the regulatory barriers in this regard.

"We had a very successful meeting, and all the regulators finalised a plan of action to address regulatory issues to enhance cross-border electricity trade," said Chairman of Bangladesh Energy Regulatory Commission AR Khan.

He was briefing journalists on the proceedings of the meeting at a hotel in the capital.

The first-ever "Council of Saarc Energy Regulators" meeting was hosted by the commission.

The Saarc Secretariat extended its full support by sending its Director Mohammad Ibrahim Ghafoori to the conference.

AR Khan said the Saarc region has a huge potential to generate electricity, and its energy

Grabbers gobbling Bheluar Dighi destroying allures

In the 1980s, people had a full view of Bheluar Dighi from all four sides from a distance. Its panoramic beauty drew visitors from far-flung places. Three decades later, only one bank is free.

In violation of law, small shops were built one after another surrounding the five-century-old pond. Bangladesh Railway (East Zone), its custodian, however, is blasé.

"Its beauty has been snatched," said Belal Uddin, an expatriate in Saudi Arabia, who grew up frolicking around the pond, now sprawling over 13.58 acres of land in Pahartali of Chittagong city. "Now it is hard to call to mind its past allures."

Rakib Hasan, a university student, said it could no longer be called Bhelua Sundori's Dighi (Sundori means beautiful). "The beauty is lost."

The legend goes that Bhelua, the charming wife of Chand Shawdagar, a rich businessman living somewhere on the east bank of the Jamuna river, was once abducted to Chittagong by a merchant smitten with her. As punishment, then ruler of Gaud executed the abductor and dug the dighi in place of his house compound in 1519-1533.

The story is written in Hamidullah Khan's "Ahadisul

Kawanin", dubbed the first book on Chittagong's history. Originally, Bheluar Dighi was

much larger. "Now all but the west bank are occupied by illegal structures," said Nasiruddin Mahmud, a dweller of Pahartali. "It was completely free in

the early 1980s." Abdul Bari, railway divisional estate officer, said the government acquired the pond in 1897 for Assam Bengal Railway, which built houses for its staff on the east bank. In 1980s, the authorities leased out the south and east banks to shop

owners, he said.

In a recent visit, this correspondent saw scores of tin and brick

shops, some of which encroached several feet into the pond.

Recognising the illegal occupation, Bari said that as per the lease agreement, the shops and the banks must be at least 20 feet apart.

The railway authorities did not lease out the north bank but a brick mosque was built well inside the pond and construction of several shops followed.

On condition of anonymity, a Pahartali businessman said the encroachers had connections to some railway high-ups, and thus enjoying impunity.

Abul Kalam, 70, a resident, said such a huge pond could not be built
