3 robbers get death penalty for killing fellow

A Dhaka court yesterday sentenced three members of a robbery gang to death in a case filed for killing one of their fellows at a hotel in Old Dhaka in

It also fined Mohammad Rubel, Rony Biswas, 23, and Roman, 25, Tk 25,000 each, in default to suffer one year in jail.

According to the prosecution, they beheaded another Rubel on June 6 in that year and kept the head at Shah Kamal restaurant (later named Meem Hotel) to blackmail its owner.

However, their attempt was foiled when police arrested them.

The convicts killed him following an internal feud among them over disbursement of booties.

Sutrapur police pressed charges against the three on December 29, 2010 and the court indicted them on September 21, 2011.
