

Narrowed down road poses risk for vehicles, pedestrians

Most part of the 36-kilometre road from Bismillah Chattar of Bhandaria upazila to CMB Bazar of Mahtbaria upazila under the district remains in an awful condition, posing risk for vehicles as well as pedestrians.

The seven kilometres of the road from Bismillah Chattar in Mathbaria to Gudighata in the same upazila is somewhat in good condition, having a width of 18 feet, said sources at Pirojpur Roads and Highways Department (RHD).

But rest of the road, having original

width of only 12 feet, has virtually narrowed down to half at places due to serious damage, they said.

The portion from Ikri Bazar of Bhandaria to Jhautala of Mathbaria upazila is in the worst condition, making vehicular movement difficult, especially when two big vehicles come from the opposite directions.

Hundreds of vehicles including buses, trucks and private cars, three-wheelers and motorbikes to and from Dhaka, Khulna, Barisal, Pirojpur, Barguna, Patuakhali daily move along the road, locals said.

"We need twice the usual time to reach Mathbaria from Bhandaria as the road is badly damaged. Movement on the bumpy road also causes harm to the vehicles," said Rafikul Islam, 48, a bus driver on the road.

Pedestrians alleged that they face life risk when two big vehicles cross each other, leaving no sidewalk for them.

Contacted, Md Nurun Nabi Tarafder, executive engineer of Pirojpur RHD office, said they have completed the process to start the work for repair of 16.25 km damaged portion of the road soon.

Housewife strangled

A housewife was strangled allegedly by her husband for dowry at Kutubpur-Jummapara village in Badarganj upazila on Wednesday.

The deceased was identified as Ivy Begum, 25, wife of Firojul Islam, 32, son of Ahmed Ali of the village. She was mother of a child.

Family sources said Firojul married Ivy, daughter of Iyub Ali of Osmanpur village in the upazila, five years ago.

After the marriage, Firojul often tortured Ivy for Tk 50,000 dowry.

On Wednesday night, Firojul strangled his wife following an altercation over the issue and fled the scene.

College boy hacked to death

A 'missing' college student was found dead at Chalanbil in Singra upazila on Wednesday night.

The deceased was identified as Atiqur Rahman, 22, son of Abdur Rashid, a resident of Bargana area in the same upazila.

Police said, Atiqur, who remained missing since December 23, was hacked to death.

Locals found his body lying in a field in the area yesterday morning and informed police.

Later, police recovered the body and sent it to Natore Sadar Hospital morgue for an autopsy.

UP chairman, 3 others held for attack on own party

Police yesterday a UP chairman and three others for their alleged involvement in an attack on a rally organised by local BNP leaders at Achintapur in Gouripur upazila on December 12.

The arrestees are Gouripur upazila chairman Ahmed Tayebur Rahman Hiron, joint convener of BNP Mymensingh (North) unit, convener of Jubo Dal Gouripur unit Nazrul Islam, activists Uzzal and Nurul Islam.

Police said, when Makbul Hossain Bakul, convener of a faction of

Gouripur BNP, went to Achintapur union to form union committee on December 12, Hiron's supporters attacked the rally, injuring five people including Bakul.

They also ransacked several vehicles, said Mohammad Ali Sheikh, officer in-charge of Gouripur Police Station.

A case was lodged with the police station, accusing 26 people including Hiron, said the OC.

The arrestees were produced before a Mymensingh court yesterday noon which sent them to jail, he said.

In Rajshahi, police on

Wednesday night arrested Bagha municipality mayor Akkas Ali of the district on charge of making disparaging remarks about Prime Minister Sheikh Hasina and State Minister for Foreign Affairs Shahriar Alam, reports UNB.

Aminur Rahman, officer in-charge of Bagha Police Station, said on information, a team of police arrested Akkas Ali from in front of the municipality office at about 7:30 pm while he was making the remarks.

However, he was released on a bond by his family members at night.

Man killed in clash over disputed land

A man was killed and 10 others were injured as two groups of villagers clash on Wednesday over the ownership of a piece of land at Sadarpur village in Sadullahpur upazila on.

The deceased was identified as Saiduzzaman, 45, a resident of the village.

Zia Latifur Rahman, officer in-charge of Sadullahpur Police Station, said when Akbar Ali of the village went to cultivate a disputed land, Mohammad Ali and his supporters way laid him in the afternoon, triggering a clash.

Both groups attacked each other with sticks and weapons, leaving 11 people injured.

The injured were rushed to Pirganj Upazila Health Complex. Later Saiduzzaman

succumbed to his injuries at about 10:00 pm in Rangpur Medical College Hospital.

In Moulvibazar, at least 60 people were injured in a clash between two groups at Pachimvagh village of Ajmeriganj upazila in Habiganj district on Wednesday night, reports our correspondent.

Locals said, the clash took place over establishing supremacy in the area between former UP Chairman Ali Amjad Talukdar and former UP Chairman Laliur Rahman Talukdar.

The supporters of two groups were locked in clash with iron rod, hockey stick, bamboo and other sharp weapons in front of Pachimvagh area.

Police lobbed tear gas shells and fired rubber bullets to bring the situation under control.
