Denial of Historical Facts of Liberation War

Punish through new law

War crimes researchers, freedom fighters, academics tell launching of 10 books about genocide asking to write more about it

War crimes researchers, freedom fighters and academics yesterday urged the government to, like European countries did over the Holocaust, enact a law with provisions of punishment for denial of historically established facts and settled

issues of the 1971 Liberation War. They also emphasised more write ups on genocide committed during 1971 and other relevant issues to

counter propaganda against it. The call came at the publication ceremony of a collection of 10 books titled "1971: Ganohatya-Nirjatan Nirghanto Granthamala" in the capi-

tal's WVA auditorium. Eight persons, mostly youths, wrote the books on 10 separate acts of genocide around the country on the basis of their

research, field visits and interviews.

killing fields and mass graves and on collecting historic documents of 1971, published the books.

War crimes researcher Shahriar Kabir said denial of established facts of Holocaust committed by Nazis during the World War II was a crime in most European countries, including Germany.

Historian and the trust President Muntassir Mamoon said the genocide, torture and killing fields did not get importance in the last four decades and for these reasons, many people dared to question the number of victims of genocide.

Raising questions over the genocide is tantamount to dishonouring the martyrs and rape victims of 1971 and

those who do so are traitors, he said. Educationalist Burhanuddin Khan Jahangir said political parties which

Talks on Teesta Water Sharing, Border with India

Bangladesh needs internal political consensus first

Discussion told

Bangladesh must forge an internal political consensus to negotiate water sharing of trans-boundary rivers, the border treaty, and trade deficit with India, speakers told a discussion yesterday.

Otherwise, India will take advantage of a prolonged political weakness and dillydally on settling the issues extremely crucial for Bangladesh, they said.

"Bangladesh's concerns over river water sharing and border issues with India are related to its existence," said former state minister for foreign affairs Abul Hasan Chowdhury. Negotiations with India would be much easier if there were political accord,

he said. A group of retired senior professionals called The Dhaka Forum organised the

discussion at the capital's Brac Centre. Though Bangladesh has assured all-out economic and political partners. support to address India's security concerns,

the latter has made empty promises on the Teesta water sharing and land-boundary treaties time and again since Indian premier Manmohan Singh's visit to Bangladesh in September 2011, said former ambassador M Serajul Islam.

The president of Bangladesh came back from India empty-handed without getting any specific timeframe for the signing of Teesta and border treaties, he said.

Shamsher Mobin Chowhdury, BNP's vice-chairman, said China funded and built a deep-sea port in Sri Lanka but it was not understandable why the same could not be done in Sonadia of Cox's Bazar despite China's interest.

Former ambassador Farooq Sobhan said construction, finance and operations of a deep-sea port in Bangladesh required major diplomatic efforts on how to deal with India and China because both were Bangladesh's
