Confined Khaleda announces nonstop blockade

brigade and utility services, and restaurants, hotels and drug stores will remain out of the purview of the blockade, party sources said.

Meanwhile, the ruling Awami League and its various front organisations defied an indefinite police ban on political activities in the capital. They brought out processions and held rallies and human chains in many parts of the city to celebrate the day as the "Victory Day for Democracy".

But the government took every measure to thwart the BNP's bid to hold any rally in the capital.

On the way to the BNP chairperson's office, 12 trucks, some of them loaded with sand and bricks, were placed at Sunday midnight. Three police trucks, three armoured personnel carriers and a water cannon were also positioned on nearby streets to "beef up" security.

In a similar fashion, Khaleda was confined to her Gulshan residence on December 29, 2013. She was not allowed to join the "March for Democracy" aimed at resisting the January 5 polls.

On Saturday night, cops picked up BNP Joint Secretary General Rizvi

hospital. The law enforcers also drove out all other leaders and activists of the opposition party and its office staff and locked the main entrance from outside.

All roads to Khaleda's Gulshan office and the party's Nayapaltan office were blocked and guarded by a large number of law enforcers, preventing the BNP men from gathering there.

The government action to foil the BNP's planned rally also caused immense public sufferings in the capital and elsewhere. The government used the administration to cut off the capital from the rest of the country since Sunday, by snapping major roads and waterways communication. Interdistrict communications were also disrupted.

Outside the capital, BNP men brought out processions in several districts and clashed with AL men and police. Four people were killed in such clashes.

But the city streets were under the control of the ruling party activists, who took to the streets in their hundreds to observe the first anniversary of the January 5 polls.

Police, instead of enforcing the ban,

Khairul Islam Jewel, an organising secretary of Swechchhasebak League, said they did not hold any procession or rally to respect the police ban on political activities.

"We just remained alert in the streets as conscious citizens of the country to safeguard democracy," he said. But another leader of the organisa-

tion said they were asked to gather there by the party high-ups. "We had no option but to come,

though I know it violates the law," said the leader, seeking anonymity. Several hundred Chhatra League

men staged motorcycle showdowns in Shahbagh and Press Club areas.

Party central and city unit leaders took position before the party headquarters on Bangabandhu Avenue.

City AL General Secretary Mofazzal Hossain Chowdhury Maya, also disasIslam, food minister, were present

Asked if their gathering defied the DMP ban, Maya said the AL was not holding rallies and processions. "We have taken to the streets so that no one can create anarchy." Around 10:30am, Maya went to the

From early morning, law enforcers cordoned off its headquarters and put up barricades on all the roads leading to it. Several hundred members of different law enforcement agencies took position at different points around the office.

Police set up barbed-wire fences at the Kakrail intersection, one of the entry points to the BNP office. Similar fences were at Fakirapool intersection.

No one was allowed to cross the barricades expect for the journalists, who had to show their identity cards. But there was no restriction to enter the school AL office area.

Fresh anxiety grips students, guardians

O-level and A-level students are likely to bear the brunt of political unrest as their January session exams begin today amid the BNP's countrywide nonstop blockade.

The BNP called the blockade yesterday. Two O-level and an A-level examinations are scheduled for today. But the British Council in Bangladesh, which administers the exams, has not yet made any change in the examination schedule.

"If the situation turns violent, we will inform the students whether the exams will be held," said a British Council official who looks after

Natore witnessed the worst of the clashes across the country. Two students were shot dead and 15 others were injured as activists of the ruling Awami League and the BNP traded bullets.

The deceased were Rakib Hossain, 20, and Raihan Ali Rana, 20, both students of Natore NS Govt College. Rakib's father claimed that both of them were pro-BNP Jatiyatabadi Chhatra Dal activists but the claim could not be verified.

Activists of both sides brought out processions in Tebaria area of the town around 10:30am. Indiscriminate firing from the processions caused injuries, sources said.

Rakib and Raihan were declared dead after they were taken to Natore Sadar Hospital, police said.

Witnesses said the clash erupted in front of police who were just spectators. However, Superintendent of Police Basudev Banik of Natore said there were no police during the clash.

Rakib's brother Anjurul Munshi filed a murder case with Natore Sadar police station.

RAJSHAHI

A BNP leader was shot dead and some 25 people were injured when BNP activists clashed with law enforcers at Baneswar Bazar of Puthia upazila.

Mojiruddin, 45, was the BNP ward

unit vice-president of Maria union in Charghat upazila. He died on the spot around 4:30pm after being shot in the head, said Alamgir Kabir, superintendent of police of Rajshahi.

Witnesses and police said the clash erupted around 3:00pm when law enforcers intercepted a BNP procession at Baneswar Bazar.

hurled brick chunks and crude bombs at police. The police fired over 100 rubber bullets, teargas shells and sound grenades.

The district police chief claimed that the BNP men's attack on police was planned. "The police was forced to open fire in self defence when BNP men shot at them and hurled over 50 homemade bombs."

Sources claimed that local AL activists joined the police and left only after Rab and BGB personnel reached the spot.

In the morning, around 10 BNP men were injured when police fired about 40 rubber bullets and teargas shells after BNP men attacked them with crude bombs at Dori Khorbona in Rajshahi city.

The BNP men also torched northern regional Awami League office and Ward-30 AL office at Binodpur. They also set fire to a straw-laden truck in Charghat.

CHAPAINAWABGANJ

A BNP activist was killed and 10 people, including two law enforcers, were injured during a clash between police and Jamaat-BNP men at KansatGopalnagar intersection in Shibganj upazila.

Deceased Jamshed Ali, 40, was the son of Momtaj Ali of Shibnarayanpur. Shahjahan Mia, president of district unit BNP, claimed that Jamshed was a BNP activist.

Moinul Islam, officer-in-charge of Shibganj Police Station, said police The BNP men armed with sticks opened fire around 3:00pm when CHITTAGONG Jamaat-BNP men hurled crude bombs and brick chunks at police, violating the section-144 imposed there.

THE CAPITAL

Pro-BNP lawyer Saidur Rahman Jatan and police constable Mustafizur Rahman were injured during a scuffle between pro-BNP lawyers and the police in Supreme Court area after chases and counter chases took place between pro-AL and pro-BNP lawyers in the afternoon.

At least 10 people were injured when police fired rubber bullets on a procession led by BNP leader Mirza Abbas in Shahjahanpur.

Police recovered 20 abandoned petrol bombs from BNP's youth wing leader Mohammad Saleh's house in Gendaria in the morning.

An AL office at Naya Bazar and two BNP offices at Bangshal and Shuritala were set ablaze. BNP men allegedly set fire to a police motorbike, two buses and the office of the Dhaka division

Criminals also exploded homemade bombs in Segunbagicha, Fakirapool, Purana Paltan and near Shikkha Bhaban.

At least 20 people, including three policemen and a shop employee, were injured during a clash between police and activists of the BNP and Jamaat-e-Islami. Police attempts to foil a 20-party alliance rally near Nasiman Bhaban in the afternoon triggered the clash.

The government is apprehensive that the opposition parties will resort to violence.

Justice Mustafa Kamal

was born in Rangpur in 1933 and was named Mustafa Kamal by national poet Kazi Nazrul Islam, said a press release issued by his daughter Nashid Kamal.

He had an illustrious academic career -- standing first class first in BA (Hons) and MA in Political Science from Dhaka University in 1953 and 1954. In 1958, he obtained MSc (Economics) in Political Science from the London School of Economics and Political Science and joined the Lincoln's Inn in 1959.

After completing his studies, Mustafa Kamal practised law in the Dhaka court, and was appointed as a High Court judge in 1979. He was elevated to the Appellate Division in 1989. He served as the Chief Justice of Bangladesh from June 1 to December 31 in 1999.

Mustafa Kamal has imparted wisdom, creativity and progressiveness to the judiciary for 20 years, the press release states.

His judgements remain as exemplary documents to his successors, standing out both in style and content. In 2003, he was appointed as a consul-

tant for Alternative Dispute Resolution (ADR) by the then government and had taught modules on the ADR in 64 districts of the country.

He may be called the "father of ADR" in Bangladesh. He also served briefly as the chairman of the Law Commission.
