Both the dead -- Md Rubel, 28, of Senbag upazila's Shibpur and Md Mohsin, 29 -- were activists of the BNP's youth front Jubo Dal, according to Kamakhya Chandra Das, general secretary of the district unit Jubo Dal.

Blockade supporters were rampaging through Chaumohani Rail Gate area in Begumganj upazila yesterday evening, said ASM Ashrafuzzaman, additional superintendent of Noakhali police.

When police reached the spot, the blockaders started pelting the policemen with brick chunks and stones, forcing the law enforcers to open fire, he added.

The injured were rushed to Noakhali Abdul Malek Ukil Medical College Hospital where Rubel and Mohsin were declared dead.

Kamakhya claimed they had brought

out a peaceful procession in support of the blockade but police intercepted and opened fire on them. However, Superintendent of Noakhali Police Ilias Sharif told The

Daily Star that it was the blockaders who fired the shots first and police only retali-

He also claimed that seven policemen were injured in the violence.

Fourteen BNP-Jamaat men were detained in this connection as of 10:50pm and drives were on to arrest

The local BNP is enforcing a daylong shutdown in the district today to protest the killings.

DHAKA At least seven vehicles were torched in the

capital yesterday.

Unidentified criminals, presumably blockade supporters, set fire to a bus of the public administration ministry in front of Motijheel Krira Bhaban around 6:15pm.

Fire fighters rushed to the spot and doused the blaze. No casualty was reported.

Criminals also set fire to a bus in front of Bahadur Shah Park in Old Dhaka around 6:40pm, one near Azimpur Bus

Stand around 7:00pm and another at Shewrapara in the morning.

Apart from these, two more buses were torched in front of Mirpur Indoor Stadium and in Khilkhet, and a sport utility vehicle was set afire in Segunbagicha last night, according to fire service officials.

Despite the arson attacks, traffic movement inside the city was almost normal, with its streets packed with all sorts of public and private vehicles. **JESSORE**

A bus helper -- identified as Murad Mollah, 20, of Magura Sadar upazila -was burnt as miscreants set his bus alight

while he was sleeping in it early yesterday.

Officer-in-Charge Enamul Haque of Jessore Kotwali Police Station said a group of blockaders set fire to the bus parked at Khajura Bus Stand around 4:00am. Police and fire fighters rushed to the

spot and sent Murad, who suffered 50 percent burns, to Jessore Medical College Hospital, he said. Another bus was torched near the bus

stand around the same time. But none was hurt in the incident.

FROM PAGE 16 A sense of fear and tension nonetheless was all-pervading.

"The streets may turn into battle fields all of a sudden. It is indeed frightening to take my daughter to school. Whenever we see people clustering together in a place, my daughter looks scared," said Shormy Rahman, a mother in the capital's Indira Road.

"Sometime I ask my daughter to stay home. Although a new academic year has begun, she is yet to concentrate on her studies. She is confused as to what to do," said the mother, whose daughter studies at Holy Cross High School.

More than four crore primary to secondary level students are beset with political uncertainty at the beginning of their new year. They received new textbooks but could not start their classes properly. Though many schools have remained open despite the blockade, presence of students is thin.

"If students turn up, we take classes. But their attendance is still less than what is expected," Shahan Ara Begum, principal of Motijheel Ideal School and College, told The Daily Star yesterday.

Gaffar Mia's case was no different. A tea vendor at Ramna, he had to run the risk of keeping his stall open for it was his

bread and butter.

"The business has been bad for the last two days as number of customers dropped. However, I've got more customers today [yesterday] than the previous two days," he said.

Abid Islam, too, had a little respite yesterday. A private banker, he had found it difficult on Monday and Tuesday to get to his Gulshan office from his Mirpur residence. He had to change vehicles thrice and then walk quite a distance to reach his office. But it was a pretty smooth journey yesterday. Only his nerves remained stretched all the way.

"I had to spend Tk 150 to 200 to go to

my office on the first two days of the blockade because I had to take rickshaws and a CNG-run three-wheeler to make it to my office. But today I've got a direct bus to Gulshan-2. Then I walked to my office," he said. "We saw some violent fighting on television. It scares me. Yet I have no alternative as I need to attend my office. The politicians have made daily lives of people like us very diffi-

Abid had another fear. His wife works at a bank at Karwan Bazar. "I remain anxious about her safety and security," he added.

"Passenger buses and good-laden trucks are getting burned everyday. Such incidents are causes of concern for com-

mon people as well as businessmen. "We want relief from this situation for the smooth running of our business," Helal said.

found, all of them floating at sea. And despite the discovery of the tail, authorities could not say when the black boxes would be found and retrieved.

One problem is the tail being deep into the seabed, according to chief maritime affairs minister Indroyono Soesilo.

The search for the rest of the plane would now focus on a two-nauticalmile area surrounding the tail, with a

remotely controlled mini-submarine a key part of the effort, Soesilo and other senior Indonesian officials told a press conference.

Many of the bodies yet to be recovered were likely in the main parts of the plane that have yet to be found, they Indonesia's transport ministry said

yesterday that it had fired one transport official and disciplined several others in a crackdown following the crash, as it investigated how the flight was able to depart without permission.

Indonesia alleges the plane was flying on an unauthorised schedule when it crashed and AirAsia has since been suspended from flying the Surabaya-Singapore route.

"To date, we have taken action

against eight officials -- two from the transport ministry, four from state navigation operator AirNav, and two airport officials," Hadi Mustofa, an official with the transport ministry's

public affairs office, told AFP. "One of the transport ministry officials was fired and the other official was temporarily suspended. As for the other six officials, some have been temporarily suspended and some have

been transferred." AirAsia Indonesia has declined to comment on allegations it violated its

permits. Dozens of military and search officials saluted coffins containing the latest recovered bodies as they were carried by pallbearers to an air force

policeman as he lay on the pavement. One attacker says "you wanted to kill me?" before shooting the officer execution style.

Large numbers of police and ambulances rushed to the scene and shocked residents spilled into the streets. Reporters saw bullet-riddled windows and people being carried out on

stretchers. Prosecutors said 11 people were also injured in the attack, with four in criti-

cal condition. One man who witnessed the attack

described a scene like "in a movie."

"I saw them leaving and shooting. They were wearing masks. These guys were serious," said the man who declined to give his name. "At first I thought it was special forces chasing drug traffickers or something." Authorities said their cold and

calculating manner suggested they had been well-trained. French authorities placed the Paris

region on its highest alert level and beefed up security with soldiers deployed at major transport hubs. The attack took place at a time of

European capitals over fallout from the wars in Iraq and Syria, where hundreds of European citizens have gone to fight alongside the radical Islamic State group.
