SC clears way for trial of Mahmudur's graft case STAFF CORRESPONDENT

DRY WEATHER LIKELY

The Supreme Court yesterday cleared the way for a lower court to continue trial in a corruption case against Mahmudur Rahman, detained acting editor of the daily Amar Desh, by rejecting his two leave-to-appeal petitions.

The Anti-Corruption Commission filed the case on June 13, 2010, accusing him of not submitting his wealth statement to it.

On September 28, 2010 the HC stayed the proceedings of the case but the court vacated the order on May 27, 2013.

A Dhaka court on April 28, 2014, framed charges against Mahmudur while on September 11, 2014, the HC rejected his revision petition challenging the indictment. He filed leaveto-appeal petitions with the SC in 2013 and in 2014 against the HC orders.

ACC lawyer Khurshid Alam Khan said a Dhaka court is scheduled to resume recording deposition on January 22.

CTG TEACHER MURDER

Police yet to make headway

Police are yet to make any headway in the case centring the murder of a Chittagong Nursing College teacher, Anjali Dev. Anjali was killed by

unidentified masked assailants in Chawkbazar on her way to the college on Saturday morning but they did not take her cellphone, handbag or money, which suggests it was a preplanned murder, said police.

Jahangir Alam, assistant commissioner of the Detective Branch of Chittagong Metropolitan Police, also the investigation officer of the case, said they are working on different leads, including allegations of family feud, as Anjali was the second wife of Dr Rajendra Chowdhury.

Anjali's family members, neighbours, colleagues and witnesses have already been interrogated, he added.

Yesterday, the college students brought out a procession from Chittagong Medical College Hospital premises, which ended at Probortok intersection in the port city, demanding immediate arrest of the culprits.

BAKSHIBAZAR VIOLENCE No bail, no remand for Goyeshwar

A Dhaka court yesterday sent BNP standing committee member Goyeshwar Chandra Roy to jail after rejecting his bail prayer and police's 10-day remand prayer in a case filed over the December 24 Bakshibazar violence.

Goyeshwar was earlier remanded for five-days in two other cases, one filed on December 26 with Turag police for creating anarchy while the other with Shahbagh police for attacking the ruling party's Netrakona-1 lawmaker, Chhabi Biswas, on Dhaka Medical College Hospital oremises on December 24.

The same court also sent Jubo Dal President Syed Moazzem Hossain Alal to jail after rejecting his bail prayer and police's 10-day remand prayer in the same case filed with Shahbagh

BGB to open air wing to curb cross-border crimes

Border Guard Bangladesh (BGB) is set to open an air wing to combat trans-border crime, primarily trafficking of drugs with a special emphasis on Yaba, through patches of an around 400 kilometre-stretch of unfenced, unguarded and nearly inaccessible border with Myanmar and India in the Chittagong Hill Tracts.

"We already sent the proposal to the home ministry last week," BGB Director General Brig Gen Aziz Ahmed told journalists yesterday emerging from Jatiya Sangsad Bhaban after attending the second meeting of a sub-committee the parliamentary standing committee on home affairs formed.

Prime Minister Sheikh Hasina gave the at the Prime Minister's Office in the third week of last month, he said, adding that intrusion of Yaba from Myanmar was now Bangladesh's biggest threat. A BGB source said trafficking of drugs,

especially Yaba, through the stretch, where road connectivity is virtually non-existent, increased sevenfold in the last four years, bringing about the decision.

At yesterday's meeting lasting for around two hours in SCC where Rezaul, a former Sylhet city BNP organising secretary, and pro-BNP Panel Mayor-2 Saleh Ahmed Chowdhury were present, the councillors justified their decision over two issues.
