Sust student orgs unhappy over politics suspension

University remains scheduled to reopen on Jan 18

Prominent student organisations at Shahjalal University of Engineering & Technology (Sust) are refusing to accept the university administration's temporary bar on politics on the campus, expressing their discontent to The Daily Star yesterday.

An emergency Syndicate meeting on January 10 decided to impose the suspension and reopen the university on January 18, and halls the day before, allowing only resident students with allotted seats.

Sust was closed indefinitely on November 20 after two factions of Bangladesh Chhatra League clashed, killing an activist from outside the cam-

Bangladesh Chhatra League's Sust unit President Sanjibon Chakravarty Partha termed the decision "unacceptable" while Jatiyatabadi Chhatra Dal

Convener SM Jahangir declared paying no heed to it, stating that such repercussions for one organisation's activities should not befall all. Samajtantrik Chhatra Front President


Anik Dhar stated that student politics was a constitutional right and echoed Jahangir on rejecting the consequences. Terming the decision "undemocratic,

authoritarian", Bangladesh Chhatra Union President Srikanta Sharma compared it to chopping off one's head as a solution for a headache. Meanwhile, the three-member probe

committee, headed by Prof Ilias Uddin Biswas, could not file its report yet because he "could not talk to the students" amid closure of the university. The committee, however, was not given

any deadline to finish the investigation. Till date, 41 BCL activists have been arrested in three cases filed over the incident.



Govt officials get Malaysian visa exemption

The cabinet yesterday approved a proposal to ratify a bilateral agreement allowing visa-less entry and stay of 90 days for diplomatic and official passport holders of Bangladesh and Malaysia.

The visa exemption will apply for family members and children under 21 years of diplomats, Cabinet Secretary M Musharraf Hossain Bhuiyan told journalists, adding that the agreement was signed on December 3 last year, during Prime Minister Sheikh Hasina's visit to Kuala Lumpur.

Bangladesh has visa exemption agreements with 12 countries and discussions are ongoing with 18 more.

for Tripura. Of the existing two, one was opened where Baliamari under Rajibpur upazila of Kurigram meets Kalaichar in Meghalaya's West Garo Hills district, on July 23, 2011.

In the same year the other haat was opened where Lauwaghar (Dalora) in Sunamganj faces Meghalaya's Balat in East Khasi Hills district. The haats are being set up under a

Memorandum of Understanding on border haats and trade signed on October 23, 2010.


