The High Court yesterday upheld a lower court verdict that sentenced two people to death for killing two children in Dhaka in 2008.

The convicts -- Ranju Sarker alias Ranzu Sarder, 30, and Md Liton alias Kosai Liton, 30, -- are now in jail.

The HC bench of Justice Shahidul Islam and Justice KM Kamrul Kader gave the verdict after rejecting separate appeals filed by the convicts challenging the lower court verdict.

However, the grounds on which the HC delivered the verdict could not be known as its full text was not released yesterday.

According to the case statement, Ranju and Liton killed Jewel, 10, and Biplob, 7, after sodomising them at an abandoned house in Nayatola area under Ramna Police Station on April 29, 2008.

Jewel's father Alauddin filed a murder case after police recovered the decomposed bodies of Jewel and Biplob on May 1, 2008.

Ranju and Liton made confessional statements before police and magistrates, the statement added.

Next year on August 5, a Dhaka court convicted Ranju and Liton and sentenced them to death after finding them

Liton's lawyer Khabir Uddin Bhuiyan said his client would file an appeal with the Supreme Court challenging the HC verdict.

BNP's Nasir, Taimur get bail from HC

The High Court yesterday granted anticipatory bail to 22 BNP leaders and activists, including Mir Mohammad Nasir Uddin and Taimur Alam Khandker, for four weeks in two cases.

Nasir got bail in a defamation suit, filed by freedom fighter Shawkat Ali Khan alias Sundar Khan for being present at the programme, where BNP Senior Vice-President Tarique Rahman termed Bangabandhu Sheikh Mujibur Rahman "a top Razakar" on December 16, 2014, and for not protesting against the comment, said AKM Ehsanur Rahman, a lawyer for the leaders.

Meanwhile, Taimur and 20 BNP leaders and activists of Narayanganj got bail in a case filed for vandalising vehicles and exploding bombs during January 9 blockade.

People can establish rights using RTI act

Speakers tell launching of video on the law

By application of the Right to Information (RTI) Act, 2009, people can establish their rights and help ensure good governance, transparency and accountability of the government and non-government service providers in the country.

Speakers made the observation at the launching of a video on how to reap benefits from application of the RTI act produced by Dnet, an NGO, with support from Manusher

Jonno Foundation (MJF).

Dnet and the Information Commission organised the event at the commission's office in the capital yesterday.

Chief Information Commissioner Mohammad Faruk said the video showed how ordinary people can be empowered with information.

"There are so many safety net programmes of the government but many people do not even know about them," said Shaheen Anam, executive director of MJF and convener of

Information Rights Forum.

She hoped that the simple language used in the video would help people learn about the RTI law and its applicability easily and quickly.

Secretary of the information ministry Martuza Akhmed as a special guest at the event said he would ensure distribution of the manual in all the districts through the Department of Mass Communication. "We would also ask Bangladesh Television and other private channels to air the video," he added.



ACC approves charge sheets against trader of Old Dhaka

The Anti-Corruption Commission (ACC) yesterday approved charge sheets in two cases filed for laundering around US \$4.3 million abroad against a trader of Old Dhaka in the capital.

Mohammad Rafik Uddin, owner of Fyaz Uddin and Company at Mitford in the capital, opened 10 letters of credit (LC) worth \$ 4.02 million with Moulvibazar branch of Al-Arafah Islami Bank to import foodstuffs from the UAE in 2012.

According to the case statement, Mohsen Al-Barak General Trading of Dubai was shown as the exporter in the LC, said ACC Deputy Director Hrittik Saha.

In the same year, another LC of US \$278,000 was opened with the same branch for importing foodstuffs from Nabel Hossainn General Trading in Dubai, he

Both the amounts were siphoned off to the UAE but no food was imported, said Hrittik.

The ACC started investigation into the allegation against him in 2013 and filed the two money laundering cases with Chawkbazar Police Station in the capital at the beginning of last year, he said.

Since the start of the probe, Rafik has been absconding, Hrittik further said.

hurling crude bombs at police, and creating hindrance to the work of law enforcers".

This correspondent yesterday visited the scene, the victim's office and residence and neighbouring areas and talked over 50 people but none said there was a political

programme or any bomb explosion. Expressing anger over the incident, the people of the area demanded punishment for the cops involved.

Mohammad Dulal, a grocery shop owner near the rail tracks, said neither the BNP nor the Awami League had held any political programme near the rail lines in the last couple of months.

"What police is saying now is false and fabricated," he said.

The SI could not be reached by phone.

Iqbal Hossain, deputy commissioner of Uttara Division of Dhaka Metropolitan Police, said he primarily came to know that the incident followed a blockade demonstration.

A three-member team of police led by an additional deputy commissioner is investigating the matter, and will submit a report in 10 working days, he said.
