Boy dies falling from roof in capital

A 12-year-old boy died after falling from the roof of their tin-shed house in the capital's Gendaria area yesterday.

The deceased, Akash, a student of class-6 of Gendaria High School, slipped down after he climbed up the roof to collect a kite stuck there and received serious injury, said police quoting the deceased's relatives.

He was rushed to Dhaka Medical College Hospital

where doctors declared him dead.

Tea vendor kills driver in capital

A driver of a human hauler was stabbed to death allegedly by a tea vendor over a trifling matter in the capital's Darus Salam yesterday.

Mohammad Shahin, 19, was declared dead at Dhaka

Medical College Hospital on arrival.

Rafiqul Islam, officer-in-charge of Darus Salam Police Station, said Shahin asked the tea vendor, Sujan, 19, for an empty can of condensed milk which he refused, triggering a quarrel and later Sujan stabbed him in the abdomen with a knife.

4 illegal brick kilns fined Tk 4 lakh

every public exam in the last two years, including that of Secondary School Certificate (SSC), mired in allegations.

Nahid also urged students and guardians not to go on wild-goose chases hearing rumours and to instead concentrate on studies.

He said punishment would be ensured under Public Examinations (Offences) Act-1980 and the Public Examinations (Offences) (Amendment) Act-1992, having fines and jail terms between three and 10 years. Meeting sources said as part of preparations for the exam,

scheduled to begin on February 2, each of the country's 10 education board would get a control room with a deputy secretary in charge and phone and internet connections and information technology experts.

They will report any form of irregularity to Bangladesh Telecommunication Regulatory Commission and law enforcement and intelligence agencies, they added. Further details are at the education ministry's website.

Nahid said all-out measures have been taken so that no controversy arose.

One of the law enforcers in attendance, Sheikh Muhammand Maruf Hassan, additional commissioner (detective branch) of Dhaka Metropolitan Police, even challenged leakers. "We are confident that none will dare to leak questions this time," he said.

Inu tells seminar

A traffic cop was preparing to fine a person for haphazardly parking his car on the footpath in Dhaka. While noting down the person's name, address, and detail identity, the policeman found that the person he was going to penalise was no "ordinary" man but the son of a minister.

Within moments the policeman halted the fining process and apologised to the minister's son because he could not identify him in the first place.

The story goes on. The cop promptly called up his superior official, who asked him to beg pardon of the minister's son.

This happened a few months to the son of Information Minister Hasanul Haq Inu, who claimed that his son finally paid the fine, despite unwillingness of police.

The minister himself stated the example, talking about how the perpetrators responsible for road accidents go unpunished due to politically influential people

and corrupt government officials. Inu was speaking as chief guest at a seminar titled "Role of Media in preventing road accidents", organised by the Passengers' Welfare Association at the capi-

tal's Jatiya Press Club yesterday.

In most cases, the culprits escape punishment through underhand dealings through influential quarters. This culture of impunity and networking are a significant contributor to the recurrence of road accidents, he added.

The office, from where the vehicles' fitness certificates and drivers' licences are issued, is a hub of corruption, he said, alluding to the Bangladesh Road Transport Authority (BRTA). These documents are issued without proper inspections and tests, and subsequently, unfit vehicles and unskilled drivers run on the road causing accidents, he added.

About the role of journalists, Inu said the media should report more on awareness building among the people and on loopholes in the transport sectors and negligence of responsible officials.

A statement of the Passengers' Welfare Association that was presented at the function says around 83 percent of the people of accused of road accidents are not arrested.

In 2013, over 2,000 cases were filed for road accidents accusing 2,057 persons, but only 352 were arrested, the statement adds. SEE PAGE 5 COL 5

The officials from Sylhet and Mymensingh regions and the Indian state agreed to resolve the issues, including killing of civilians.


Smuggling of arms and drugs and human trafficking were, among others, discussed in the meeting.


