A mobile court sentenced two people to one month's imprisonment for arranging marriage of an underage girl at Baraghariya village in Aditmari upazila on Wednesday.

The convicts are bridegroom Laizu Miah, 24, son of Wahab Ali of Uttarpara village, and bride's grandfather Jasim Uddin, 65, of Baraghariya in the upazila.

Police said Mazeda Khataun, 14, daughter of Jabed Ali of Baraghariya village and a student of Class VI of DS Dakhil Madrasa in the area, was set to be married with Laizu on

A man was killed and three others were injured as armed robbers opened fire on the villagers at Bhadrasan village in Shibchar upazila of the district early yesterday.

The deceased was identified as Jahangir Hossain Bepari, 30, son of Aziz Bepari. Police quoted witnesses

as saying that a gang of 15/20 robbers entered the house of one Anil Saha by breaking open the door at around 2:30am and beat up the family members.

The gang confined Anil, a grocer, and his family members to a room and looted cash, gold ornaments and other valuables.

Both husband and brother-in-law on Wednesday confessed to the killing of Rina Begum in Kalapara upazila of the district over a month ago.

They gave statements before a court under Section 164, said Md Azizur Rahman, officer-incharge of Kalapara Police Station.

After recording their statements, Senior Judicial Magistrate Swapan Kumar Das sent the deceased's husband Rashed Khan, 40, and brother-in-law Haider Khan to jail in the evening.

Police arrested the two in Khurier Khaya ghat area under Amtali upazila of Barguna district on Tuesday. The arrestees hail from Goiamtala village in Kalapara upazila.
