Obama, Modi plan radio show to reach out to masses REUTERS, New Delhi

The leaders of the world's largest democracies will next week take to India's radio airwaves, the main source of news and information for many in the country, to get their message out.

U.S. President Barack Obama, who will be the chief guest at New Delhi's showpiece Republic Day military parade on Jan. 26, will join Prime Minister Narendra Modi on a special edition of the latter's radio

asked to pre-submit questions by Sunday to the "Mann Ki Baat," or "Talking from the Heart". "This month's 'Mann Ki

Baat' episode will be a special one, where our Republic Day guest @BarackObama & I will share our thoughts together," Modi tweeted on Thursday. Modi makes radio

speeches at least every month to communicate with two-thirds of India's 1.2 billion people who regularly listen to the radio.

Obama's decision to appear on the show during his visit is a sign of the bond the two leaders share. In a unique departure from protocol, Obama accompanied Modi on a motorcade drive from the White House to the memorial honouring slain U.S. civil rights leader Martin Luther King Jr. during the leader's visit to Washington last year.Modi and Obama also issued a joint editorial before that trip, a first for an Indian leader, according to

Opposition protests brought Nepal's parliament to a grinding halt yesterday, with hopes fading fast of an eleventh-hour agreement on a new constitution before a midnight deadline expires. Lawmakers rushed into the well

of the parliament chamber as they reconvened late yesterday, in a chaotic bid to prevent politicians from the ruling party proposing a vote on disputed issues in the constitution.

"We want a constitution based on consensus," the opposition lawmakers shouted.

Nepal's rival parties have spent years mired in deadlock while trying to reach agreement on a constitution for the young republic. Parliament speaker Subash

Nembang called an emergency meeting of top leaders in the afternoon in a last-ditch push for a deal on the national charter, but talks ended without an accord.

"The country is watching us... what kind of message are we giv-

ing?" said Nembang.

"Let us work together and conclude the process."

Analysts say the protracted stalemate raises the risk of unrest in the impoverished Himalayan nation, where lawmakers this week threw chairs and scuffled in parliament as tempers frayed.

Authorities have deployed 1,000 police to guard parliament after the violence spilled over onto the streets, and on Thursday 2,000 flag-waving protestors demonstrated outside. "I am very sad today. We voted for

them... and they have failed to deliver," said Kathmandu-based xray technician Moti Lal Sharma Thakur, reflecting a growing sense of frustration over the delayed charter.

"We had high hopes and they have disappointed us yet again," the 28-year-old told AFP.

The constitution was intended to conclude a peace process begun in 2006 when Maoist guerrillas entered politics, ending a decadelong insurgency that left an estimated 16,000 people dead.

Nepal in limbo over draft charter

Leaders in emergency talks to bridge gap as constitutional deadline looms

Six prime ministers and two elections later, discord between the opposition Maoists and ruling parties has intensified, paralysing the drafting process. Hours before parliament opened,

former Maoist premier Baburam Bhattarai urged lawmakers to "commit to drafting a constitution based on common agreement". "Only a constitution based on

consensus will ensure long-term peace in the country," he wrote in a message on his official Facebook page. A key sticking point concerns

internal borders, with the opposition pushing for provinces to be created along lines that could favour historically marginalised communities. Other parties have attacked this

model, calling it too divisive and a threat to national unity. The ruling parties and their allies

have the two-thirds parliamentary majority they need to approve a constitution without Maoist support.

But the former insurgents have

warned of further conflict if they fail to take opposition views into account. A missed deadline will prolong

instability and hurt economic growth in a country where one out of four people survive on less than \$1.25 a day, according to World Bank data.

Several lawmakers from the ruling coalition told AFP that a vote was the only way forward, after a string of missed deadlines.

But analysts say such measures would alienate marginalised communities and spell disaster for the country. "A constitution achieved with only

minimum consensus will have no scope of success," said Lok Raj Baral, executive chairman of the Nepal Centre for Contemporary Studies. "Both sides need to realise that a

compromise formula is the only way out," Baral told AFP.

The prospect of instability has worried neighbouring India and China, with Indian Prime Minister Narendra Modi in November urging politicians to hammer out a charter based on consensus.

POLITICAL CRISIS IN THAILAND

Ousted PM slams impeachment vote

Ousted Thai premier Yingluck Shinawatra yesterday attacked impeachment proceedings against her ahead of a crunch vote that could see her banned from politics for five years and deepen the country's bitter divide.

Yingluck, the kingdom's first female premier and the sister of former leader Thaksin Shinawatra, was toppled from office by a controversial court ruling shortly before the army staged a coup in May.

She faces impeachment today by the junta-picked National Legislative Assembly over her administration's populist rice subsidy programme, which funnelled cash to her rural base but cost billions of dollars and inspired protests that felled her government.

Yingluck arrived at heavily policed Parliament House in central Bangkok accompanied by a handful of her party members.


"There is no position to remove me from as the Constitutional Court has already removed me as prime minister," she told assembly members, also saying she should not be impeached for violating a constitution that no longer exists under junta rule.

Yingluck robustly defended the rice scheme as an attempt to support Thailand's rural poor, who historically receive a disproportionately small slice of government cash.

"I am not corrupt, I was never careless," she said, rejecting accusations that had been levelled against her and urging members to consider her case with fairness and "without being guided by anyone".

But a junta spokesman rejected Yingluck's allegation that the impeachment process had no basis in law. "The process is

A successful impeachment needs three-fifths of the 220strong assembly to vote in favour when they meet today. A guilty verdict would bring an automatic five-year ban

from politics and risks enraging her family's 'Red Shirt' supporters, who have laid low since the coup. Speaking before the hearing yesterday, Jatuporn

Prompan, chairman of the Red Shirts, cautioned against street protests on his television show, after noting signs he believed would "lead to impeachment".

"From tomorrow, we will see more clearly... If we are not patient, Red Shirts will be accused of being responsible for bad things," he said on Peace TV.

Experts say the impeachment move is the latest attempt by Thailand's royalist elite and its army backers to nullify the political influence of the Shinawatras, whose parties have won every election since 2001.

Thailand's National Anti-Corruption Commission has led the probe into the rice programme, which paid farmers up to twice the market rate for their grain but left Thailand with a mountain of unsold rice.

CAMBODIA KHMER ROUGE ATROCITIES

'Soldiers slit prisoner throats, ate organs'

A witness told Cambodia's UNbacked court Wednesday that Khmer Rouge soldiers slit prisoners' throats and ate their gall bladders during the 1970s, as the genocide trial of the two most senior surviving leaders resumed.

Nuon Chea, 88, known as "Brother Number Two", and former head of state Khieu Samphan, 83, face charges over the killing of ethnic Vietnamese and Muslim minorities, forced

marriage and rape during the 1975-1979 regime that left up to two million people dead.

In August the pair were given life sentences for crimes against humanity after a two-year trial focused on the forced evacuation of Cambodians from Phnom Penh into rural labour camps and murders at one execution site.

The genocide trial, which began last July, has faced repeated delays due to boycotts by the defendants' lawyers and most recently because of the brief hospitalisation of Khieu Samphan.

The prosecution's first witness, Meas Sokha, told the court that he saw Khmer Rouge soldiers kill hundreds of



inmates at Kraing Ta Chan prison in Takeo province, around 80 kilometres south of Phnom Penh, where he was detained along with 11 other family members. "While I was tending cows

and buffaloes, I could see how prisoners were killed. Most of them had their throats slit,' said the 55-year-old. "Two would hold a pris-

oner tight and another would slit the throat of the prisoner," he said, adding that the Khmer Rouge played

music through a loudspeaker "to hide the sounds of the killing".

He told the court that at least 20 prisoners were killed per day after a week of starvation at the prison, where he was held for more than two years from 1976. His father and younger siblings also died at the jail.

The witness added that soldiers killed small children by throwing them against a tree before dropping their bodies into the mass grave at the prison. He also told the court that Khmer Rouge cadres would eat the gall bladders of executed prisoners after drying them in the sun.

Both Nuon Chea and Khieu Samphan deny all charges against them and are appealing their life convictions.
