UPDF activist shot dead in Khagrachhari

Santu Larma led faction of PCJSS blamed for the killing

An activist of United People's Democratic Front (UPDF) was shot dead by unidentified criminals in Lafaidong area under Manikchhari upazila of the district yesterday.

The deceased was identified as Uchimong Marma, 20, son of Balachu Marma of Maradhulu village in the upazila.

Locals said an unknown gang opened fire on the UPDF activist, leaving him

dead on the spot.

UPDF blamed Santu Larma led faction of Parbatya Chattagram Jana Sanghati Samity (PCJSS) for the killing.

In press release, UPDF district coordinator Pradipan Khisha said the armed cadres of Santu Larma led PCJSS opened fire on Uchimong and two other party activists on their arrival in Lafaidong area at around 9:00am to carry out organisational activities.

Two housewives killed over dowry in 2 districts

Two housewives were killed allegedly by their husbands and in-laws for dowry in Sirajganj and Laxmipur districts on Sunday.

In Sirajganj, a woman was strangled for dowry in Tarash upazila of the district, reports our Pabna correspondent.

The deceased is Ayesha Khatun, 20, wife of Shariful Islam of Binshara village.

Police and locals said Ayesha married Shariful last year. After their marriage, Shariful and his family members often tortured Ayesha for Tk one lakh as dowry.

Following an altercation over the issue on Sunday night, Ayesha's husband and in-laws strangled her and then hanged the body from the ceiling of her room.

On information, police rushed to the spot, recovered the body and sent it to Sirajganj

General Hospital morgue for autopsy. The deceased's father filed a case against Shariful and his parents, said Md Ataur Rahman,

officer-in-charge of Tarash Police Station. Police arrested Ayesha mother-in-law

Farida Begum, said the OC, adding that Shariful went into hiding after the incident.

Away in Laxmipur, a pregnant woman was beaten to death allegedly by her husband and in-laws for dowry at Charmonsha under Sadar upazila the same night, reports our correspondent.

The deceased is Poly Begum, wife of Sumon Hossain, a resident of the area.

Poly married Sumon a few years ago. After their marriage, Sumon and his family members used to torture Poly for dowry, said her brother Monir Hossain.

Suman locked in an altercation with Poly over the dowry issue in the afternoon. At one stage, he and his family members beat up Poly, leaving her dead on the spot.

On information, police rushed to the spot, recovered the body and sent it to a

hospital morgue for autopsy. The body bore several injury marks, said Rubel Hossain, sub-inspector of Sadar Police Station. Sumon and his family members went into hiding after the incident, said the SI.

8 Shibir men held on abduction charge in Bogra

Detectives arrested eight Shibir men in Jamilnagar area of the district town on Sunday on charge of abducting a young man.

The victim was identified as Abdul Halim, 35, son of late Hafizur Rahman of Kochimbazar area in Sundarganj upazila of Gaibandha district. The arrestees are Abu

Zafar, 19, son of Abdur Rashid of Daulatpur village and Nurunnabi Mia, 20, son of Abdul Motin Fakir of Kallayanpur village in Sirajganj district; Nurunnabi Ali, 20, son of Akbar Ali of Nandigram upazila, Abu Hasan, 24, son of Zillur Rahman of Krishnapur village, and Al Amin Mia, 25, son of Ashraful Islam of Gangnagar area in Shibganj upazila, Ariful Islam, 21, son of Badruzzaman Ahmed of vehicle. Phulbari upazila in Bogra district; Shafiqul Islam, 19, up the seven Shibir activists Raninagar upazila in later shown arrested on Noagaon district, and Al charge of kidnapping the Amin Sarkar, 19, son of man.

Police said a group of Shibir men abducted Halim for Tk 5 lakh ransom in the morning and confined him to a mess in Jamilnagar area. Later, the victim tactfully informed the law enforcers through SMS on mobile phone about his abduction.

Being informed, a team of DB police led by ASP Ariful Islam Mondol raided the area, rescued Halim and arrested Shibir activist Al Amin. They also seized 17 cellphones, two digital cameras, a computer, 12 books on jihad, 27 CDs and

Four brothers get life for murder

A Chapainawabganj court yesterday sentenced four brothers to life imprisonment for killing a man in Shibganj upazila in 2007.

The convicts are Lal Mohammad, 50, Bazlur Rahman, 45, Monirul Islam, 35, and Sharif, 30, of Chawkkirti village in the upazila.

The court also fined them TK 20,000 each, in default they are to suffer six months more in jail.

According to the prosecution, the four, son of late Entaj Ali, killed Amir Ali, 35, of the same village over a land dispute on March 29, 2007.

Saidur Rahman, brother of the victim, filed a murder case with Shibganj Police Station, accusing the four brothers on the following

After examining the prosecution witnesses and other relevant documents, District and Sessions Judge Kabita Khanam, pronounced the verdict.

A fire broke out at railway market on Shahid Shamsul Huque Road in Saidpur municipality in the district early yesterday. On information, firefighters rushed to the spot and doused the blaze after two hours of frantic effort. Robber succumbs to injuries

A robber, injured in mob beating in Zianagar upazila of Pirojpur on Saturday night, died at Khulna Medical College and Hospital (KMCH) on Sunday night. The dead is Siddique, 40, son of Mobarak Ali of Ranipur village in Betagi upazila of Barguna district. A gang of seven robbers swooped on the house of one Nasiruddin Hawlader at Togra village under Zianagar upazila at around 11:00pm on Saturday and looted eight tolas of gold ornaments and Tk 30,000, said police. Hearing screams of the family members, locals rushed to the spot and caught Siddique while others managed to flee. They beat him up mercilessly, leaving him critically injured. Police later rescued Siddique and sent him to KMCH where he died on Sunday night.



Savage treatment by quack costs his life

Victim of brutality in the name of treatment by a village doctor, a physically challenged boy died at Nilphamari 100-bed Hospital on Sunday.

The victim, Sakib, 13, son of Zikrul Islam, 40, of Boro Khamatpara village of Raminagar union under Nilphamari Sadar upazila, was a Class III student of Khamatpara Government Primary School.

"On Saturday morning, I took my son Sakib to the chamber of village doctor Moshiur Rahman, 45, at nearby Chaderhat market for treatment of his curved legs," the boy's father Zikrul Islam

"Moshiur said that Sakib

told this correspondent.

needed a kind of physiotherapy for cure. Around 11:00am, he came to our house, tied the two legs of Sakib tightly and put a bamboo stick under the legs. Then Moshiur, a weighty man, stood on the boy's legs and jumped there repeatedly," he said.

"As Sakib began to

scream, I proceeded to rescue him, but the village doctor rebuked and pushed me aside, saying that our ignorance was responsible for the bad condition of the boy," Sakib's mother Morium Begum, 35, said. "As the boy's condition

worsened, village doctor

Moshiur left the house, suggesting us to take him to hospital," she added.

Sakib's parents took him to Nilphamari 100-bed Hospital on Saturday noon and admitted him there in a critical condition.

Despite the doctors' serious efforts, the boy died around 11:00am yesterday.

"The boy died of encephalitis possibly caused by serious physical and mental shock leading to disturbance in the functioning of the brain," said Dr Enamul Huque, child specialist of the hospital. A case has been registered

with Nilphamari Sadar Police Station and investigation is on, said police.
