ACC for revival of Gatco case against Khaleda

The Anti-Corruption Commission yesterday prayed to the High Court for reviving the Gatco graft case against BNP Chairperson Khaleda Zia filed in 2007.

The anti-graft watchdog urged the court to initiate a hearing on a HC rule that had questioned the legality of filing the case under the Emergency Power Rules (EPR), 2007.

ACC lawyer Khurshid Alam Khan appealed to the HC bench of Justice Md Moinul Chowdhury and Justice JBM Hassan to include the matter in its today's cause-list for fixing a date for the hearing.

The move comes at a time when several lawmakers inside and outside of parliament are demanding legal steps be taken against Khaleda, describing her as the "mastermind" behind the ongoing 20-party block-

ade violence. The case was filed against the BNP chief, her son Arafat Rahman Koko,

Jamaat-e-Islami leader Matiur Rahman Nizami, and 21 others with Tejgaon Police Station on charges of corruption in awarding Global Agro Trade (Pvt) Co Ltd (Gatco) a contract for container management at inland container depots in Dhaka and Chittagong.

The graft caused the state exchequer a loss of over Tk 1,000 crore. Later, the case was brought under the

On September 30, 2007, the HC granted Khaleda bail in the case and issued a rule upon the government and ACC to explain why bringing the charges under the EPR should not be declared illegal. Following another petition, the

court on July 15, 2008 stayed the proceedings of the case against her and issued another rule upon the government and anti-graft watchdog to explain why the proceedings should not be quashed.

The ACC lawyer yesterday told The Daily Star that he was unaware of any reply to the rule.

Egypt's top Muslim cleric backs Brotherhood arrests

Egypt's top Islamic cleric yesterday backed the arrest of more than 500 supporters of the blacklisted Muslim Brotherhood following clashes over the weekend on the anniversary of the country's 2011 uprising.

"I am not sad for this outcome as such criminals ought to be prosecuted," Egypt's Grand Mufti Sheikh Shawky Allam told reporters in Singapore.

"I strongly condemn their actions as they are crimes that breach the laws of our country," said Sheikh Allam during a four-day visit to the Southeast Asian city-state at the invitation of the local Islamic Religious Council. "Those that have been arrested

will be prosecuted legally. The reason they have been arrested is not political because they have transgressed the law,

Egypt's Interior Minister Mohamed Ibrahim on Monday said Egyptian security forces had arrested 516 "elements" of the Muslim Brotherhood, who were "involved in firing ammunition, planting explosives and bombing some facilities".

> According to the existing policy, a borrower can have his loans rescheduled thrice for a maximum of eight years. To get the facility, he must make a down payment of 10 percent of the loan for the first time, 15 percent for the second time and 30 percent for the third time.

> He has to pay interest in line with market rate of 13-14 percent.

> The need for a new policy to restructure large loans came to the fore after Beximco Group appealed to the central bank for rescheduling its loans of Tk 5,269 crore.

> The conglomerate sought a lengthy duration to repay the loans, along with relaxed conditions and low interest rates.

Boston also imposed a travel ban, and subway systems in New York and Boston were suspended.

Heavy snow is still reported in Massachusetts, with reports of snow up to 25in deep in the town of Worcester. However, parts of eastern Pennsylvania and New Jersey have been spared extreme snow.

Despite the easing in conditions, the National Weather Service warned that the storm could still bring "crippling snowfall amounts and lifethreatening blizzard conditions to much of the north-east".

The NWS had previously warned that a "potentially historic blizzard" was approaching the north-east. But the blizzard appeared less

severe than expected on Tuesday morning, with snowfall levels ranging from 2.5cm (1in) in Washington DC to 38cm (15in) at New York State's Islip airport at 03:00 local time (08:00 GMT). Meteorologists expected the snow

and strong winds to continue throughout yesterday, before weakening overnight.

"In areas close to the immediate coastline... hurricane force wind gusts to near 120km/h (75mph) will be

possible," the NWS said. As the weather deteriorated, workers in New York left early and headed

for the safety of home, heeding warn-

ings from officials. The subway system has been shut down, for the first time because of snow.

Broadway shows were dark, the neon-lit avenues deserted. It gave a ghostly feel to a city that famously never sleeps. The storm's effects are being felt way

beyond Manhattan, from New Jersey to Maine. Coastal areas such as Cape Cod and Long Island could face flooding and power blackouts. Boston is also in its path.

The Governor of Massachusetts called it "a top five historic storm." New York Governor Andrew

Cuomo warned residents against violating the driving ban in 13 southern counties of the state. "If you are in your car and you are

on any road, town, village, city, it doesn't matter, after 11 o'clock [23:00 local time; 04:00 GMT], you will technically be committing a crime. "It could be a matter of life and

death so caution is required," the governor said. Echoing his words, New York City

Mayor Bill de Blasio urged residents to stay out of the way of the 2,300 snowploughs clearing city streets. "You can't underestimate this storm. What you are going to see in a

Liberia closes Ebola centre at epicentre of outbreak

Liberia's president on Monday announced the closure of an Ebola treatment facility which lay at the epicentre of the virus's worst outbreak in history, as the disease's spread has slowed in the country. Ellen Johnson Sirleaf warned

Liberians that while they could not yet afford to relax, the country had made significant progress in the fight against Ebola, and thanked states who helped Monrovia combat the "Lofa, the epicentre of the virus,

has had no new cases for over 70 days," she said in the speech at the national parliament. "The Ebola Treatment Unit in Foya

is closed," she said, referring to an area in the north of the country near its border with Guinea, where the virus hit Liberia for the first time. "Today we take pride that 13 of

15... counties have not reported new cases for 21 days," she said, referring to the virus's maximum incubation period.

stages of development of the helicopters The biggest challenge for those behind the plan is making a helicopter that can take off and land safely on the planet, where the atmosphere is vastly different from that on Earth.

While helicopters might seem to be

easier to fly on Mars, given the planet has

three-eighths of the gravity of Earth, it is actually much harder since the atmosphere is around 100 times less dense. Helicopter blades work using the density of the atmosphere -- so one

on Mars would have to spin much faster, or use bigger rotor blades. Nasa has been testing prototype machines in a big vacuum chamber, where scientists can change the atmospheric density so that it's like that on Mars. They have built scale models of the helicopters, which must

spin at around 2400 revolutions per

minute to be able to take off. The system is designed to fly for about two or three minutes per day. The rest of the time will be spent charging the helicopter using onboard solar panels, which will keep it warm as well as providing energy for the flights.
