#### Cow lifter beaten to death

A suspected thief was beaten to death at Pathshala intersection in Ishwardi upazila of the district on Monday. The deceased was identified as Mujibur Rahman, 35, son of Khabir Uddin of Raipur Khetupara village in Sujanagar upazila. Police and locals said a gang swooped on the house of one Montu Biswas in the area and tried to take away a cow. Hearing screams of the family members, locals rushed to the spot, chased the thieves and caught Mujibur while his cohorts managed to flee. The angry mob later beat him up mercilessly, leaving him critically injured. Mujibur succumbed to his injuries at Ishwardi Upazila Health Complex at night. The body was sent to Pabna Medical College Hospital morgue for autopsy, said Ashish Kumar, sub-inspector of Ishwardi Police Station.

### Worker killed in wall collapse

A construction worker was killed and two others were injured in a wall collapse in Pashchim Brahmandi area of the district town yesterday. The dead is Sabuj, 30, of Birpur area in the town. Witnesses said a portion of wall fell on a group of workers around 1:00pm when they were working at an under-construction building of one Nuruddin Mollah, leaving three of them injured. The injured were taken to Narsingdi General Hospital. Doctors referred Sabuj to Dhaka as his condition deteriorated. He died on the way to the capital, said Mofizur Rahman, subinspector of Narsingdi Sadar Police Station.

#### Housewife commits 'suicide'

A housewife allegedly committed suicide at Mohinikanti village in Jhikargachha upazila yesterday. The deceased was identified as Sumi Akhter, 20, wife of Sohrab Hossain. She was a first year honours student of Shaheed Mashiur Rahman Degree College in the area. Family sources said Sumi married Sohrab two years ago. After their marriage, Sohrab often tortured Sumi for dowry. She took her life by taking poison following an altercation with Sohrab over the issue in the morning, said the victim's father.

#### Youth murdered

A youth was killed over gabling at Raipur in Nalcity upazila on Sunday night. The deceased is Md Shaheen Khan, 30, son of Manan Khan of Jagua area in Barisal Sadar upazila. Police said Shaheen and one of his associates went to one Majid Khan's house for gambling in the area at night. Following an altercation over a trivial matter, other gamblers beat up Shaheen, leaving him critically injured. Shaheen, however, managed to flee the scene and took shelter at a nearby house where he succumbed to his injuries. The law enforcers recovered his body from the spot the following morning and sent it to Jhalakathi Sadar Hospital morgue for autopsy, said Md Maksud, officer-incharge of Nalcity Police Station.

### Arrest warrant against cop
