France is divided over the case of an eight-year-old boy who was questioned by police for saying: "I am not Charlie. I am with the terrorists." A moderate Islamic association said that the interrogation of Ahmed and his father was proof of a "collective hysteria" since 17 people died in terrorist attacks in Paris three weeks ago.

The education minister Najat Vallaud-Belkacem said the boy's school had reacted "entirely correctly" by drawing his behaviour to the attention of education authorities and the police. She said that there was no question of legal action against the child but that a complaint had been made against his father for an allegedly "brutal" attitude towards school staff.

Arguments for and against the questioning of Ahmed became the hottest subject on French social media for most of the day. The boy and his father were ordered to go to a police station in Nice on Wednesday. On 8 January, the day after the attack on Charlie Hebdo, Ahmed refused to take part in a nationwide two-minute silence.

He was reported to have said in class and then again in the playground: "I am not Charlie. I am with the terrorists. The Muslims were quite right.

The door was shut, but not locked from inside. They found the body and saw the almirah was open around 10:15am. Clothes were lying scattered on the floor.

Rezwan-ul-Alam, elder brother of Fahmida, told this correspondent that her sister used to live in one flat and rented out another. She owned both the flats on the floor. Her husband Golam Rabbani works at a private firm in Bahrain, Siratul Mostagin, 20, the couple's only son, is staying in the United States for study.

"My sister had no enemy," Alam added. He filed a murder case with Rampura Police Station against unknown persons.

Fahmida would seldom go out of the house. She didn't open the door to strangers, said residents of the building.

Mahbubur Rahman Tarafder, officer-in-charge of Rampura Police Station, said they detained Sabiha and Rouf for interrogation.

The motive behind the murder could not be ascertained immediately but police suspected that the murder might have taken place sometime on Thursday. An investigation into the incident was underway in this regard, police said.

The security guard told reporters that he didn't see any stranger entering the house on Thursday night while Sabiha said she last worked at Fahmida's house on Wednesday

Top Thai cops jailed in corruption case that toppled princess

Two senior Thai police officers allegedly at the centre of corruption network whose exposure led to the downfall of a senior Thai princess were jailed yesterday under Thailand's controversial lese majeste law.

Pongpat Chayapun, the former head of Thailand's elite Central Investigation Bureau, and his exdeputy Kowit Vongrongrot were arrested in November alongside a string of top brass in a corruption probe that went on to implicate relatives of Princess Srirasmi, then the Crown Prince's wife. She later renounced her royal title

and was divorced by Crown Prince Maha Vajiralongkorn in a dramatic and opaque moment of palace intrigue that shocked Thailand's elite at a time of heightened anxiety over the health of the country's revered but ailing monarch.

Both officers were sentenced to six years in jail yesterday after admitting lese majeste under sec- an unnamed royal in their allegedly tion 112 of Thailand's criminal code and for corruption, a court

official said. "He (Pongpat) pleaded guilty to charges, including insulting the monarchy, and the judge sentenced him to

five years plus twelve months in jail,' an official at Bangkok Criminal Court, who asked not to be named, told AFP.

"That sentence was commuted from 12 years because he confessed to the judges," the official added.

A second official said Kowit had also been handed a six year sentence. Under the royal defamation law --

one of the world's strictest -- anyone convicted of insulting the king, queen, heir or regent faces up to 15 years in prison on each count. At least 17 people were arrested

during the investigation of the corrupt group, who were accused of amassing illicit fortunes through corrupt patronage networks as well as gambling and oil rackets. The Thai authorities have yet to give

full explanation of how those charged in the corruption network defamed the monarchy. At the time of their arrest, police

said Pongpat and his group had made "false claims" to be acting on behalf of corrupt dealings. But senior police officers charged

with investigating the circle hinted that they were unable to elaborate any further because doing so could in itself breach lese majeste laws.

The current duration record was set in 1978 when Ben Abruzzo, Maxie Anderson and Larry Newman made the first transatlantic balloon flight at a total time of 137 hours, five minutes and 50 seconds.

The Two Eagles team will need to stay in the air for around 138 hours and 45 minutes to beat it.

"We're not taking any time to celebrate," said Steve Shope, head of mission control. "We have a lot of work to do and we're just taking this flight one hour at a time." The pilots are flying in a hi-tech

balloon fitted with an array of monitors and other instruments designed to keep track of their course and accurately compile their flight data to be submitted to record-keepers. Their capsule sits beneath a massive, helium-filled envelope and a

specially-designed carbon fibercomposite capsule, which is built especially to be able to stay aloft for 10 days. Despite their goal of beating the

current distance and endurance records, the next real challenge for the Two Eagles team will be a safe landing; as there is no certainty about their final destination.

The militant group, which emerged after the 2011 Egyptian revolution, later claimed responsibility, saying on Twitter that two suicide bombers and three car bombs struck an army base and adjacent security building in el-Arish -- the deadliest of all attacks.

Meanwhile, Egypt's army clashed with jihadists in Sinai yesterday, leaving two children dead. Two more people including a 12-year-old were badly wounded by gunfire.

The most active group, Ansar Bayt al-Maqdis, changed its name to Sinai Province last year when it swore allegiance to Islamic State, the hardline Sunni militant group that has seized swathes of Iraq and Syria, drawing USled air strikes, reports Reuters.

A daily news broadcast released via Islamic State Twitter feeds said Thursday's attacks had been led by "men of the Islamic State".

Soldiers and police are often targeted at outposts outside Sinai's main towns, but the attack on military facilities in al-Arish could signal an escalation in their capabilities, said Zack Gold of the Institute for National Security Studies in Tel Aviv.

Thai military ramps up 'attitude adjustment' for critics

A prominent leader of the opposition Red Shirt movement and a former minister yesterday became the latest critics of Thailand's junta forced to report to barracks for "attitude adjustment" as the military ramps up its campaign against dissent. Nattawut Saikuar, secretary-general

of the movement loyal to ousted premier Yingluck Shinawatra, and Pichai Naripthaphan, a former energy minister in her government, were both ordered to appear before the military after publicly criticising the regime. So-called "attitude adjustment" ses-

sions are used by the military to haul in those deemed to be uncooperative with Thailand's generals, who imposed martial law and took over in a coup last May.

At least five people -- three former ministers, a Red Shirt leader and Yingluck's lawyer -- have now been ordered to report this week.

Thailand's junta has moved swiftly to stamp out any renewed criticism of their rule following the retroactive impeachment of Yingluck last week and after a top US diplomat made critical comments on Monday that infuriated the generals. The military insist the summons are

simply invites -- though in reality any refusal to cooperate would likely lead to significant censure. "Please use the word invite,"

General Udomdej Sritabutr, army chief and a key junta leader told reporters at Government House. "We ask for their cooperation ... and

if they don't understand we will invite them again," he added. Earlier this week junta chief Prayut

Chan-O-Cha made it clear he would not tolerate those who spoke out against the regime, adding he would use punitive measures including banning critics from travelling abroad and having their assets investigated or seized.
