## Forkan killed man before raping his daughter

### Testifies victim's cousin at war crimes trial; in another trial martyr Abdur Rashid's son too points out Hasan Ali as the killer

Recounting the condition in which his newly-wed cousin was left by a riverbank after being raped and her father's murder, the fifth prosecution witness yesterday moved himself to tears, demanding he be served justice for the atrocities war crimes accused Forkan Mallik allegedly committed.

"We found her unconscious. She was totally devastated. I cannot

describe anymore," Selim Hawladar testified before the three-member International Crimes Tribunal-2.

Her husband of three months had to be coaxed with money coming from the sale of their land to refrain him from going for a separation. Although she recovered and afterwards had three sons and one

daughter, the man deserted her 15 to 16 years ago and remarried, he said.

He was involved with Awami League in 1970 and Forkan had campaigned for Muslim League.

"At about 2:30pm, I saw war crimes accused Forkan Mallik, (one) Akabbor Gazi, 10-12 Razakars and the Pakistani

(occupation) army coming towards our house," said the resident of Patuakhali's Kakrabunia village in the description of the Bhadra 5 (August 22) incident of 1971.

Selim immediately ran home to alert his family, but his uncle and cousin failed to escape and hid under a bed while he and his mother and sister hid nearby.

The attackers first looted valuables. "Akabbor and accused Forkan

## Cancer plaguing Bangladesh

*Bad food habits, smoking, adulterated food, environmental pollution blamed on World Cancer Day*

Cancer is becoming a plague in Bangladesh with nearly three lakh people being affected by the disease every year, said Bangladesh Cancer Society's President Dr Molla Obaidullah Baki.

While there are estimated 13 lakh cancer patients in the country, some two lakh of them die every year, he told The Daily Star yesterday, on the occasion of World Cancer Day.

"Bad food habits, smoking, adulterated food and environmental pollution are some of the common causes of cancer," he said.

The major reasons for breast and cervical cancers are early marriage, frequent childbirths and refraining from breastfeeding, and unhygienic practices during menstruation.

Men, on the other hand, mostly suffer from lung, oral and laryngeal cancers that are mostly caused by smoking and tobacco consumption, the oncologist added.

Prof Obaidullah said as per the World Health Organization, there should be at least one cancer treatment facility for each one million people.

"Considering this, Bangladesh should have at least 160 such facilities, but it has merely 20, both at government and private levels," he said.

At public sector, a patient needs two to three months to get a serial while at private sector the treatment cost is too high. Therefore, prevention should be the main focus for Bangladesh, he added.

Dr Habibullah Talukder, head of cancer epidemiology department at the National Institute of Cancer Research and Hospital, suggested that the authorities take initiatives for community-level screening of breast, cervical and oral cancers and each division should have at least one cancer hospital to help the poor patients.

Journalist and freedom fighter Haroon Habib was seen standing in the middle of the huge spacious ground searching for Suborno's stall in the afternoon.

"The book fair is one of the biggest events of Bangla Academy, which it has been organising for years now. It is expected that they should be more professional and efficient in the arrangements," he said, disappointed at the absence of a map or indicators.

"We expect to put up the map of the grounds by tomorrow," said Jalal Ahmed, member secretary of the book fair management committee.

As part of routine monitoring, Ahmed and his team yesterday cracked down on sales of pirated books and some stalls selling books of other publishers without authorisation.

"We asked them to inform their owners to meet us at the academy office tomorrow (Thursday) at 1:00pm and explain why they broke the fair rules. If they fail to provide satisfactory answers, we will take necessary action against them," said Ahmed, adding that they warned three stalls seriously violating fair rules.


