COURT CORRESPONDENT A Dhaka court yesterday ordered a further investigation of the death of silver screen actor Shahriar Chowdhury Imon popularly known as Salman Shah.

Metropolitan Magistrate Jahangir Hossain passed the order after Salman's mother Nilufar Chowdhury filed a noconfidence petition against the judicial probe conducted by a metropolitan magistrate.

The court asked Rapid Action Battalion to probe the case and submit a report by April 12.

On July 9 last year, Metropolitan Magistrate Imdadul Haque submitted the probe report which found no indication of murder, and reported that the actor had committed suicide at his Eskaton residence on September 6, 1996.

His father, Kamaruddin Chowdhury, had filed an unnatural death case which he later turned into a murder

WAR CRIMES TRIAL

Two more implicate Siraj in Bagerhat massacre of Hindus

Two more prosecution witnesses yesterday testified that war crimes accused Sheikh Sirajul Haque alias Siraj Master was involved in killing 500-600 Hindu villagers of Bagerhat on May 21, 1971.

One of them saw Siraj Master shoot and stab dead three residents of Dakra village.

The three-member tribunal led by Justice M Enayetur Rahim recorded the depositions of the 20th prosecution witness Rabindranath Adhikari and 21st witness Kalipado Mondal.

On Sunday, a survivor testified on the massacre.

The witnesses, both in their 70s, said they took shelter at Dakra Kali Mandir along with 5,000-6,000 villagers fleeing to India for life amid atrocities by the Razakar, an auxiliary force to the

Pakistani army. Around 1:30pm, they saw 40-50 Razakars coming towards them by two boats, they said. One boat stopped by Dakra School and another at Dakra Bazar.

The witnesses said the Razakars opened fire on the people taking refuge at the temple, indiscriminately.

Kalipado said he hid in a bush near Thakurbari. "From there I saw accused Siraj Master shoot Kumod Thakur, Rashik Thakur, and Shushil Thakur and knife them to death," he said.


Rabindranath said he heard from others that Siraj Master along with other Razakars hurt his father and brother. His father succumbed to injuries 10 days later while his brother recovered after treatment. "My

brother is still alive but cannot move like a normal person," he said. Both witnesses said they saw around 500-600 bodies lying in different parts of the

According to the demonstrators, they usually get paid per piece produced but the production time fluctuates depending on fabrics. So, if their salary does not increase, it will be difficult for them to survive.

The injured including workers from both the demonstrating and promanagement groups took first aid at a local hospital. Production resumed yesterday after a daylong shutdown.




