Clash over land dispute leaves 10 injured

At least 10 people were injured in a clash between two groups of villagers over capture of a disputed land at Shyampur union under Melandah upazila of the district yesterday morning.

Of the injured, two were admitted to Mymensingh Medical College Hospital while the rest to Melandah Upazila Health Complex and Jamalpur General Hospital.

Locals said there was a long-standing dispute between Nagor Ali of Balurchar village and Sadhu Molla of Kazaikata village over the ownership of a land in the union.

On Wednesday, Nagor Ali and his men transplanted Boro saplings on the disputed land.

At around 8:00am yesterday, Sadhu Molla and his supporters went to the field and uprooted the

saplings. Hearing the news, Nagor Ali and his men, equipped with lethal weapons, attacked Sadhu Molla and his supporters, leading to a clash between the groups.

At least 10 people from both sides were injured during the clash that continued for three hours, police said.

No case was filed with Melandah Police Station as of filing of this report at 5:30pm yesterday.

BSF returns bodies of 2 cattle traders

Indian Border Security Force (BSF) yesterday handed over the bodies of two Bangladeshi cattle traders to its Bangladesh counterpart.

Following a flag meeting held at Labutala frontier in Moheshpur upazila of the district at 7:30pm, BSF returned the bodies of Aminur Rahman, 35, son of Miraj Ali of Labutala village, and Khoyjul Hossain, 40, son of Shahadat Mondol of Jaluli village in the upazila.

Jahangir Hossain, commanding officer of BGB 26 Battalion in Jessore, led the BGB team at the flag meeting.

Earlier, doctors at Bongaon Hospital conducted post-mortem examinations on the two bodies.

The bodies were handed over to their respective families around 8:00pm.

Housewife killed for dowry in Jessore

A housewife was killed allegedly by her husband for dowry at Khatura village in Monirampur upazila on Wednesday night.

The deceased was identified as Sharmin Akhter, 19, wife of Asadul Islam of the village.

Family sources said Sharmin married Asadul two years ago.

After their marriage, Asadul and his family members often tortured Sharmin for dowry.

Following an altercation over the issue on the night, Asadul beat up Sharmin mercilessly, leaving her dead on the spot, said victim's mother Ayesha Begum.

On information, police rushed to the spot, recovered the body and sent it to Jessore Medical College Hospital morgue for autopsy.

Sharmin family filed a case with Monirampur Police station, accusing Asadul.

Asadul had gone into hiding soon after the incident, police said, adding that they are trying to arrest the accused.

Robbers injure 2

Two people were injured, one with bullet, in an attack by robbers under Banshkhali upazila early yesterday.

The injured are Julu Bala Das and Dilip Kanti Dey of Napora village.

Julu was first taken to Banshkhali Upazila Health Complex and then shifted to Chittagong Medical College Hospital, said police.

SI's body exhumed for fresh autopsy

Body of a police sub-inspector was exhumed yesterday after one and a half months of his suspected murder.

Police exhumed the body of Akram Hossain, 42, a sub-inspector (SI) of Special Branch of Police, also a resident of Hamdah village in the town, from the municipal graveyard around 11:00am in presence of Executive Magistrate Iqbal Hossain.

According to police, SI Akram got critically injured when he met a tragic road accident near Bardah village in Shailakupa upazila of the district around 11:00pm on December 28 last year.

Later, he succumbed to his injuries on January 13 this year, while undergoing treatment at Jhenidah Sadar Hospital.

Jannat Ara Parvin, elder sister of the deceased, filed a murder case with Jhenidah Judicial Magistrate's Court on January 20 accusing Akram's widow Banani Parvin and her friend Moon Hossain, a local trader.

She also appealed to the court praying for fresh probe into the incident. The court granted the prayer and ordered to exhumation the body.

Meanwhilw our Bogra correspondent adds: A mason was hacked to death in Dehor area under Kahaloo upazila yesterday. The deceased was identified as Bipul Mia, 21, son of late Mokbul Hossain of Dehor village. Police and family sources said Bipul went out of house on Wednesday night and remained missing since then. Locals found his body in the in a pddy field yesterday morning and informed the police. The law enforcer then went to the spot, recovered the body and sent it to Shaheed Ziaur Rahman Medical College Hospital morgue for autopsy.
