Nigeria president vows no further polls delays

AFP, Abuja

Nigerian President on Friday on Friday promised there would be no further vote delays, after the electoral agency pushed back the presidential and parliamentary polls by six weeks to May.

"We will surely conduct elections as scheduled. We promise you. Communicate this to your homes that elections will be conducted as scheduled and on 29th of May, there will be an inauguration of a president of this

country," he told the foreign envoys. The electoral agency INEC had on Saturday postponed the presidential and parliamentary elections earlier scheduled for February 14 to March 28, citing insurgency problems especially in northeast of the country.

The Independent National Electoral Commission (INEC) also shifted state governorship and assembly elections from February 28 to April 11.

The United Nations and the European Union have led a chorus of disapproval over the poll shift.

Jonathan said that the six-week extension would give the security agencies time "to clean up" the three states -Borno, Yobe and Adamawa -- that are mostly affected by an insurgency by Islamist Boko Haram militants.

normal will, Facebook will honour that choice. It is an attempt to walk the line

between protecting the privacy of the people who own profiles, and allowing grieving friends and families to access the site, as the Wall Street Journal notes. That is a balance that many other internet companies have to tread as they decide how to deal with the accounts and data of those users that have died.

Google introduced a similar system of "digital heirs" in 2013, allowing users to decide what will happen with users' data after they pass away or become inactive for some time.

"We hope that this new feature will enable you to plan your digital afterlife-in a way that protects your privacy and security — and make life easier for your loved ones after you're gone," wrote Google product manager Andreas Tuerk in a blog post at the time.

Rare ray of hope in UN climate talks

The detente achieved at UN talks that concluded Friday with a framework for a world climate pact is only temporary, achieved by kicking the difficult decisions down the road, parties and observers say.

But it also generated a degree of optimism rarely observed in the tense process -- a sense of common purpose which many hope will bolster negotiators in the months to come.

"I think this has been a very important meeting from a process point of view and a psychological point of view," said Union of Concerned Scientists analyst Alden Meyer.

He pointed to broad consultations held with country representatives by the talks' joint chairmen ahead of the six-day session in Geneva -- one of four official meetings this year to prepare for the December conference in Paris that must adopt a universal climate pact. "That has paid off. People felt con-

sulted, they felt listened to, they understood the process," he added.

"This is the parties' text, they own it sented.

An official framework text prepared for the 2009 Copenhagen climate conference, which failed to produce an agreement, had exceeded 300 pages and was challenged by a number of alternative drafts.

The 86-page Geneva blueprint, the product of years of negotiations, seems manageable by comparison, and represents the first-ever proposal with buy-in from all the world's nations. "At this early stage, the palpable

positive spirit coming out of Geneva is a much better measure of progress than the current length of the negotiating text," said Jennifer Morgan, climate director at the World Resources Institute think-tank.

The document lists a variety of alternative approaches on most issues often reflecting country positions that diametrically oppose one another.

It more than doubled from a 37page draft compiled at a conference in Lima last December, with parties allowed to add items until they were satisfied all their views were repre-

Questionable indemnity

On expiry of the original two-year tenure, parliament in 2012 amended it and extended its tenure by two years which too expired in October 2014.

The House passed a bill on January 27 extending the lifespan of the law for another four years with the controversial provision.

This law protected the government while it took up dozens of rental power projects now meeting more than a quarter of the country's demand. Initially this law was used for awarding contracts to really interested investors. But later on it was used to give companies, which neither had the experience nor genuine interest, the job to build rental power plants.

For instance, the-then Awami League parliamentarian Aslamul Haque got two power projects in 2011 to be implemented in Dhaka. None of them saw the light of day.

Then different authorities started misusing the power to cover their inefficiencies in contract negotiations. For instance, the Petrobangla's 2010 move to building a Liquefied Natural Gas (LNG) terminal through an open tender fell flat due to flawed negotiation. This fast-track project ultimately was placed under this controversial act and approved earlier this month, five years behind schedule.

Similarly, the Petrobangla floated a seventh amendment act too. tender to drill 10 wells in various national gas fields of the country. After some poor handling of tenders, it opted for a deal with Russian company Gazprom and placed the deal with a \$200 million price tag under this law arguing that the wells needed to be drilled by late 2014 to increase gas supply.

producer, Gazprom's actions were following torture during the slow and unimpressive and the gas Operation Clean Heart carried out to supply it achieved was half the target. Petrobangla is now asking whether it was worth spending \$200 million to get the paltry quantity of gas.

In Anwar Hossain Chowdhury versus Bangladesh, the apex court in 1988 said the power of judicial review was a basic feature of the constitution and it could not be taken away or curtailed even by the amendment of the constitution.

After more than two decades, the Supreme Court in a verdict declaring the constitution's fifth amendment illegal and void observed that the power to declare any provision seeking to limit the jurisdiction of the court was ultra vires.

The constitution's fifth amendment passed by the second parliament had validated and ratified all actions done by the martial law regimes between August 15, 1975 and April 9, 1979.

The second martial law ruler Ershad had followed the same suit to indemnify himself and all his actions. The parliament dominated by his Jatiya Party in 1986 passed the constitution's seventh amendment act. It had also the same provision to oust the court's jurisdiction.

French ambassador to Denmark Francois Zimeray, who had been present at the debate but was not hurt, told AFP the shooting was an attempt to replicate the Charlie Hebdo killings in Paris.

"They shot from the outside (and) had the same intention as Charlie Hebdo, only they didn't manage to get in," he said by telephone from the venue.

"Intuitively I would say there were at least 50 gunshots, and the police here are saying 200," he told AFP.

"Bullets went through the doors and everyone threw themselves to the floor. A statement by Danish police said "an unidentified man died after

having been hit by bullets" in the strike, and three officers were wounded in the shooting. Police also said the Volkswagen Polo, by which the two suspected assailants fled the scene, was found

abandoned around two hours after

the attack.

Specialists commenting on the attack in initial media reports said it was likely automatic rifles were used in the strike in order to fire as many rounds in a short period of time.

The assault comes at a time of heightened security and rising fears of Islamist attacks, following January 7 and 9 incidents in Paris that left 17 people dead. A series of anti-terror sweeps have

been carried out across Europe since mid-January, resulting in the arrests of dozens of suspected jihadist and seizures of large stocks of weapons and explosives. Those included January 17 raids in Belgium that thwarted what police

called imminent "terrorist attacks to kill police officers on public roads and in police stations." Two suspects were killed fighting

Belgian police in those sweeps.

Charlie Hebdo raised the ire of Islamist extremists by republishing cartoons by Vilks and other caricatures, and periodically satirising Islam on its own in later editions.

Vilks has been under police protection since his earlier controversial cartoons were published.

Concern of renewed attacks targeting symbols of press liberties and freedom of expression have been growing since the Charlie Hebdo strike, Reporters Without Borders secretary general Christophe Deloire told AFP after the Copenhagen assault.

"It's something that we feared after Charlie Hebdo. We see that ultraradical groups are leading a war against freedom of expression, against the freedom to be irreverent about religion and against the simple freedom to debate them," Deloire said.

Greece has begun tough negotiations with its creditors as hopes rise that a make-or-break meeting next week could reach a deal on the new government's demands to overhaul its huge international bailout. The technical talks in Brussels

Friday came a day after Greece's antiausterity Prime Minister Alexis Tsipras laid out his plans to sceptical counterparts including German Chancellor Angela Merkel at his first European summit. World stocks and the euro both rose

Friday amid growing optimism that debt-stricken Athens could now thrash out a compromise with finance ministers from the 19-country eurozone at a

critical meeting on Monday. But the clock is ticking as the 240-

billion-euro (\$270-billion) EU-IMF bailout is due to expire at the end of February, and failure to reach a replacement agreement could trigger a Greek default and a chaotic exit from the Eurogroup chief Jeroen

Dijsselbloem said Friday he was "pessimistic" about any quick deal with Greece, labouring under a mountain of debt equivalent to 175 percent of its annual economic output. "The Greeks have sky-high ambi-

tions. The possibilities, given the state of the Greek economy, are limited," said Dijsselbloem, who is also Dutch finance minister. "I don't know if we'll get there by Monday," he added.

Businesses and jobs were the principle sources of income for almost 40 percent of households nationally but the prevalence of salaried income was generally much lower in the food insecure agro-ecological zones like coastal belt, eastern hills, haor, padma chars and northern chars, the study finds.

Twenty-four percent women aged between 14-49 years were earning in 2013 and one-fifth of the households studied received remittance. The people of Chittagong, Sylhet and Dhaka divisions received higher remittances than those of Rajshahi and Rangpur, it said.

"It is encouraging that some indicators of food security are improving ... We can use the report to make new plans to make Bangladesh free from poverty," said State Minister for Finance MA Mannan.

Ninety-six percent households across the country had sanitation mentioned.

facilities in 2013, the report adds.

A total of 22,896 households in 954 communities across the country were surveyed under the project. Of the samples, 19,013 women aged between 19-49 years and 4,263 girls between 10-18 years were interviewed.

Additionally, 12,000 children's weights were measured and 9,984 caregivers were interviewed.

Of the respondents, 59 percent women consumed inadequately diverse diets. The situation is worst in Khulna, Rajshahi and Rangpur, the survey said. In 2013, too many girls had chil-
