

Potters pass hard days as blockade hinders sale

The non-stop countrywide blockade and frequent hartals enforced by BNP-led 20-party alliance brings added sufferings to the potter community, already hard-pressed due to decline in the demand of earthenware.

"Usually this time of the year sees good sale of earthen materials but now the sale of our products has drastically fallen as wholesalers can hardly come to us due to countrywide transport problem for over a month," said Gobindo Paal, 70, of Paalpara at Mulgram village under Pirojpur Sadar upazila.

"In late 2013 and early 2014, we faced similar problems due to political unrest," said Gourango Paal, 64, another potter of the area.

Sale of earthenware sees gradual decline due to popular use of plastic, silver, and iron made household articles as well as electronic devices, said potters, adding that the ongoing blockade and hartal has added to their sufferings.

Tk 1.8cr Indian medicines seized

Members of Border Guard Bangladesh (BGB) seized Indian contraband medicines worth Tk 1.80 crore at Katakali Bazar in Sadar upazila early yesterday.

Tipped off, a team of BCB-6 Battalion halted a Dhaka-bound truck coming from

Benapole at Katakali Bazar around 5:00am and seized the medicines from the vehicle, said SM Moniruzzaman, director of the battalion.

The trucker and his helper managed to flee the scene, sensing the presence of the border guards.

The seized medicines were later handed over to BGB Chuadanga sector headquarters.

4 hurt in blasts while defusing bombs

Three army men and a police constable were injured in blasts while defusing two bombs at Jessore Sadar Police Station yesterday.

The injured army men are Babar Ali, 42, Korban Ali, 32' and Tarek Mia, 30, of Jessore Cantonment, and constable Jafar Ali, 43, of Sadar Police station.

Officer-in-charge (OC) Enamul Haque of the police station said the bombs went off when a bomb disposal unit was defusing those.

The injured were admitted to Jessore CMH, the OC added.

Two held with pistol, bullets

Two people were arrested with a pistol and 26 bullets in Panchbibi upazila of Joypurhat early yesterday.

The arrestees are Mehbub Rahman 39, son of Khoibar Rahman of Phuldighi village, and Rakibul Islam, 36, son Rafiqul Islam of Sutrapur village under Bogra Sadar upazila.

Members of Joypurhat Rab-5 challenged the duo in Bagiana village on Panchbibi-Hili Road and seized the pistols and bullets from them.

Major Abdur Rahim, commander of Rab-5, said the two were wanted in several cases filed with different police stations of Joypurhat district.

Over 500 families related with the pottery at Mulgram village are passing days amid anxiety as wholesalers from different areas like Khulna, Jessore, Bagerhat and other places dare not come to the area due to countrywide

political unrest.

Visiting Mulgram last week, this correspondent found men and women busy in making their products including earthen jars, cake making dices, cooking pots, lids and toys.

"We have continued making our goods but the sale has fallen due to lack of buyers. Now it is difficult to earn Tk 100 a day from this profession," said Shankar Paal, 35, of Paalpara at Mulgram.

8 robbers held, trawler seized in Dhaleshwari

Police arrested eight robbers and seized a trawler from the Dhaleshwari River in Sadar upazila of the district yesterday.

The arrestees are Rafiqul Islam, Rubel, Dulal Mia, Alauddin Mia, Jahirul Islam, Nobin Hossain, Harun Mia and Ohidul Islam. They all are from Charhogla village

under Sonargaon upazila of Narayanganj.

Police said a gang of robbers on board a trawler swooped on a Khulna-bound clinker-laden cargo ship from Narayanganj near Haatlakkhiganj at around 9:00am and took away Tk 28 thousand from Mostafizur Rahman, master of the vessel.

As Mostafizur informed the river police of the inci-

dent over mobile phone, a police team chased the robbers and caught eight of them.

The law enforcers seized the trawler and recovered Tk 8,000 from their possession. The other members of the gang managed to flee with the rest of the looted money, said Sub-Inspector Mosharraf Hossain of Muktarpur river police outpost.

Ensure land rights, withdraw false cases

Madhupur indigenous people demand at human chain, rally

Indigenous people in Madhupur upazila under the district yesterday formed a human chain, held a rally and submitted memorandum to the prime minister demanding proper steps for ensuring legal ownership of their land and withdrawal of 'false' cases against them.

The indigenous people organised the hour-long programme from 11:00am to 12:00pm on Tangail-Mymensingh Road at Jalchhatra Bazar in association with Manusher Jonno Foundation, Enhancement of Indigenous Peoples' Land Rights and Community Based Advocacy and Networking Committee.

After the programme, they submitted a memorandum to the prime minister

through Muktadir Aziz, upazila nirbahi officer of Madhupur, demanding the realisation of their nine-point demands, local indigenous leaders said.

The demands include demarcation of the indigenous villages through survey by forming three teams comprising representatives from the land ministry, forest department and social organisations dealing with indigenous people, ensuring traditional land rights of the indigenous people, giving them the opportunity to maintain forests and natural resources, cancellation of the gazette notification of 1984, withdrawal of a total of 1098 false cases filed by the forest department against 184 indigenous families in the upazila and

establishment of a cultural academy for preservation and development of the local indigenous people's history, culture and tradition.

Eugene Nokrek, president of Joinshahi Adivasi Unnoyon Parishad, William Dazel, president of Tribal Welfare Association, Maloty Nokrek, president of Achik Michik Society, Sulekha Mrong, its secretary, Koch community leader Gouranga Bormon, Jostina Nokrek, former vice-chairman of Madhupur upazila parishad, Shree Kumar Guha, upazila unit president of Sachetan Nagorik Committee, and Golam Kibria, upazila unit president of Manobadhikar Bastobayon Parishad, addressed the rally, among others.

Mother, son found dead in Sherpur

A young woman and her minor son were found dead at Kalakanda village in Shribordi upazila yesterday.

The deceased are Surjomoni Aktar, 21, wife of Biplob Hossain, and her two-year-old son Simanta of the village.

Police said Biplob's younger brother Shamim spotted the body in the afternoon and cried for help.

Informed by the locals, police rushed to the spot and found Surjomoni's hanging body and Simanta's throat-slitted body lying in a pool of blood on the floor.

Md Shahjahan Mian, assistant superintendent of police in Sherpur, said they are trying to unearth the reason behind the killing.

They might have been killed over family feud, added the ASP.

Man gets life for killing stepmother

A Chapainawabganj court yesterday sentenced a man to life imprisonment for killing his stepmother.

The convict is Suruj Ali, 22, of Laxmipur-Jamadarpara village in Sadar upazila of the district. The court also fined him Tk 20,000, in default, he is to suffer six months more in jail.

According to the prosecution, Suruj Ali beat up his stepmother Joly Begum mercilessly over a family feud on May 27, 2013. She died instantly.

Victim's daughter Sahida Akhter filed a case against Suruj with Sadar Police Station the same day.

After investigation, Sub-Inspector Dulal Uddin, also the investigation officer of the case, pressed charges against Suruj on July 31, 2013.

After examining witnesses and other relevant documents, District and Sessions Judge Kobita Khanam delivered the verdict in the case.

2,500 trees illegally axed, sold by ex-UP chairman

Around 2,500 trees on both sides of a canal in Askerpur union of Dinajpur Sadar upazila have been felled and sold off in a week.

People of Nimaikhari village in the union filed a complaint with the assistant commissioner of land (AC land) on Thursday, stating that Mosharraf Hossain, former chairman of

Askerpur Union Parishad (UP), illegally felled and sold off the trees.

The villagers claimed that they planted the trees on both sides of the canal 12 years ago. Former UP chairman Mosharraf Hossain felled the trees and sold them for Tk10 lakh, they alleged.

They demanded proper investigation into the matter and legal action against the ex-UP chairman. The

felled trees include fruit-bearing ones, eucalyptus and acacia.

Md Ehtesham Reza, assistant commissioner of land of Sadar upazila, said legal action will be taken against the person responsible for felling the trees after proper investigation.

Contacted, Mosharraf Hossain said he leased the land from the authorities concerned 15 years ago and planted the trees there.



Clashes leave two dead in Bagerhat, Magura

Two people were killed and five other injured as rival groups of villagers clashed in Bagerhat and Magura districts on Saturday night.

Our Bagerhat correspondent reported that two groups of villagers locked in a clash following an altercation between two youths--Muhid and Khalid--of Mollarkul village in Mollahat upazila over playing badminton in the morning.

Murad's father Hafizur and his men attacked the house of Farid Khaki, father of Khalid, while he was holding a meeting with his supporters at around 9:00pm.

Both sides, equipped with lethal weapons, swooped on each other. At one stage, Hafizur opened

fire from his licensed gun, leaving a youth dead on the spot.

The deceased was identified as Rubel Kazi, 26, son of Layek Kazi of the village. Police recovered the body and sent it to Bagerhat Sadar Hospital for autopsy.

In Magura, a youth was killed and five others were injured in clash between two groups of people in Mohammadpur upazila on Saturday night, reports our Kushtia correspondent.

The deceased was identified as Azad Sheikh, 35, son of Majed Sheikh of Palla village in the upazila.

Police said two groups of youths from Bhatra and Palla villages locked in an altercation over a trivial matter during the annual sports and cultural programme of Nagripara Dakihil Madrasa at the

upazila headquarters.

As a sequel to that, some youths of Bhatra village beat up 4/5 youths of Palla village while they were returning home from the Madrasa playground at around 8:30pm.

Hearing the news, people of Palla village launched an attack on Bhatra village, prompting the people of the village to retaliate.

At least six people from both sides were injured during the clash. Of them, Azad of Palla village succumbed to his injuries at Mohammadpur Upazila Health Complex at around 9:30pm.

The rest of the injured are undergoing treatment at different hospitals and clinics in Magura town.

Both sides filed separate cases with Mohammadpur Police Station.
