

2 injured in Ctg cocktail blast

3 cocktails, 2 petrol bombs recovered in Rangpur

Two people were injured in a cocktail blast in Khulshi area of Chittagong city yesterday.


Meanwhile, police recovered three cocktails and two petrol bombs from a drain in front of the office of Bangladesh Betar in Dhap-Sagarpara area of Rangpur.

In Chittagong, a cocktail blast at a brick and sand shop, Jamal Enterprise, left Shah Alam Manu, 20, and Manir Hossain, 35, injured. Both are receiving treatment at Chittagong Medical College Hospital, according to our Chittagong correspondent.

Police said they are investigating the incident but have no lead so far.

According to our Rangpur correspondent, city corporation employees found the bombs while cleaning the drain in the city.

Md Abdul Qader Jilani, officer-in-charge of Rangpur Kotwali Police Station, said they have defused the bombs.

## NBR yet to realise green tax from polluting industries

UNB, Dhaka

Although seven months of the current fiscal year have already passed, the National Board of Revenue (NBR) has not yet taken any effective step to realise one percent surcharge or green tax from industries and factories polluting the environment.

The system of paying "green tax" was supposed to come into effect from July 1, 2014 as the government introduced the tax in the budget for the current fiscal year. As per law, companies polluting the environment have to pay one percent surcharge on the cost price of their goods.

The VAT wing was to collect the one percent surcharge under the "Environment Protection Surcharge Collection Rules 2014". The amount of surcharge would be non-tax revenue that the government will spend on protection of the environment.

The government has decided to impose the one percent "Environment Protection Surcharge" or "green tax" on ad valorem basis on all kinds of products manufactured in Bangladesh by the industries which pollute the environment, Finance Minister AMA Muhith said in his budget speech.

A total of 760 industries in Dhaka, Chittagong and Khulna have been short-listed, from 2,500 selected earlier, to be penalised with green tax for polluting the

## Mola in ponds may double fish production

Says WorldFish Centre study

Fish production can be made almost double in ponds by introducing mola fish with other carp fishes, shows a research of WorldFish Centre in Dhaka.

"Before our intervention, three tonnes of fishes were produced in a one-hectare pond, now fish production has increased to over 5.5 tonnes, of which one tonne is mola fish," Dr Benoy Kumar Barman, senior scientist of WorldFish Bangladesh and South Asia, told the news agency.

Revealing their research findings, he said production of carp fishes have increased after introduction of mola in ponds.

About the economic value of mola fish, the WorldFish scientist said, "One tonne of mola is equivalent to two tonnes of other fishes in terms of money."

In 2010, WorldFish Bangladesh with support from the International Fund for Agricultural Development launched a project on innovative fish production technologies in ponds and wetlands with small fish species.

The WorldFish survey shows that the contribution of small fishes, including mola, to total fish production was only 4.5 percent before the intervention of the project.

In 2011, the contribution was 15 percent and it was 31 percent in 2012 of

## Road crashes kill 6

Six people were killed and two others injured in road accidents in five districts yesterday.

Our Bogra correspondent reports, a truck hit four people on Bogra-Dhaka highway in Shajahanpur upazila, killing two of them and injuring the other.

The deceased were Abdul Aziz, 55, of Dhunat upazila; and Hawya Begum, 35, wife of Ashraf Ali of Shajahanpur upazila.

Anowara Bewya, 60, and Idrish Ali, 40, were taken to Shaheed Zaiur Rahman Medical College and Hospital.

Our Rangpur correspondent reports, a motorcyclist died instantly as a covered-van hit him at the city's Hajirhat in the afternoon.

The deceased was Md Faruk Hossain, 38, son of Md Alamgir Hossain of the city's

Uttam-Betarpara area.

Our Dinajpur correspondent reports, a biker was killed as his motorbike was hit by a battery-run three-wheeler on Joypurhat-Akkelpur road at Paikertoli village in Joypurhat.

The deceased was Md Firoz Hossain, 38, of Joypurhat Sadar upazila.

Our Lalmonirhat correspondent reports, a truck hit a man killing him instantly on Lalmonirhar-Burimari highway in Saptibari Majhar area of Aditmari upazila.

The victim was Abu Miah, 63, of Majhar village in the upazila.


Our Thakurgaon correspondent adds, Bayojid Shah, 8, son of Mozibar Rahman, was killed as a truck hit him while he was crossing Tentulia-Banglabandha highway at Ranchandi village in Tentulia upazila of Panchagarh.
