#### Nepal cops fire teargas at charter protesters AFP, Kathmandu

Nepalese police yesterday fired teargas and water cannon at thousands of opposition supporters who converged on the capital to protest controversial plans to vote on a disputed new national constitution. As anger mounts over the planned vote, protesters threw bricks and stones in brief clashes with security forces who responded with about 20 rounds of teargas, police and an AFP reporter on the scene said.

#### US boy, 3, shoots himself dead

A three-year-old Texas boy died after accidentally shooting himself in the head at home on Friday, US media said. The little boy, who was home in Houston with his mother and brother at the time, was rushed by helicopter to a hospital in critical condition but later died, said the NBC news station KPRC.

#### Drone raid kills three Qaeda men in Yemen AFP, Aden

A drone strike yesterday killed three Al-Qaeda militants in Yemen, a tribal source said, in a region where the United States is the only country operating the unmanned aircraft. The raid "targeted a vehicle in which three members of Al-Qaeda were riding in the village of Bijan, in Shabwa province," the source said.

#### Mexico nabs Knights Templar cartel leader AFP, Mexico City

Mexico's most wanted drug lord Servando Gomez, whose Knights Templar cartel smuggled drugs to the US and iron ore to China, was finally captured Friday, without a shot fired. The former teacher nicknamed "La Tuta" was detained by federal police as he left a house in Morelia, officials said.

### 1b at risk of hearing loss from loud music

More than one billion young people risk damaging their hearing through listening to loud music, the World Health Organization said on Friday. The WHO estimates that around half of those between the ages of 12 and 35 in middleand high-income countries are at risk due to unsafe levels of sound on personal audio devices.

# US sets 'bottom lines'

AFP, Washington

The United States on Friday set out what it called its "bottom lines" to reach a deal with Iran to rein in its nuclear program, ahead of new talks next week.

Washington had stuck to its guns that it wanted a "good deal" and had agreed to several extensions of the negotiations "because we have held firm to certain bottom lines," a senior US administration official said.

US Secretary of State John Kerry will leave at the weekend for Switzerland, where he will meet once again with his Iranian counterpart Mohammad Javad Zarif. The pace and intensity of the talks have

sped up as global powers gathered under the P5+1 group have been seeking a deal with Iran to stop it acquiring a nuclear weapon -something Tehran denies trying to do. A March 31 deadline for a political frame-

work for the deal is looming with negotiators saying they will aim to pin down the final technical details by June 30. While US officials cautioned that there

were no guarantees a deal would be reached, they said "the negotiations have advanced substantially, gaps have narrowed."

The officials were talking only days ahead of a controversial visit to Washington by Israeli Prime Minister Benjamin Netanyahu, who has vehemently opposed a nuclear deal with Iran.

Netanyahu is due to address the US Congress on Tuesday on why he believes the Iran deal is a bad move, despite opposition from the White House which sees it as interference ahead of Israel's elections later in March.

Sri Lanka yesterday began a three-day hearing on missing persons cases amid protests by Tamil groups who are demanding a credible investigation into such issues.

The presidential commission investigating cases of missing persons has started its hearing in the country's eastern Trincomalee province.

"The relatives of those who have forcibly disappeared are tired of going before various mechanisms set up by the government of Sri Lanka from time to time," Tamil Civil Society Forum said in a letter to the commission.

# India raises defence budget modestly

Moves to narrow military gap with China

India yesterday announced a modest 7.9 percent increase in defence spending for the fiscal year starting 01 April, suggesting that it will move only gradually with the military's long wish list for fighter jets, ships and artil-

After years of neglect, India is trying to narrow the military gap with China, which has been building up its fleet of ships and submarines making forays in the Indian Ocean.

Finance Minister Arun Jaitley, unveiling the federal budget for 2015/16, said defence spending will rise to 2.47 trillion Indian rupees (\$40.07 billion). For the current fiscal year, the allocation was 2.29 trillion rupees, a jump of 12 percent over the previous year.

"Defence of every inch of our land is above everything else," Jaitley said.

But the limited rise in the military budget three-quarters of which is spent on maintaining the world's third largest standing force - means only some new weapons will be ordered this year.

But economic ties have rapidly expanded between the two countries and Modi is expected to visit China later in 2015.
