## Indigenous people demand separate land commission

Indigenous people of the district formed a human chain and held a rally in the town yesterday to press their five-point demand, including formation of a separate land commission for them.

The gangs are grabbing their

cultivable lands, houses, ponds, graveyards, and cremation grounds in collusion with a section of unscrupulous land officials, they alleged.

They urged the government to form a separate land commission to protect their land rights.

The rally was addressed, among others, by Bichitra Tirki, president of the district unit of Jatiyo Adivasi Parishad, and its member Kornelius Murmu.


They later submitted a memorandum to the deputy commissioner.

#### 1,00,000 Yaba tablets seized

Members of Border Guard Bangladesh (BGB) in separate drives seized one lakh Yaba tablets from Teknaf upazila of the district yesterday. On secret information, the border guards raided a boat in Kaiukkhali Canal and seized 90,000 Yaba tablets at around 8:00am, said BGB-42 Battalion sources. However, the smugglers managed to flee the scene, sensing the presence of the BGB men. In another drive, the border guards arrested one Md Sirajullah, 28, a Myanmar national, along with 10,000 Yaba tablets in Hatcherkhal area of the upazila.

#### AL leader hurt in attack

A local Awami League leader and his associate were injured in an attack by criminals in Charparboti union of Companiganj upazila on Monday. The injured are Md Nurul Huda, 58, Muktijoddah affairs secretary of Charparboti union unit of AL, and his associate Md Belal Hossain, 40. Sajidur Rahman Sajid, officer-in-charge of Companiganj Police Station, said a gang equipped with sharp weapons attacked the duo in the area when they in a motorbike were going to their houses at around 11:00pm. #### 15 houses gutted

At least 15 houses were gutted in a fire at Debarupara village in Birganj upazila yesterday. KM Kutub Uddin, chairman of Chhotogram Union Parishad, said the fire originated at the house of one Insan Ali at 1:20pm and soon engulfed the 14 adjacent houses. On information, firefighters rushed to the spot and doused the flames with the help of locals. The affected house owners claimed that the loss caused by the fire could go up to Tk 15 lakh.

#### Two held with firearm

Joint forces arrested two youths along with a firearm at Kanungopara in Panchhari upazila on Saturday afternoon. The arrestees are Ashin Chakma, 32, son of Rabichandra Chakma of College Para area in Dighinala upazila, and Susomoy Chakma, 30, son of Shubhankar Chakma of Nanchhari area in the upazila. Acting on a tipoff, a team of police and Bangladesh Army conducted a raid in the area at around 4:00pm and arrested the duo along with the firearm, said Moin Uddin, officer-in-charge of Panchhari Police Station.

#### Fake Indian currencies seized

Members of Border Guard Bangladesh (BGB) seized counterfeit Indian currencies worth Rs 17.45 lakh from a house at Bishawnathpur in Shibganj upazila on Monday night. A BGB team, acting on a tip-off, raided one Asamuddin's house at the village and seized 17 lakh 45 thousand 500 counterfeit Indian currencies, said Lt Col Abu Zafor Sheikh Mohammad Bazlul Haque, commanding officer of BGB-9 Battalion. However, Asamuddin, 45, and his son Babu Ahmed, 25, managed to flee the scene, sensing the presence of the border guards, said the CO.

#### Cotton factory catches fire

Students, townspeople stage sit-in in front of DC's office, demanding arrest of the killer Hossain and Additional who later went to his house

Townspeople, relatives and students of different schools yesterday staged a sit-in in front of the deputy commissioner's office yesterday, demanding immediate arrest of the killer of SSC examinee Imran Khan.

They staged the sit-in after parading different roads of the town. During the two-hour

long agitation, they chanted slogans, demanding immediate arrest and exemplary punishment of the killer. Later, Deputy

Ramzan Khan, was stabbed to death by his friend Emon following an altercation over playing cricket at Jagati High School ground on Monday. Imran was playing cricket

the spot and talked to the Emon came back with a knife and stabbed Imran They withdrew the sit-in indiscriminately, leaving him critically injured, said Abdul Khaleq, officer incharge of Sadar Model

Police Station. Locals rushed Imran to Kushtia General Hospital where he succumbed to his injuries at around 7:00pm. Emon had gone into hiding soon after the incident, the OC added.

Imran was appearing in this year's SSC examinations from Kalakakoli High School in the town.
